I have also attached one further document. It is an Informal Cabinet Briefing Note. This is the only other document produced in 2013. It has not been in the public domain previously.

In relation to the Informal Cabinet Briefing Note, please be advised that section 3 has been redacted. This is because section 3 has précised a report from Price Waterhouse Cooper which contains a clause that prohibits the disclosure of the information to third parties. The report was provided by Price Waterhouse Cooper on the basis that it must be treated as confidential information. The BeWILDerwood (Bure Valley Ltd) Business Plan was appraised by Price Waterhouse Cooper who applied sensitivity analysis across all components to moderate the financial scenarios and provide support to the negotiating position of the Council regarding financial return and 'step-in' rights. Subsequently, based on Bure Valley's business plan and their projections of income and expenditure, negotiations took place and a financial model was agreed, in principle, which showed the potential to generate additional income for Tatton Park.

It is the Council's position that this information is "commercial information" and is subject to a duty of confidence.

Regulation 12(5)(e) EIR applies where information is commercial or industrial in nature; the information is subject to confidentiality protected by law; such confidentiality is provided to protect a legitimate economic interest; the disclosure of such information would adversely affect such confidentiality Bristol City Council v ICO and Portland Brunswick Squares Association EA/2010/0012.

## Public Interest Test

The EIR presumption in favour of disclosure is subject to an exception where there is a legal duty of confidentiality. It is submitted that there is a strong public interest in the maintenance of valuable commercial confidential information, as without such an assurance third parties would be discouraged from confiding in public authorities. The harm to the Council is an undermining of trust and confidence in dealings with third parties and the harm that disclosure would affect the public authority's ability to do similar business with others in the future, with similar harm to the public interest. The disclosure of confidential information by a public body engages ECHR rights Veolia v Nottinghamshire CC [2010] ECHA 1214.

The harm to the Council and Bure Valley is as fore stated. A third party may replicate the business model; or another landowner within the local area would have specific knowledge which would allow them to develop this project or a competing project, taking away or diminishing the financial benefit Tatton would derive from a family attraction
