WHAT IS HAPPENING

The Chinese government is committing human rights abuses and specifically targeting Uyghurs, Kazakhs and other Turkic Muslims in East Turkistan. These heinous crimes committed by the Chinese government constitute as defined by *The Convention on the Prevention and Punishment of the Crime of Genocide* which was signed by the United Nations General Assembly in 1948. A convention which China signed.

Crimes which constitute a genocide:

- (a) Killing members of the group;
- (b) Causing serious bodily or mental harm to members of the group;
- (c) Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part;
- (d) Imposing measures intended to prevent births within the group;
- (e) Forcibly transferring children of the group to another group.

Despite this, China is being rewarded with hosting the 2022 Winter Olympics...

WHAT CAN YOU DO?

Send emails/letters to the International Olympic Committee urging them change the location of the Olympics to a country which is not committing a genocide. A Sample letter and contact information are available on the next slides.

There is overwhelming evidence that clearly demonstrate that the policies implemented by the Chinese government constitute a genocide. It is inexcusable to claim ignorance.

SAMPLE LETTER

The International Olympic Committee

Attn: President Thomas Bach

The world remembers clearly the images of Adolf Hitler opening the 1936 summer Olympics in Berlin, an image that has marred the reputation of the games and served as a reminder of how easy it can be for the international community to lose all credibility. At the time the United States also asserted that “politics has no place in sport”. In spite of the concerns raised by human rights activists, Beijing hosted the 2008 summer Olympic games. And now, thirteen years later, we see that rather than such opportunities opening the Chinese regime to the world, they have empowered it to commit human rights atrocities to the point of genocide with no consequence. Politics may have no place in sport, but how do we define human rights? China is violating the United Nations. Seventy years since the founding of the CCP, tens of millions of people have been killed, yet the world has been muted. Beijing hosting the 2022 Winter Olympics makes a mockery of the values of humanity. For the IOC to willfully ignore China’s genocidal crimes and instead rely on “assurances” from Beijing that “the principles of the Olympic Charter will be respected in the context of the games” is absolutely preposterous. In the lead up to the hosting of the 2008 Olympics, attention was already turned on how Beijing forcibly disappeared many of the low-income citizens in Beijing who might have created discomfort by visibly demonstrating any economic disparities. Since 2008 China has only ramped up its human rights abuses. Beyond being a mistake, this makes the IOC complicit in genocide. Businesses that sponsor the Olympics are also facing conscious decisions to financially empower a regime that is exterminating an entire group of people while cracking down on the freedoms of billions both in their borders and across the globe. We therefore demand the revocation of Beijing’s right to host the 2022 Winter Olympics. In the meantime, we, the concerned citizens of the world, will raise our voices to remind both corporations and individuals alike that we are watching the decisions that are made, and it remains our firm belief that regarding China, “No Rights No Games” is the only position to take.
