This requires conscious information and security.

As a company, we are obliged to inform you about the handling of your personal data. What happens to them, for what purpose, and how they are stored and secured. This is expressed in this Privacy Statement. It must be concise, transparent, comprehensible and easily accessible.

Your data will be treated with care, confidentiality and respect.

Of course, if you sign up for the newsletter, I will use your details only for that purpose. If you sign up for the newsletter, I will only use your details for that purpose. If you submit a request via the contact form, we will use your e-mail address or telephone number to contact you.

What exactly is your personal data?

By visiting the website, filling in a contact form, your personal data are processed: first and last name, address data, telephone number, e-mail address, IP address (the address from which the website was visited, or the internet connection used) and data about your activities on the website.

Why are they requested?

To contact you. We use your name and contact details to maintain contact and inform you about relevant matters related to the contact we have together. All information you mail us will be carefully stored. Information shared by telephone is recorded in writing when necessary. Your data will also be processed to send newsletters or otherwise inform you about our business activities, and to analyse visitor behaviour to improve the website.

What does not happen to your data?

Your data will not be sold to others. Nor will it be used to compile extensive visitor profiles, nor for decision-making based on automated processing (i.e., by computer programs or systems without human intervention).

Are your data shared with third parties?

Yes, only if necessary due to a legal obligation or a legitimate interest such as reasonable business practice:

- tax adviser, because of access to invoices with address details
- websitehoster, for the storage of data from contact forms
- newsletter software, for the digital newsletter

Processor agreements have been concluded with these 'processors'.

What happens while you surf?

Technical and functional cookies are used to make my website work properly and to guarantee ease of use.

Cookies - let them work for you

A cookie is a small and simple text file that is stored on your computer or mobile device when you first visit a website. Through the settings of your internet browser you can opt out of cookies (no longer save), delete all previously stored information, and have a notification given when a cookie is sent. Please note that some websites may not function properly if you disable all cookies.

Your data is well protected

I take the protection of your data seriously. Your data is not stored online ('in the cloud'), my computer is secured with appropriate and effective technical measures, and the website uses a reliable SSL certificate. An SSL connection can be recognized by the lock and the word 'safe' for the url (currently still under construction for this website).

How long will your data be stored?

No longer than necessary to achieve the goals for which your data are collected. In concrete terms: the data of existing customers are not kept longer than five years after the end of the last customer contact. The data of potential customers are not kept longer than two years after the first contact if no agreement is reached. There is one exception: just like every entrepreneur, I am legally obliged to keep my records, including invoices with address details, for seven years.

Is something wrong, do you want to view your details or have them removed? Please contact me and I will make it all right for you, within two working days at the latest. If you see reason to do so, you can object to the processing of your personal data and/or file a complaint with the Dutch Personal Data Authority.
