## **Ed Lit Cash: Terms and conditions**

- 1. This competition is open to anyone of all ages, except for employees or Board Members of Edinburgh UNESCO City of Literature Trust and their immediate families. Entries under the age of 18 must be submitted under the supervision of a legal guardian.
- 2. The competition task is: to nominate unique ideas for getting Edinburgh reading and writing, whilst celebrating the city's UNESCO City of Literature status
- 3. The prize is one hundred pounds sterling, awarded to the entrant who submitted the winning entry, as deemed by the judges, by the stated deadline. The prize is non-transferable and non-divisible.
- 4. The competition is open to entrants residing in the UK and with a UK bank account and the entrant must be following @EdinCityofLit on Twitter in order to enter.
- 5. Only one entry to the competition is permitted per person per week. Bulk, automatically generated or third party entries are void.
- 6. Entries are to be submitted online via the entry form on the Edinburgh Literary Cash page and the competition will be held weekly from 27/04/2020 and an end date will be decided by the Edinburgh UNESCO City of Literature Trust (EUCL). EUCL shall not be responsible for technical errors in telecommunication networks, internet access or otherwise, preventing entry at this website.
- 7. Entries must be received by 12 noon GMT each Friday. Entries received outside this time period will not be considered. The competition will run weekly with the first deadline being 12 noon, Friday 1<sup>st</sup> May 2020. No purchase is necessary. Entries will not be returned.
- 8. Every effort will be made to notify the winner by email by 5pm on the Monday following the Friday deadline, using the email address provided by each winner. Winners must respond within 7 days in order to have their payment processed or an alternative winner may be chosen. If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited.
- 9. Submitting your entry constitutes your consent for us to use your entry and your name for editorial or publicity purposes, should you be a winner. Winners will be announced on the Tuesday following the Friday deadline and announcements will be made via <a href="mailto:cityofliterature.com">cityofliterature.com</a> and EUCL's social media channels.
- 10. EUCL shall use and take care of any personal information you supply and in accordance with data protection legislation. By entering the competition, you agree to the collection, retention, usage and distribution of your personal information in order to contact you about the competition, for the purposes of payment and for the purposes noted in paragraph 9 above.

- 11. The winning entry will be chosen by a judging panel which will be made up of Trustees from EUCL. The judges' decision is final and no correspondence will be entered into. A list of winners linked to the competition will be posted on EUCL's website and social media channels.

- 13. Payment of the 100 pounds sterling prize will be made to winners when they have been contacted and supplied appropriate bank account information to EUCL for such a payment to be made. Winners may be required to submit valid identification before receiving their prize.
- 14. EUCL accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the competition or accepting the prize. EUCL further disclaims liability for any injury or damage to your or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the competition.
