The Science Fiction Research Association Conference 2022 (SFRA 2022) "Futures from the Margins" is organized and hosted by the CoFUTURES research group at the Department of Culture Studies and Oriental Languages, University of Oslo, in association with the Science Library, University of Oslo.

Science Fiction Research Association (est. 1970) is the oldest professional association dedicated to scholarly inquiry into Science Fiction and the Fantastic across all media. Each year, the SFRA conference is organized and hosted by a different organization in locations around the world.





Feminist monster studies Panel discussion organized by The Monster Network

Marginalised bodies, voices and knowledges are often relegated to the realm of the monstrous, in the sense that they are deemed 'abnormal', untruthful, or unreliable. In this panel, we revisit the ways in which monsters and the monstrous long have been of interest to feminist, queer and decolonial thinkers. Importantly, this is not to "show" what is construed as monstrous, but to demonstrate how thinking-with the monster can serve as a feminist method to grapple with and challenge structures of differentiation, and boundary-making categories of belonging. What kinds of monstrous imaginaries are at stake in thinking about and planning for the future? To what extent does the threat of the monstrous reimagine debates about knowledge production, agency and belonging?

In this panel, we introduce feminist monster studies as a thinking tool for exploring tensions between what is considered acceptable and unstable or disregarded, unofficial/unrecognised and official/recognised, knowledges and bodies. Although the monster can certainly be unsettling, our aim is to spawn a discussion about boundaries, belonging and marginalisation relevant to contemporary science fiction, debates and imaginaries about futures, and develop strategies for how to reimagine collaboration and collectivity across differences and divergencies.

We live in a time of monsters. Monsters sans Frontières (MSF) is a panel-discussion-cum-mini-workshop at SFRA 2022 that seeks to bring together distinct nodes of Scandinavian/Nordic, South Asian/Indian, and Arabic/Islamicate speculative traditions of monstrousness (Fafnir in Delhi, Bhoots in Oslo). MSF hopes to identify epistemes of monstrosity that connect - and separate - localized monsters with the times in which they are produced and consumed. MSF comprises a panel discussion on monsters in different national/cultural/linguistic contexts, and a mini-workshop on creating/critiguing the aforementioned monsters. The event will feature the following resource persons: Nordic/Scandinavian Monsters: Margret Helgadottir South Asian/Indian Monsters: Indrapramit Das

FORMAT

The panelists will share their experiences of creating/critiquing monsters (45 mins). The participants will then examine "familiar" monsters in their own cultures (15 mins) and explore how these monsters negotiate with themes such as politics, demographic change, climate change, technological change etc. (15 mins). Subsequently, participants will, as individuals or groups, build a "monster" of their own on googledocs (15 mins). This will be followed by an open discussion and review, and subsequent reworking/fine-tuning of the monster (30 mins).

Kalpavigyan: A Speculative Journey **Organized and presented by CoFUTURES**

This is the first documentary film on the history of Bangla Kalpavigyan and on Indian Science Fiction. But what is Bangla Kalpavigyan? Is there such a thing as Bangla Science Fiction? Is there such a thing as Indian SF?

This is our journey with the genre, captured and presented like never before in film.

Beginning with the early work of writers such as Rokeya Sakhawat Hussain (Begum Rokeya) and the speculative mode in Bengal, and ending with the pioneering webzine Kalpabiswa, the film traces the historical arc of Kalpavigyan over a century of the genre. The principal focus of the film are the genre magazines of the 1960s-80s published in Kolkata and the writers and editors who ignited the movement by giving it shape and form through these magazines. The film is built around a series of conversations with these writers and their successors, and also features critical reflections from researchers and scholars who have worked with the genre both in relation to Bengal and Kalpavigyan as well as the wider phenomenon of SF.

The figure of Adrish Bardhan, the editor of the first Bangla SF magazine, 'Aschorjo', looms large over the film, as do major writers such as Satyajit Ray, Premendra Mitra, and Leela Majumdar. The film dives into the particularities of editorial decisions, political concerns, and personal histories that made the magic of Kalpavigyan happen amidst often bleak publishing realities and poverty. But it also sheds warm light on the ultimately liberating strain of speculative utopianism that shapes and continues to shape the genre as an ongoing discussion between fans, critics, and writers.

The film will be of interest to all fans and scholars of Kalpavigyan and SF. The research documentary showcases the research conducted by the CoFUTURES project on Indian SF.

Speculative Storytelling as Transformative Practice: Reimagining Narratives of Displacement Organized by collaborators from the UN and faculty from the Parsons School of Design

This session will focus on cultivating spaces for collaborative creativity, offering opportunities for participants to imagine and manifest artifacts and propositions as modes of speculative storytelling to promote social change.

The event will be facilitated by collaborators from the United Nations and by faculty from Parsons School of Design who are currently exploring how storytelling and speculative fabulation can act as world-building practices. The collaborative partnership engages art, storytelling, design, and the social sciences to address alternative approaches to thinking about displacement, asking difficult questions about the UN and the futures it shapes.

Participants will have the opportunity to not only engage in generative activities but learn more about this collaboration through a gallery exhibition, and gather insights from Project Unsung, a speculative storytelling project that brought together creative collaborators from around the world to help reimagine the humanitarian sector and promote narrative change and foresight within the UN system.

FACULTY

Lauren Parater is a Creative Strategist at United Nations Global Pulse, supporting the UN Secretariat's innovation and strategic foresight portfolio. Previously, she led strategic communication and storytelling initiatives at the UN Refugee Agency's Innovation Service. Her current professional and personal explorations focus on the intersections of design, narrative change, world-building and social justice. She has spent her career exploring how creativity and radical imagination can be used to communicate complex issues and spur alternative ways of seeing and being in the world.

Cian McAlone is Assistant Innovation Officer at the UN Refugee Agency, supporting the Innovation Service's Strategic Communications and Design portfolio. He is interested in the role of communication, narrative, and organizational strategy in serving the political, social and economic concerns of people forced to flee.

Shanice Da Costa is an artist and training environmental scientist. Having South Asian heritage and living as an immigrant in both UAE and Germany, she has a deep appreciation for multicultural belonging (and multicultural cuisine). Professionally, she has an interest in intersectional climate justice and ecological art, and how the two are being ad- dressed in climate change communication. She has been supporting the Innovation service on both design and environmental conversations since December 2020.

Jane Pirone is an Associate Professor of Design Ecologies at Parsons School of Design where they served as Dean of the School of Design Strategies from 2015-2019 and as Director of the Communication Design program from 2006-2011. Jane's creative and transdisciplinary practice engages with living systems, storytelling, participatory futures, and new technologies from critical, queer and post-human perspectives.

Barbara Adams is a sociologist whose interdisciplinary research looks at how knowledge is produced and po-litical action is initiated through art and design projects. Barbara coedited the book Design as Future-Making and is co-editor in chief of the journal *Design and Culture*. She is Assistant Professor of Design and Social Justice at Par- sons School of Design and was previously a postdoctoral fellow at Wesleyan University.

Hala Abdel Malak is design critic, curator, educator, researcher and strategist. Born in Beirut during the civil war, she grew up, worked, and studied internationally, in Lebanon, USA, Canada, UAE, Holland, UK, Morocco and France before grounding in New York. Hala's multicultural background is reflected in her versatile transdisciplinary approach she explores work around global dynamics, power, organization, leadership and societal impact. Her interests span from re-imagining and challenging learning, knowledge production and creative education to include diverse, non-colonial and indigenous perspectives and traditional ecological knowledge, the exploration of global cultural and societal dissonance and flow, the resonance around migration and forced displacement and the triggers and contexts for resistance, advocacy and revolt. Her work has been featured and published in Print Magazine, Design Indaba, Metropolis, AIGA, Beirut Design Week, NYC x Design, Wanted Design NYC, Smithsonian Media, MOMA and SXSW, where she was awarded the Learn by Design award for her work on refugee education. She is an Assistant Professor of Strategic Design and Management and Director of the Strategic Design and Management BBA at Parsons School of Design.

OSLO TRAVEL GUIDE

Getting to Oslo

Oslo is the capital city of Norway, located in the south-east of the country by the beautiful Oslo-fjord. The city is well connected through Oslo Gardermoen International Airport (airport code OSL) which has multiple daily flights to most major European cities (Copenhagen, Stockholm, Amsterdam, London, Paris, Munich, Frankfurt, Madrid, Istanbul, Warszawa, etc.) as well as weekly flights to New York, Dubai and Doha. It is also possible to get to Oslo by train from Stockholm (operated by SJ), Gothenburg (Operated by Vy) and Copenhagen (Requires changing trains in Malmö or Gothenburg).

Oslo Airport is located outside the city and is well connected to the city center via a high-speed Airport Express Train that takes 20 minutes to Oslo Central Station in the city center and departs every 10 minutes. It is also possible to take a slower, albeit cheaper commuter train operated by Vy to Oslo Central Station. From Oslo Central Station it is easy to get around the city by metro, tram, bus, walking or a taxi.

Conference Venue

SFRA 2022 will be hosted at the University of Oslo in the Vilhelm Bjerknes' House. The UiO Campus is well connected by Tram and Metro to the rest of the city, and is approximately 10-15 minutes from the city center via public transit. The campus has two metro-stations that are serviced by the three metro lines (#4, #5, #5R) and one tram station serviced by two tram lines (#17, #18).

Getting to UiO - University of Oslo

Currency and Norwegian Prices

The currency in Norway is Norwegian Kroner (abbreviated NOK or kr.) All restaurants, stores and kiosks accept Visa/Mastercard, however many places don't accept cash. Norway has a (rightful) reputation as an expensive place, and Oslo even more so. However it doesn't have to be. Check out: How to Visit Oslo on a Budget (Yes, It's Possible!)

Accommodation

Because the SFRA 2022 will take place on the UiO Campus in the Blindern Area of Oslo there is no conference hotel. As the UiO campus is well connected via Oslo's public transit system there are many accommodation choices in Oslo. Some recommended affordable hotels that are well connected to campus: Ankerhotel, Hotel Bondeheimen, Thon Hotel Gyldenløve, Oslo - Citybox, Comfort Hotel Karl Johan. Hotels in Oslo typically cost around 90-150 euro per night and include breakfast.

Transit: Getting Around Oslo

Oslo has an advanced and extensive public transport system with trams, trains, subways, boats and busses, and a well-developed cycling infrastructure making it easy to get around the city.

- Ruter is the municipal transport system operating all public transit in Oslo. They have an app where you can buy tickets and find your travel route. We recommend buying a 7-day ticket as single tickets get very expensive.
- Oslo City Bike (oslobysykkel.no) provides bikes for rent placed at stations throughout the city. Great way of getting to know the city in an environmentally friendly and fun way.
- Scooters Oslo is serviced by three scooter companies: Voi, Bolt, and Tier.

COVID-19 and Travel to Norway

Norway has removed all COVID-19 restrictions and there is no requirements for proof of vaccination nor negative PCR test for entry into the country. Facemasks and social distancing are not required. For updated information about COVID-19 and travel to Norway see:

FREQUENTLY ASKED QUESTIONS

Program and Format

The conference will start at 09.00 on June 27, 2022, and will end at 17.00 on July 1, 2022. The main sessions of the conference (panels & paper sessions) will be hybrid (online+in-person).

Hybrid format

All primary presentation sessions of the conference will be held online and offline. For those presenting in person, all presentation rooms will have a laptop computer, a projector and screen, and internet access via eduroam; if you wish to use your own laptop instead, please ensure that you have an appropriate adaptor. Please contact us immediately if you have any concerns about AV.

Presentation time limit

The total length of any main session: panel / paper session is 1 hour. This is a hard non-flexible limit. Presentations should be limited to 10 minutes per paper to allow time for questions. In the case of papers that are part of pre-formed panels, you may determine your own moderator and timing for the session, but please leave 15 mins for audience questions. In the case of individual papers put into sessions by the conference organizers, the first person listed on the program is deemed to be the moderator, and the presentation order will follow that of the schedule.

Timezone

All primary presentation events (offline and online) will be held between 09.00-18.30 OSLO/NORWAY time. This is to accommodate the widest range of timezones globally.

Off-campus events

We have several events off campus, including a special movie screening, gallery visits, author's night, pub night etc. You are welcome to decide on your attendance for these events.

Local accommodation

The organizers will not be assisting directly with accommodation. Oslo is also a traveler friendly city, so almost any hotel, hostel, or Airbnb (even cheap ones) will have good standards. If you want to plot your travel from any hotel location in Oslo, just enter University of Oslo, Blindern Campus as your target destination. Oslo is also one of the safest cities in the world. If you have guestions, please don't hesitate to ask. Everyone here will speak English (although speaking Norwegian will get you brownie points!).

Accessibility

The entire campus is designed with accessibility in mind, and all public transport in Oslo is designed for accessibility as well. If you have any specific questions, please let us know and we will try our best to provide assistance.

Food

The organizers will not be providing food, except coffee/tea and light refreshments for certain events. The campus has 25 on-site food courts, restaurants, cafetarias and cafes. Vegetarian, vegan, lactose, and gluten free options are easily available. Food (on campus cafes, and in restaurants and cafes all over the city) is generally marked for allergens, and people are really happy to help accommodate dietary choices.

Visas

Depending on your country of citizenship, you may need a Schengen Visa to enter Norway.

Local assistance

The CoFUTURES team will be on-site and also available in online rooms to assist conference attendees in every possible manner.

CODE OF CONDUCT

All presenters and participants must also adhere to the policies outlined in the SFRA Code of Conduct outlined below.

SFRA CODE OF CONDUCT

This code applies at all SFRA conferences or SFRA-related meetings. It applies not just to SFRA members, but to anyone attending an SFRA event.

This code is instilled to ensure a mutually respectful atmosphere by prohibiting harassment at all SFRA-related events. Harassment includes deliberate intimidation, stalking, following, harassing photography or unauthorized recording, sustained disruption of talks or other events, inappropriate physical contact, or unwelcome sexual attention. The SFRA draws a distinction between academic/artistic presentations and other public spaces at SFRA-related events. Although the SFRA honors freedom of expression for the purpose of thoughtful inquiry at all times, offensive comments or material related to gender, gender identity and expression, sexual orientation, disability, physical appearance, body size, race, or religion may also be considered harassment when not tactfully deployed in connection with a scheduled presentation.

If a participant engages in harassing behavior, the conference organizers may take any action they deem appropriate, including warning the offender or in extreme cases expulsion from the conference with no refund. If you are being harassed, notice that someone else is being harassed, or have any other concerns, please contact a member of conference staff or an SFRA officer.

CoFUTURES CODE OF CONDUCT


