Explanation

Reviewing the above mentioned application for the model recognition, the Federal Bureau for Intellectual Property has decided that the application meets the conditions for the model recognition stipulated by the Models and Patterns Law and made the conclusion by asking the applicant to pay the tax for obtaining the model and its first five years protection and all the costs of the model publishing in the Herald of intellectual property.

The applicant has paid the publishing costs and tax for obtaining the model and its first five years protection and submitted to the Bureau the payment evidence.

The Pillow

The model pillow will be used for sleeping on the floor or as a pillow within the sleeping bag.

Emphasizing the novelties: the outer shape of the pillow is a novelty. The pillow has prominent two sides at which the novelty of the model can be identified. Both sides are bent in the shape of logarithmic spirals. The sides are connected by a common curve of these two logarithmic spirals. The pillow has one symmetry plane.

<u>The body description</u>: the new pillow shape, according to this model, is shown on the drawing where: fig.1 shows axonometric view of the pillow.

The pillow, as in figure 1, has two prominent sides (1) and (2) connected by a curve (3). The sides (1) and (2) and the curve (3) are shaped by a narrow strip, so that the strip is bent at the sides (1) and (2) in the shape of logarithmic spirals. The sides (1) and (2) are linked with a common curve (3) of logarithmic spirals. The height of the pillow at the side (2) is greater than the height of the pillow at the side (1). The curve (3) is upholstered with the layer (4) in the same shape as the common curve of logarithmic spirals.

The pillow has one vertical symmetry plane which split it in half at the sides (1) and (2).
