Austria

• 9.1 million inhabitants

Vienna: 2 million inhabitants

• 9 federal states

• 10 debt advice centres

Funding (2022)



Umbrella organisation of to officially recognised de advice centres in Austr

- 87 % of the funds from the 9 federal states
 - 7 % Public Employment Service (Vienna)
 - 6 % other Institutions
- € 17.7 million = € 1.90 per inhabitant per year
- 83 % of funds for debt advice
 - 11 % for financial education
 - 6 % for the assisted bank account

Social welfare legislation

- A separate social welfare law in each federal state
- Various forms of implementation
 - Debt counselling as a mandatory offer
 - As a special form of general social counselling
 - Not legally anchored






Legal forms of organisations



Umbrella organisation of the officially recognised de advice centres in Austr

- Independent social associations
- Integration in large social service providers
- Run by the province itself
- Ltd. (some are non-profit from a tax perspective)






Requirements for funding



Umbrella organisation of to officially recognised de advice centres in Austr

- State recognition
 - Examination procedure
 - Non-profit organisations
 - Consultations free of charge
 - 3 debt counsellors (full-time)
 - 2 years of practical experience
- Quality management system
- Proof of need and use of funds







Working as a debt counsellor



Umbrella organisation of officially recognised of advice centres in Aus

- Source professions
 - Jurists (~ 50 %)
 - Social workers (~ 35 %)
- Training to become a debt counsellor
 - Learning-on-the-job
 - Curriculum "Basics" (3 parts, each 4 days)
- Certificate after 2 years of professional experience

- Liaison office between the 10 debt advice centres
- Media relations
- Common spokesperson for politics
- Scientific findings

- Ministry of Social Affairs → asb → debt advice centres
- 21 additional employees










Regional differences

- Average: 15 full-time debt counsellors per 1 million inhabitants
- Range from 9 to 21
- Long waiting times in some areas
- Financial education not nationwide

A new concept of funding



- The causer pays...
- New loans: 34 billion Euros *
- 1 per mille = 34 million Euros
- Advantages

 - Uniform nationwide supply





Public purses would be relieved More loans = more funds for debt advice centres

Statistics (2022)



- 56,000 people supported 19,000 for the first time
- Reasons for over-indebtedness
 - 30 % unemployment or reduction in income

- 23 % poor handling with money / lack of financial education
- 18 % failure of self employment
- 14 % Corona
- € 61,000 average amount of debt


