PRESIDENT'S MESSAGE

ENOTHE is entering an interesting and challenging period in the network's development. How to develop a robust, sustainable and inclusive organisation? How to contribute to the promotion and development of Occupational Therapy in Europe? How to collaborate with practitioners and researchers to strengthen the voice of occupational therapy and to establish and enhance the quality of Occupational Therapy educational programmes throughout Europe?

Current actions to develop ENOTHE as an organisation include developing a 5-year strategy plan for approval at the General Assembly, initiating work to review and develop governance documents starting with project guidelines. The office is developing a five-year strategy to balance ENOTHE'S annual budget and develop a new membership fee structure. The ENOTHE office will be exploring the possibilities of establishing a common office with COTEC to secure greater stability and cost effectiveness in administration.

The board is continuing collaboration with COTEC to establish the collaborative platform, Occupational Therapy Europe (OT-EU). Both boards met in Amsterdam in January in connection with their own face-to-face meetings. The coordinating group, consisting of the presidents and vice presidents of ENOTHE and COTEC had its first meeting to work on draft guidelines for OT-EU and a definition of Occupational Therapy! Current collaborative activities include the Joint Congress in Galway, responding to a study of the international sectoral qualifications/qualifications frameworks and the WHO Final Consultation European Framework for Action on Integrated Health Services Delivery.

Finally, I would like to remind members that Inés Viana-Moldes and I will be stepping down having completed our maximum terms as members of the ENOTHE board. If you want to make a contribution and influence the future direction of ENOTHE and OT-EU why not put yourself forward for nomination to the Board.

ENOTHE: AN INCLUSIVE NETWORK

Student involvement in internal partnerships -future project opportunity being developed

One of the key 'Areas' in the proposed ENOTHE 5 year Strategy is the investigation and development of internal partnerships and our wish to be an inclusive network of university members from all European regions. We hope to achieve this by creating financial and practical solutions for inclusion. There is a requirement to demonstrate and promote the value and contribution that becoming a member of ENOTHE brings to non-members institutions. Therefore the board is working on a written proposal for students to:-



- Identify all OT programmes throughout Europe through the internet and stakeholders such as the WFOT, COTEC and ENOTHE.
- Identify the actual member institutions by contact the ENOTHE office in York
- Identify the value the contribution that being a member of ENOTHE brings to member institutions.
- Identify wishes from members regarding their membership
- Identify the reasons for resigning membership in former members by means of e.g. an online survey after identifications of all options through contact with stakeholders (ENOTHE office and (former) staff and board members).
- Identification of the reasons why institutions with an OT programme are not a member of ENOTHE at all.
- Investigate what potential members need regarding; finances, student rates, political and practical, awareness, support from university or other facilities to stay or become a member

The board will be looking for member institutions from each region that wish to share the idea of asking students to work on this research as part of their study. An initial survey showed that collaboration among students of the regions is not easy to organise, due to the variety of programmes. Therefore it seems a better idea to start the research in each region separately. Students are free to choose one or more of the proposed objectives mentioned above. The board will then gather the information and based on the outcomes will better be able to be an inclusive network.

This is a different style of project from the two current types that ENOTHE operate and the Board will be developing a specific application to accompany this project. When the application is ready to 'go live' we will announce this to all our members.




FINANCIAL PLANNING UPDATE

In October 2015 at the General Assembly in Ruse, Bulgaria, the ENOTHE Office shared the current position of the members' finances. Initially it appears that we have a healthy amount of money in the bank but yearly shortfalls in relation to money coming into the organisation and money going out are not well balanced. In other words we are using the surplus that we make to cover a shortfall in our annual income.

Work is beginning to be undertaken to explore how ENOTHE finances can be better balanced so that the network organisation can be both active and sustainable for the long term.

The group held a workshop during the ENOTHE annual meeting in Ruse, Bulgaria 2015. This workshop was entitled "Citizenship and professional development: alternative perspectives to client-centred practice" and aimed to explore the paradigms underpinning education and practice. This will also help to develop a co-created space for reflection and debate around alternative views.

The group has been preparing a chapter for the forthcoming book, provisionally entitled "Occupation based social inclusion" with editors Hanneke van Bruggen, Nick Pollard and Sarah Kantartzis. The chapter "deals with a citizenship perspective on occupation and an occupational perspective on citizenship in order to facilitate participation and social justice".

Forthcoming actions will be preparing two accepted workshops for the COTEC-ENOTHE Joint Congress, Galway 2016: "Participatory Citizenship: alternative approaches to client centred practice" and "Living experiences of doing citizenship".

`The innOvaTe Student led Conference';

design and delivery of a conference from a student perspective

The academic rationale: Sian Burgess

Alongside professional and practice qualifications, academic tutors aspire to enable students to develop employability skills and create opportunities for learning through engagement with activities to support lifelong learning.

Cotterill (2015) discusses how the constraints of the assessment and teaching structures within a Higher Education establishment can disempower students and have a negative impact on student's inspiration and motivation to direct their own learning.

In an attempt to empower students to be involved in self-directed learning the University Of Derby in the UK pre-registration students were given the opportunity to direct their own learning event. The student group chose to plan and deliver a student conference to showcase student work and projects amongst themselves and local OT practitioners.

It was considered important to try and replicate the experience of a conference as much as possible to allow students to identify areas of personal interest and direct their own learning to support their own individual continuing professional development agenda.

The student perspective: Thomas Hawksworth

It is often tough for students to contextualise theory in the four walls of the classroom or to ascribe different frameworks and approaches to their practice when they are on practice placements. Some of this, I've come to understand, is about who is claiming the 'ownership' of these experiences as what students learn and how students practice occupational therapy is not entirely 'owned' or managed at a student level. Whilst this is wholly appropriate, having student-led activities which prioritises autonomy, creativity and innovation and cultivates a sense of ownership over the delivery and content of education has a positive impact on student self-belief (Awang and Archer, 2008) and increases the development of professional self-identity (Collins et al, 2012).

The experience of planning a conference was a daunting one. At our first meeting, we started to conceptualise and define our conference in terms of timing, theme and devolved committee remits; which also started to highlight what we had to offer or what we might gain from the process, as each of the committees drew and developed different skills. This was one of the main learning points and outcomes of the experience; that students were able to transfer existing skills to a new arena but also grow new skills that would not be available without this format.

As I headed the marketing committee for example, I needed to be able to disseminate information in different ways and liaise with the committee teams, the university systems, working professionals and professional bodies in order to source materials and market our conference. Most of these were new experiences, especially in developing a more professional style of disseminating information, but also utilised my problem solving abilities when trying to advertise and negotiate meetings with these groups.

Building confidence in public speaking and developing my own professionality in terms of what I have to offer and the areas of OT that might interest me in the future will surely benefit my level of employability post-graduation. Indeed Tymon (2013) might agree with me as his study found that developing student-led skills outside of the classroom, like flexibility, planning and communication which are qualities that are linked to employability.
