

# **COMMUNITY GUIDELINES/POLICY**

# For everyone's well-being, following guidelines apply at Garvik's Camping

pon arrival, you check-in your vehicles at the reception. -No caravan may be placed without approval of the campsite host.

-The recommended distance is **4 meters**. *(Fire authority)* 

The campsite neither lends nor leases boat slips.

# CONSIDERATION

To show each other consideration is a general rule at the campsite. Disturbing behaviour is not allowed.

Between **11 PM and 7 AM** it should be quiet at the campsite, except for dance nights organised by the campsite. On these occasions, the time is 1 AM to 7 AM. Noise or other loud sounds from music equipment as well as quarrels, vandalism etcetera can lead to immediate eviction without a refund for remaining time at Garvik's Camping.

# SPEED LIMIT

To and from the campsite "Garviksvägen" the speed limit is 20 km/h. The speed limit **"walking speed"** applies within the campsite. Do not disturb the calm at the campsite with motorized vehicles more than absolutely necessary. Drive as short distances as possible.

# RESPONSIBILITY

If you are not in your awning tent, electric heaters, gas heaters, car heaters, burning candles, tealights, or similar may **not be left unattended**. (*Fire authority regulations*) For environmental reasons, we ask you to use electricity sparsely and not have heating on when you leave the campsite.

• Please put clothes lines high enough up so they do not cause harm to others.

• You are not allowed to cut down trees, bushes or to remove branches.

• Garvik's Camping accepts no responsibility for theft or damages to guests and their property that is outside of our control.

#### GRILLS

• Charcoal grills must be handled in a safe manner and can never be left unattended before they are put out. **Disposable grills** and grills under 60 cm are FORBIDDEN.

Charcoal must be disposed of at the assigned location (cement tube by the waste containers where you throw your sorted household waste)

• Open fire is not allowed within the campsite nor at the beaches and rocks.

# **FIRE DETECTORS**

For everyone's safety we recommend fire detectors in caravans and awning tents.

# GAS

Connections to the gas installation in caravans/campers must be checked every two years. The gas installation must be approved. Please also check the hoses and connections to your gas heaters and gas grills.

# **POWER CABLES/CONNECTIONS**

Connection cables type A07BB or HO7RN-F or equivalent with the following dimensions must be used: min. area **2,5 mm max. 25 meters**.

The cable must be routed directly from the pole to the caravan and an industrial/CEE plug must be used. No connections in between are allowed. Cable reels are absolutely forbidden.

# WASTEWATER

A bladder or closed container must be used for wastewater from the caravan/camper. These are emptied and cleaned at the assigned location by the service houses.

#### ANIMAL OWNERS

Dogs **must** be on the leash within the campsite. It goes without saying that you clean up after your animal. Dog walks should take place outside of the campsite. No animals are allowed to swim in the bathing bays.

#### PLAY & BALL GAMES

There is a playground, between the bathing and middle bay there is a lawn for soccer and volleyball. It is not advisable to kick balls between caravans, cars, and tents and this should be avoided.

#### WASTE

At our campsite, for the sake of the environment, we sort out or household waste.

#### **BULKY REFUSE**

Recycling depot in Strömstad Opposite to OKQ8 approaching Strömstad At the waste containers on the campsite it is possible to dispose of household waste and glass in separate containers. The campsite guest is responsible for taking care of everything else.

#### **COMMON AREAS**

For everyone's well-being we help each other to keep everything clean and tidy.

#### **CLEANING**

A cleaning firm cleans toilets and showers. We take care of the kitchens ourselves to make sure that they are clean and tidy.

#### CARS

It is not allowed to wash cars or caravans within the campsite and **charging of electric cars is forbidden** (according to electricity regulations)

#### **DEPARTURE/CHECK-OUT**

When you leave your spot it should be cleaned and put in order.

#### **EVICTION**

-You or anyone in your company commit vandalism within the campsite. -Your caravan/tent does not adhere to the campsite's electricity regulations.
