#### 4.1. Approval of September 2022 meeting and October 2022 Planning Meeting Minutes.

## 4.2 Report on action points from the last meeting.

**4.2.1. Website address issue (Action - S.Longman)** Simon has got the website back up and running however, this still requires updating and the domain renewing. Cllr Longman stated that the hosting cost has risen by £40 and he has taken over as site admin. There is still some further work to be done. (ACTION A.Harte & S. Longman).

## 6. County Councillor's Report (Cllr. Tom Richardson)

129/22 Cllr Richardson informed the Council that the speed limit policy was presented to the committee and approved. It will now go forward to be adopted by the cabinet member. This new policy reduces the national speed limit on rural roads from 60mph to 50mph and on unclassified roads down to 40 mph, 20mph outside of Schools. The policy allows Parishes to apply for reduced speed limits more simply and easily. The community highways team will assess all applications and Parishes can fund the changes if they wish to bring them in more quickly. Cllr Richardson stated that they were trying to reduce the number of signs on posts, replacing these with painted limits on the highway surface as it is more cost effective. They are also looking at improvements to drainage and general road safety measures.

- 8.1. SDNP/21/04334/FUL Seaford College. Proposed zip wire and low and high wires. Invited to comment by 5th October 2021. The application was discussed and RESOLVED to submit a 'No Objection' response. Application still in progress...no further correspondence since 18th January 2022
- **8.2. SDNP/21/02886/FUL Seaford College.** Proposed new woodland and ecology centre. (Approved in principle by 60/22 SDNP). ELPC raised no objection. Still in progress. SDNP comments 13th April 2022...**some concerns remain unresolved**
- 8.3. SDNP/22/02855/HOUS. Eastwood Farm. Demolition of existing outbuildings and erection of new building comprising of pool, gym and garden store. ELPC resolved to raise no objection. Still in progress. The case officer is still concerned about water neutrality and light spill.
- **8.4. SDNP/22/04552/HOUS and 04553/LIS. Barnett's Farm.** Restoration of dwelling and replacement of windows. 131/22 ELPC recommended approval of the application. **Application in progress.**
- **8.5. SDNP/22/04467/FUL. Seaford College.** Eight new tennis courts and replacement of existing tennis courts with 132/22 new all-weather hockey pitch and new car parking. ELPC raised no objection. **Application in progress**
