- Internal Certification to the candidate completes the course

The second party (**BSB GLOBAL NETWORK**) will provide below:

- Proposed campus space at Cambrian School & College, Plot 21/A, Road # 1, Hasnabad, South Keranigonj, Dhaka
- Fully equipped classroom with at least 25 students seating facilities
- Administrative office space for the course coordinator
- Marketing expertise and allow first parties to promote its program at various events organized by second party
- Provide consultancy services to the candidate to study/work in Italy or other countries within the current business capacity of the second party
