- President spoke about the process followed for conducting online AGM as it was not possible to hold the meeting in person due to restrictions imposed by the Govt. due to outbreak of Corona virus across the world
- Since the Annual Report of KKS had been shared with members over WhatsApp on 19th September 2020 and through email on 20th September 2020 by the President, he presented only the overall summary of the fiscal year 2019-20, covering the following important points
 - Strengthening and widening the goals of KKS in serving the community and society as a whole
 - Improved quality of events and overall perception KKS is being perceived by members
 - New initiatives taken including Lifetime Service Award to be conferred upon for extraordinary services rendered to KKS all throughout
 - Informed about Mrs. Jyoti Khare, past secretary who served KKS as secretary for 11 months during the fiscal year 2019-20 and then resigned due to personal reasons in the first week of March 2020. Also, informed about the elevated status Mr. Rajani Kant Srivastava as Secretary from Jt. Secretary and Mr. Sharad Mathur as Jt. Secretary from member, and inclusion of new member Mrs. Sanjana Srivastava to EC. Members approved the same.
 - Appreciated the efforts put in by the respective owners of various successful events conducted during the year
 - Spoke on challenges faced/ being faced and future action plan for KKS for FY 2020-21
 - Emphasized the need to put in efforts to make KKS a brand of International repute
- President also spoke about the last AGM held on 20th October 2019 at Hotel Pride, Bangalore and requested members to approve its minutes. Mr. Prabhat Argal proposed and Mr. A M Mathur seconded it. The minutes were approved unanimously.
- President also informed members about the difficulties faced dealing with tax auditor and consultant for audit and statutory compliance, and suggested to have only one person capable of handling both the activities for the KKS.  - Events conducted including "Mai Kaikayi" during Diwali Dhamaka which was attended by a large number of members and their families

- Membership and old member re-connect drive
 - New initiative KYC (know your colleague) program for EC to have skill and talent inventory for the benefit of all
 - Developing and launching of KKS website and KKS connect platform
 - Quarterly publication of Newsletters as “Kayastha Darpan”
 - Digitalization of old records
 - Help in the form of donations extended by KKS to govt. bodies and NGOs towards Covid-19 relief
 - Procuring a dedicated online platform like Zoom or Google meet for holding meetings and conducting events in the current scenario with restrictions of no fact to face meetings due to Corona pandemic
- Mr. R S Bahadur, Treasurer presented the financial status of KKS and summary of audit. Members approved the audit report unanimously and appreciated the efforts put in making the right investments and managing the funds properly and effectively
- Subsequently, the awards under various categories were announced and winners were applauded for the sincere efforts put in and excellent results achieved. The PPT slides were shared with members and citations read out.

 - **Lifetime Service** – The special award initiated this year was conferred upon late Mr. K M Mathur, first President of KKS, for his extraordinary services to KKS and visionary leadership. The award was announced by Mr. Animesh Bisaria and members applauded and remembered him
 - **Scholarship** – Scholarship with VIDYA for 16 underprivileged girl students with NGO, VIDYA for the year 2019-20 and its renewal for 20 girls for the current year 2020-21. Members were briefed about the same by Mr. Animesh Bisaria
- Mr. A M Mathur and Mr. Prabhat Argal expressed their feelings and confidence in the existing executive committee for doing wonderful job all throughout the year including that of digitalization and online events without which there would not have been any event due to Corona. They also mentioned that KKS is in the right hands. Members fully endorsed and appreciated the timely intervention of digital adoption in carrying out various activities and engaging members proactively.
- Members appreciated the job of complying all the statutory compliances
- Members assured of their continued support in future as well
- Mr. Rahul Kumar in particular suggested approaching Income tax Dept for getting exemption under 80G so as to have donations from entrepreneurs under CSR.

Mr. Animesh Bisaria informed him and other members that application for the same has already been submitted to Income Tax department last year and efforts are on to get the exemption certificate immediately after situation becomes normal as concerned officials in IT department need to be met for expediting the same.

- Other members including Mrs. Anita Srivastava, Mrs. Vandana Dayal and Mrs. Kiran Rawar also shared memories of their long association with KKS.
- Few award winners including Mrs. Anita Srivastava and Mrs. Vandana Dayal thanked the EC for acknowledging their efforts and considering them for yearly awards.
- The proceedings of the meeting were recorded and would be shared with the members.

Digitalization at KKS

In order to keep pace with the changing technology, Karnataka Kayastha Samaj (KKS) has taken various initiatives to improve its working, record keeping, productivity and also to ease out the process of reaching out to members. The initiatives include:

- **Digitization of Records** - Important documents and photos highlighting rich history of KKS since its beginning have been stored on Google Drive and also on a Hard Drive in digital/scanned format.
- **Kayastha Darpan** -- A Quarterly Newsletter/ Magazine has been in practice in digital format for many years and is being made available to members through WhatsApp, Email and social platform like FB. This has helped KKS reach out to members timely and without additional expenditure of printing and postage.
- **Event Invitation Cards** – Digital invites (jpg and video) have been in practice for quite some time. This has helped bring out creativity of members.
- **Online Events** – KKS started an initiative **KKS Connect** to connect members online considering the lockdown conditions across. The online events conducted so far have been really successful and liked by everyone. This is also helping KKS increase its reach for wider publicity and participation.
- **Online Registration for Events** – KKS introduced online registration through Google Forms for online events. Members also found it convenient to them.
- **KKS Website** - KKS launched its website www.karnatakakayasthasamaj.org which is open to members and everyone across. Members can visit the same and start contributing to enhance its features, contents showing Kayastha culture and the contribution made to the society by eminent Kayasthas.
- **Presence on Facebook (FB) and YouTube** - KKS created its page Karnataka Kayastha Samaj – KKS on FB and a channel on YouTube with the same name to make its presence felt across through these popular platforms. Video recordings of events have been uploaded onto these platforms. This has helped members enjoy KKS events online at scheduled time as well as at leisure from wherever they are.
- **WhatsApp Groups** - KKS has been communicating with members over WhatsApp to notify members of its events, important notifications and important milestones achieved. It is an instant and popular messaging system which is keeping the members informed about all the activities being carried out by the KKS.
- **Digital Certificates** - KKS introduced the concept of multicolor digital certificate which is being given to members and artists for their valuable contribution to KKS, along with an appreciation cover note.
- **Online AGM** – KKS conducted online Annual General Meeting (AGM) successfully for the FY 2019-20 on 20th September 2020.
- **Online Executive Committee (EC) Meetings** – In view of Corona pandemic & Govt. guidelines, the EC has been having monthly online meetings almost every month.
- **Online Filling of Membership Details** – Google form was created to enable members to provide their details for filling the same in membership form.
- **Online Nominations for various awards** – helping KKS recognize people across.

Major Milestone – KKS gets exemption under 80G & 12AA from IT Department

KKS achieved major milestone for the first time in its history, by getting the IT exemption certificate under section 80G and 12AA of the Income Tax act 1961 on 6th March 2021, against its applications dated 16/12/2019 (Form 10A) and dated 17/12/2019 (Form 10G).

DIN & Order Nos. – ITBA/EXM/S/80G/2020-21/1031286879(1) dated 06/03/2021 and ITBA/EXM/S/12AA/2020-21/1030929996(1) dated 24/02/2021.

KKS, as a society is free from tax liability and donors will get 50% exemption under section 80G now while filling their tax returns, as per the provisions mentioned in above certificates/ letters/ orders. The exemption is valid from the assessment year 2020-21 till it is rescinded. KKS needs to maintain all documents and transactions as per the guidelines of Registrar of Society (RoS) and Income Tax (IT) meticulously on a regular basis, as non-compliance would result in cancellation of the above.

Needless to say, it was a very difficult task in terms of meeting the requirements of Registrar of Society (RoS) and IT department (Exemption) as the EC team had to go through lots of ups and downs in collating, compiling and presenting its response (a very details report of 276 pages) in line with what was asked for by the IT department vide their letter dated 8/01/2021. The efforts put in by the EC team with support from CAs and three external advisors helped us make it within the shortest possible time.

We salute our external advisors Mr. R K Gupta, Chief Principal Commissioner of Income Tax (Retd.) and one more consultant for their timely guidance and support in this regard. Mr. Rai Sachindra Bahadur and Mr. Vinod Srivastava, senior members of KKS, played a key role in getting us connected with the advisor and consultant respectively. Thanks to Mr. Sourabh Srivastava, CA for helping us submit our application and relevant forms to IT department in this regard. It was not possible to get the exemption so early without their support, guidance and involvement.

A new leaf turned in everyone's life when being lazy and staying shut at home was the call of the day. While surfing the internet one fine day, as soon as the lockdown began, Ishaan came across a post from an animal welfare Organisation which highlighted the dearth of resources for stray animals. This was the spark which was Ishaan's gift to the stray dogs in his area. Out in the night when people dared not stir to even their front doors, Ishaan noticed four extremely sad Vacant eyed dogs near the gate of the society. He fed them full meals with bowls of water. Gradually the dogs whispered and communicated amongst themselves that here was a messiah for them. 4 dogs increased to 14 and climbed up the ladder to 40. It was from that day until today Ishaan feeds 40 stray dogs every night with four buckets of food with four large cans of water, is a daily treat for these homeless. Living with his parents and grandparents, yes, they were apprehensive about it, their utmost fear being the coronavirus which was just everywhere and no clue where one could get infected from. Could it be from animals too? No one had a clue, so yes, his parents' fears were imaginable. Not bothering about what people would say or think, Ishaan just followed his heart.

Apart from taking care of their food, he stepped in to take care of their medical requirements too including finding and getting them placed in welcoming homes. All through this time he refused any charity or sponsorship. He continues to carry out these deeds from his savings.

These sweet souls, with their wagging tail is all that Ishaan looks forward to after a hard day's work.

A Corona warrior for these homeless and voiceless, in his own small way!

Ishaan operates in Noida, sector 50, within a radius of 5 km around his house.



- **Mr. Kushank Sandhu**



Kushank Sindhu, Advocate, Supreme Court of India, together with his friends and colleagues launched the #50mealpack challenge during the Covid lockdown, last year. Through an innovative network of receiving and processing donations, identifying demand and ensuring supply of food grain and meal pack, in less than a week, the initiative was able to supply more than 5 lakh meals to the needy. Each meal pack contained: 5 kg Rice, 5 kg Wheat Flour, 2 kg Dal, 1kg Salt and 1 Ltr. cooking oil.

Description of the Initiative:

#50MealPack Challenge was an initiative to distribute “50 Meal Packs” of dry and uncooked ration to those dispossessed and helpless during the lockdown. Donors posted about their contribution on social media and "challenge" other friends to do the same. The initiative was launched and operated through its partnership with NAFED and Delhi Police. NAFED prepared the food packets and the Delhi Armed Police managed deliveries.

#50MealPackChallenge was a youth-driven campaign geared towards the precise objective of feeding the underprivileged, the poor and the migrant workers during the lockdown period following the outbreak of Coronavirus.

Rickshaw pullers, hawkers, domestic helps, day laborers and other workers in the unorganized labour sector account for 81% of India’s entire workforce. They rely on meagre daily earnings to sustain a living. This vulnerable section of the society has been robbed of its livelihood and is struggling to feed themselves and their families, leading to starvation.

#50MealPackChallenge in collaboration with Delhi Police and National Agricultural Cooperative Marketing Federation of India Ltd. (NAFED) - a Nodal agency under the Ministry of Agriculture, Government of India attempted to tackle this problem of widespread hunger and starvation.
