Minutes of the Last Annual General Meeting (AGM) – FY 2018-19 Karnataka Kayastha Sabha (KKS)

- The Annual General Meeting of Sabha was held at 7pm on 20.10.2019 at Hotel Pride, Richmond Road, Bangalore.
- The house being in order, the president convened the meeting and started by welcome note from the president.
- Secretary and President presented the activity report.
- The Treasurer, read out the annual audited accounts for the year 2018-2019. After clarifications on some issues to the members the same was proposed for acceptance by all the members of society and then the accounts were accepted unanimously.
- The Treasurer also brought out that all the previous Fixed Deposits (FDs) and Mutual Funds (MFs) were sorted out and money collected with interest was deposited in the Sabha account at SBI, Indiranagar, Bangalore.

DISSOLUTION OF SOCIETY

The managing committee proposed to dissolve the Karnataka Kayastha Sabha as per the provisions of the Act and also to transfer all the existing properties of society to Karnataka Kayastha Samaj (KKS) (Society registered under Karnataka Society's Registration Act, having a similar line of objectives with our society). The resolution passed on 30th Sept. 2018 with reference to dissolution of society at A2b Ulsoor, Bangalore as below:

"The members of the Karnataka Kayastha Sabha have resolved to reconstitute the Karnataka Kayastha Sabha as the Karnataka Kayastha Samaj and hereby resolve to dissolve the Karnataka Kayastha Sabha and vest the Karnataka Kayastha Samaj with the legacy and goodwill of the Karnataka Kayastha Sabha together with its assets, including list of members, contact lists, newsletter and other intellectual property assets. The above is resolution is issued in suppression of all prior resolutions on the subject matter, which preceding resolution shall be considered cancelled and shall have no further effect"

All the members present unanimously approved and ratified the above resolution passed. Accordingly, all the exiting rights and obligations of Karnataka Kayastha Sabha has been transferred to new society, including the Term Deposits, Bank and Cash Balance.

The members of the Executive Committee who had completed their terms were thanked by the President for their years of service and dedication to the Society during its formative years. The President also extended his thanks to the members of the Board and Executive Committee for their hard work as well thanking Executive Committee for their services to the society. No additional business was brought forward for discussion; the meeting was adjourned.






