the State of Health and Safety in the Bangladesh Ready Made Garment industry". The seminar is organised in collaboration with the Dept. of Sociology and the School of Social Work at Lund University. Venue: Edebalksalen, School of Social Work, Bredgatan 13, Lund. See the poster.

The textile and clothing industries provide the single most important source of economic growth in Bangladesh's rapidly developing economy. Today, about 4 million people, mostly women, work in Bangladesh's export-oriented ready-made garment industry, and exports of textiles and garments are the principal source of foreign exchange earnings. The backside is super-exploitation and repression of the workers who receive minimal wages, and an alarming lack of occupational health and safety due to corruption. Deadly fires and other incidents occur regularly, and the Rana Plaza garment factory complex collapse on April 24, 2013, when more than 1 000 textile workers were killed is the worst disaster ever in manufacturing (photo).



Doug Miller (photo to the left) is a leading expert on workers rights in the fashion business. Between 2000 and 2008 he was Research Director at the International Textile Garments and Leather Workers Federation (ITGLWF), the global union for the sector. He has also authored a book, "Last Night in Savar", published in 2012, on the 2005 Spectrum Sweater Factory Collapse in Bangladesh (more information), and has an ongoing interest in mechanisms for costing and delivering a living wage in the global fashion industry.

Swedish writer Helena Thorfinn (photo to the right), now working as
Communications Manager for the Raoul Wallenberg Institute of Human
Rights and Humanitarian Law (RWI) at Lund University, will act as
moderator. She has previously worked as a journalist and as a social analyst
for Save the Children and the Swedish International Development
Cooperation Agency (SIDA) in Bangladesh. Last year she presented a
novel "Innan floden tar oss/Sisters by the River" based on her work
experiences. The book is a fascinating story on life in Bangladesh, including so many
true-to-life experiences such as criminally dilapidated textile factories, corruption, etc.

introductory speech. Welcome addresses wil also be delivered by Ann-Katrin Bäcklund, Dean for the Faculty of Social Sciences at Lund University, and Anna Lindberg, Director at SASNET. See the seminar poster.

Abstract: The status of women varies in a broad North and South Indian context, primarily due to the prevalence of different kinship rules and marriage patterns that distinguishes North from South of India. Additionally, the divergent social development situation in Indian states plays an important role. For instance, it could be argued that the largest state in India, Uttar Pradesh, if taken as a separate country, would have been one of the most socially deprived countries of the world. But at the same time, in terms of some indicators of social development, the state of Kerala would be comparable to Europe and north America. Realizing these regional variations is necessary for a better understanding of the Indian society.



Prof. Mandal is the fourth ICCR Professor at Lund University, and he will stay for the full academic year 2013/14. He joined the position on 11th September, and he is being hosted by the Department of Sociology. The ICCR professorships at Lund University are an outcome of a Memorandum of Understanding between ICCR and Lund University, that was signed in 2010. SASNET was actively involved in finalizing the agreement with strong support from the Embassy of India in Stockholm (more information).

Kalyan Sankar Mandal is Professor of Sociology within the Public Policy and Management Group at IIM-C. He defended his PhD at IIT Bombay

in 1982 with a thesis entitled "Inequality and Development in India: Study of an Equity-Oriented Rural Development Programme", and later worked at Gokhale Institute of Politics and Economics in Pune, and the Tata Institute of Social Sciences (TISS) in Mumbai. His research interest has primarily been Sociology of rural development, agriculture and food, education, poverty, social welfare and social policy. Currently his research is focused on Business Solutions for Poverty. Prof. Mandal is shaping up of the idea of "social business" (unlike profit maximizing business, social business aims at achieving a social objective in a financial sustainable way) by an NGO with which he is closely associated. As one main cause of child malnutrition in India is unavailability of supplementary food for the children of the low income families, this NGO has set up a social business of a low cost nutritious supplementary food that it has developed. This food will be sold for the children of low income families at affordable prices for the poor for reducing malnutrition in a financially self-sustained manner through social business. This social business has been initiated with an award grant by the World Bank (more information).

· SASNET lunch seminar on common human dependence on living soil



Professor Håkan Wallander from the Division of Microbial Ecology, Department of Biology, Lund University, holds the second SASNET/ABF Thursday lunch seminar talk for the fall semester 2013 on Thursday 17 October 2013, 12.30–13.30, at Lunds konsthall. The presentation is entitled "Soil – the basis of our existence. Examples from Nepal, America and Amazonas". With examples from three different places on earth, two in America and one in Asia (Nepal), Håkan Wallander

demonstrates how dependent we are on a living soil, and give us a glimpse of the immense diversity we are stepping on every day. See the poster.

Prof. Wallander is a professor in soil biology and environmental sciences. He works mainly with ectomycorrhizal fungi that form symbiotic relationships with trees. They produce several hundreds of kilogram of mycelia per hectare every year in most forest ecosystems. This is important for nutrient uptake of the trees, but also for carbon sequestration and N retention in the soil. His main research interest is to understand how this flux of carbon belowground is regulated, and how important the composition of the ectomycorrhizal community is for carbon sequestration and nutrient uptake. Part of his research has been carried out in Nepal, in areas where the soil is prone to erosion and salinization.

The lunch seminar presentation is based on his recent book



"Jord – Funderingar kring grunden för vår tillvaro" (Soll – Reflections on the Basis of our Existence), published by Atlantis, 2013. This book has been widely praised and at the 2013 Göteborg Book Fair, it was given the award "Årets Trädgårdsbok 2013" by Gartnersällskapet. In the motivation, it is said that Prof. Wallander in a personal way presents global and local aspects of soil and cultivation in an ambitious holistic manner.

SASNET's Thursday lunch (brownbag) seminar series, aimed at presenting and disseminating the eminent South Asia related research carried out at Lund University, was launched in 2011. Since last year the seminar series is organised in collaboration with Arbetarnas Bildningsförbund (ABF) Lund, and Lunds Konsthall. The seminars, open for all interested, are held once a month on Thursdays at 12.30 inside the public art gallery (Lunds konsthall) at Mårtenstorget 3 in central Lund. 


In his presentation, Prof. Sten Widmalm (photo to the right) will focus on the issue that peace in the Indian state of Jammu and Kashmir to a large extent depends on whether confidence in democracy can be revived on the ground. However, stability is also decided by the development in other parts of India. It hinges on how the ruling Congress (I) government manages to handle issues relating to governance and communalism. It also depends on what advances Hindu nationalists will be making in the near future. Finally, the prospects for peace are also conditioned by the

Afghanistan, that threatens to destroy ancient Buddhist cultural artifacts located on top of the copper deposits, the largest untapped copper reserve in the world. Huffman's film "The Buddhas of Mes



Aynak" will be shown at the seminar that is jointly organised by SASNET, UPF (Association of Foreign Affairs at Lund University) and the Swedish Committeee for Afghanistan in Lund. Venue: Café Athen, Akademiska Föreningen (AF), Sandgatan 2, Lund.

Brent E Huffman is working as Assistant Professor at the Medill School of Journalism, Media and Integrated Marketing Communications at Northwestern University in Illinois state, USA. After following China's international development in Africa for the last few years, he became interested in China's Mes Aynak project in 2011, and began documenting in volatile Taliban country the beginnings of the largest private investment in Afghanistan's history. Huffman later discovered that as a result of the Chinese copper mine, the entire region would be completed destroyed by open-pit mining. This cost-effective method would force local Afghans to relocate out of the area, as well as demolish their homes and the ancient Buddhist artifacts. The fate of Mes Aynak hangs in the balance as the Chinese company begins creating their destructive open-pit copper mine.

Earlier the same day – 4th December 2013 – the Centre for Middle Eastern Studies at Lund University (CME) organises an academic seminar with Dr. Huffman. The seminar will be held 13.15–15.00, in the seminar room at CME, Finngatan 16, Lund. More information will follow.

· Successful seventh European PhD workshop in South Asia Studies in Amsterdam



The Seventh European PhD workshop in South Asia Studies has been held on 26–27 September 2013. This year it was hosted by the University of Amsterdam. SASNET was represented by Assistant Director Olle Frödin, and Lund University sent two participants – PhD Candidates Maria Tonini, Centre for Gender Studies, and Srilata Sircar, Dept. of Cultural Geography. These European workshops are jointly co-organised by the European Association for South Asian Studies (EASAS); Heidelberg University, Germany; Ghent University, Belgium; University of Edinburgh, UK; Le Centre d'Études de l'Inde et de l'Asie du Sud (CEIAS), Paris, France; University of Amsterdam,

the Netherlands; and SASNET/Lund University, Sweden. Each university nominates a couple of PhD candidates and a senior Professor. The workshop's format gives each PhD candidate the responsibility of introducing the paper of another participant and raising some preliminary questions. Thanks to the format of the workshop, doctoral candidates and senior scholars have the opportunity to interact and engage in fruitful discussions within and beyond their respective fields. Lars Eklund reports from networking tour to London universities

During the week 9-13 September 2013, SASNET deputy director Lars Eklund visited universities in London, networking with



researchers
working on South
Asia related
projects. He first
attended an
international
conference entitled



'Communicating Soft Power: Contrasting Perspectives from India and China' at Westminster University, on 9-10 September.

On 11th September, Lars then visited London School of Economics (LSE), a vibrant research institution with many researchers working on South Asia projects. He as hosted by Professor David Lewis from the Department of Social Policy, and Dr. Mukulika Bannerjee at the Department of Anthropology. Dr. Bannerjee is the key person behind an initiative to launch a South Asia Centre at LSE from January 2014, and she had an interest to discuss networking experiences with Lars Eklund. Lars was also introduced to Dr. Shakuntala Banaji, Dept. of Media and Communications, and Dr. Rajesh Venugopal, Dept. of International Development.



On 12th September, Lars visited the British Library and the Endangered Archives Programme (EAP), a programme being funded by Arcadia (formerly known as the Lisbet Rausing Charitable Fund), that contributes to the preservation of archival material worldwide that is in danger of destruction, neglect or physical deterioration, not the least in South Asia. Lars was hosted by Cathy Collins, Grants Administrator for EAP.

Finally, Lars visited the School of Oriental and African Studies (SOAS) at University of London, one of most important research environments when it comes to South Asia related research in Europe. Lars was hosted by Professor Michael Hutt, Professor of Nepali and Himalayan Studies, and Chair for the Centre of South Asian Studies at SOAS, and Jane Savory, Office Manager for

the Centres & Programmes Office, that oversees the administration of the seven Regional Centres within SOAS – the Centre of South Asian Studies being one of them. They now informed about the decision convert the Centre into an Institute of South Asian Studies from January 2014.

Finally, Lars met SOAS PhD candidate Najia Mukhtar, representative of the recently formed Muslim South Asia Research Forum (MUSA), a new cross-disciplinary initiative focused on bringing together PhD students and early career researchers working on any aspect of Muslim societies in the countries of South Asia.

EMINTE is a consortium consisting of 20 universities – 10 European and 10 Indian. SASNET is an Associate partner in the consortium.

The programme is open to Indian nationals who want to study or work at one of the ten European partner universities. It involves students on undergraduate, master, doctoral and post-doctoral level as well as for university staff in academic or administrative positions. The call for scholarship applications is between 15 October and 1 December

The Ambassador also strongly emphasized the importance that the mobility programme between India and Europe should be running in both directions, not only one-way bringing scholarship holders from India to Europe. Her view was supported by several of the Indian univertity representatives present. Mr. Clivio Casali, Programme Manager at the European Commission's Education, Audiovisual and Culture Executive Agency (EACEA), was also present. He presented

statistics on the impressive number of scholarship holders that have benefited from the India lots since 2008 and onwards (including Asia regional lots with Indian universities involved), and he also presented the outline for the Erasmus + programme that will be introduced in 2014, replacing current Erasmus Mundus and other programmes.

Professor Dubhashi (photo to the right) and Associate Professor K. V. S. Prasad have both strong Indian connections since long time back, with an extensive network of contacts in major institutions, universities and industry research centres in India.



In April 2007, the Division of
Computing Science received an Institutional Grant from
STINT for "long term collaboration" with the Kanwal
Rekhi Institute for Information
Technology (KRESIT) and the Dept. of Computer
Science and Engineering at the Indian Institute of
Technology (IIT) in Mumbai. The persons in charge at
Chalmers are Prof. Dubhashi and Dr. Prasad, while at
IIT Mumbai it is Prof. Pushpak Bhattacharyya.

In 2011, Prof. Bhattacharyya spent a full year at Chalmers as Visiting Professor. The collaboration has focused on Linguistics and Computation, and the project has involved several faculty members, PhD and Masters students at Chalmers as well as at IIT Bombay. Shafqat Mumtaz Virk defended his doctoral thesis in this field entitled "Computational Linguistics Resources for Indo-Iranian Languages" on 3 June 2013. Dr. Chien-Chung Huang joined the department in 2013. He has many active collaborations in India, especially with Associate Professor Kavitha Telikepalli at the School of Technology & Computer Science, Tata Institute of Fundamental Research (TIFR) in Mumbai. Dr. Huang as also collaborated with researchers at the Indian Institutes of Technology in Delhi, Mumbai and Kanpur. In 2012 Professor Christopher L. Barret from Virginia Tech, USA was given a special Jubilee Professorship in celebration of Chalmers 150th year anniversary. Through Chris Barrett and Madhav Marathe from Virginia Tech, the department is involved in a research collaboration with Professors Dinesh Mohan and Geetam Tiwari at the Transportation Research and Injury Prevention Programme (TRIPP) at the Indian Institute of Technology Delhi for transport and traffic modelling.





Doctoral dissertation on Climate Change and Management of Urban Flooding in Mumbai



Arun Rana from the Division of Water Resources Engineering, Lund University, defended his dissertation "Climate Change Effects on Rainfall and

Management of Urban Flooding" on Friday 27 September 2013, at 10:15. Faculty opponent was Prof. Karsten Arnbjerg-Nielsen, Department of



Environmental Engineering, Technical University of Denmark. Professor Lars Bengtsson has been the main supervisor. Co-supervisors have been Prof. Ronny Berndtsson and Prof. Arun Kansal.

The thesis presents how the effects of climate change and high-intensive rainfall on the urban drainage system and management of flooding in urban areas of were studied in Mumbai, India and Southern Sweden, including Skåne and Gothenburg. Various analytical systems were applied, and the analysis revealed a high degree of variability in rainfall over Mumbai. A significant decreasing trend for long-term southwest monsoon rainfall was found. Also, a decrease in average maximum daily rainfall was indicated. The southwest monsoon rainfall over Mumbai was found to be inversely related to the Indian Ocean dipole, the El Ninő-Southern Oscillation, and the East Atlantic Pattern. In Southern Sweden, however, annual precipitation has increased significantly due to increasing winter precipitation. Link to more information.

Doctoral dissertation on Arsenic Exposure Risk from Rice in Rural Bengal

Dipti Halder from the Department of Land and Water Resources Engineering; School of Architecture and the Built Environment, Royal Institute of Technology (KTH), Stockholm, defended her dissertation "Arsenic Exposure Risk from Rice and other Dietary Components in Rural Bengal" on the 25th September 2013, at 13:00. Faculty opponent was Prof. Dr. M. Alauddin, Department of Chemistry, Wagner College, Staten Island, NY, USA. Venue: Kollegiesalen, Brinellvägen 8, (entréplan), KTH, Stockholm, Sweden. Professor Prosun Bhattacharya has been her main supervisor.



The thesis investigates the risk of arsenic (As) exposure from staple diet to the communities in rural Bengal, even when they have been supplied with As safe drinking water. The results indicate that average accumulation of As in rice grain increases with decrease of grain size, however people living in the rural villages mostly prefer brown colored SB type of rice because of its lower cost. Among the vegetables generally consumed in rural villages, the accumulation of As is highest in the leafy type of vegetables, compared to non-leafy and root vegetables. The study suggests that any effort to mitigate the As exposure of the villagers in Bengal must consider the risk of As exposure from rice consumption together with drinking water. Doctoral dissertation on Arsenic geochemistry in the alluvial aquifers of West Bengal




Ashis Biswas from the Department of Land and Water Resources Engineering; School of Architecture and the Built Environment, Royal Institute of Technology (KTH), Stockholm, defended his dissertation entitled "Arsenic geochemistry in the alluvial aquifers of West Bengal, India: Implications for targeting safe aquifers for sustainable drinking water supply" on the 23 September at 13:00. Faculty opponent was Prof. Dr. Laurent Charlet, CNRS, University of Grenoble, Grenoble, France.

Venue: Kollegiesalen, Brinellvägen 8, KTH Royal Institute of Technology, Stockholm, Sweden. Professor Prosun Bhattacharya has been his main supervisor. The thesis describes the natural occurrences of high dissolved arsenic (As) in groundwater of Bengal Basin that has put millions of people under the threat of chronic As exposure through drinking water. Present study has examined the processes that regulate As mobilization and its distribution in shallow aquifers and the potentiality of finding safe aquifers within shallow depth (<50 m) for drinking water supply. This study concludes that the reductive dissolution of Fe oxyhydroxides followed by competitive sorption reactions with the aquifer sediment is the process conducive for As enrichment in groundwater of Bengal Basin.

· Unique scholarly archives resource on Balochistan

The Balochistan Archives (Pakistan) is now available online on its web



page balochistanarchives.gob.pk/ and via its Facebook Page /balochistanarchives. The website is an information portal on documents of historical significance for scholars, civil servants, and citizens interested in the history, culture, and politics of Balochistan Province, Pakistan. Currently Balochistan Archives hold more than 27,000 original files, 5,000 rare books and manuscripts, and 300 rare maps pertaining to Balochistan, Afghanistan, Iran, and the Persian Gulf. These collections reveal the policies and practices of tribal management and frontier governance on the North West Frontier of India. In addition, the records of Balochistan Archives shed light on the conduct of British relations with Afghanistan, Iran, and the Persian Gulf and drawing of regional boundaries such as the Goldsmid Line (1872), Durand Line (1893), and Baloch-Afghan Boundary (1896). The website has several features of interest to scholars including a searchable catalogue of its holdings, finding aids to the collections, and a digital collection of select books, manuscripts, maps, and genealogies.

The Endangered Archives Programme at the British Library is now accepting applications for the next round of funding. Detailed information on the timetable, criteria, eligibility and procedures for applying for a grant is available on the Programme's website, http://eap.bl.uk/. Applications will be accepted in English or in French. The deadline for receipt of preliminary grant applications is 1 November 2013.



Since it was established nine years ago, the Programme has so far funded 214 projects worldwide with grants totalling £5.3 million. The Programme is funded by Arcadia (formerly known as the Lisbet Rausing Charitable Fund), in pursuit of one of its charitable aims to preserve and disseminate cultural knowledge and to promote education and research. The aim of the Programme is to contribute to the preservation of archival material worldwide that is in danger of destruction, neglect or physical deterioration. In South Asia, approximately 30 projects in Bhutan, India and Nepal are currently supported by the Endangered Archives Programme. They include projects on digital documentation of manuscripts at Drametse and Ogyen Choling monasteries in Bhutan (photo from Drametse); a project on Locating and surveying early religious and related records in Mizoram; a project on Archiving texts in the Sylhet Nagri script; and a project to Retrieve two major and endangered newspapers: Jugantar and Amrita Bazar Patrika in Kolkata. The Endangered Archives Programme is pleased to announce the addition of a new catalogue to its web pages. The catalogue gives details of material copied by the project EAP310: The digital documentation of manuscripts in Thadrak, Tshamdrak and Nyephug temples in Bhutan, holding significant collections of ancient manuscripts such as Buddhist canonical texts, religious and philosophical writings, historical and biographical literatures, which have hitherto remained unknown and inaccessible to scholars. 
New Delhi Conference on State and Society in North East India

The conference aims to bring together leading economists, political scientists and historians to debate a key tenet of modern development theory: the crucial link between the development of strong institutions and sustained economic growth. The primacy accorded to institutions by eminent scholars like Dani Rodrik and Daron Acemoglu has been challenged by academics like Ha-joon Chang, but the



debate has remained closeted among economists. This conference aims to enrich and expand the dialogue by engaging experts from other disciplines like sociology, politics and history to contextualise the emergence of institutions in their historical and sociopolitical context. The geographical focus on South Asia will enable the discussion to be grounded and targeted at understanding one of the poorest regions of the world, often castigated for its weak and corrupt institutions. 

New book about Mahatma Gandhi and Allama Mashriqi "Mahatma Gandhi & My Grandfather, Allama Mashriqi" is a

new book authored by the historian and scholar Nasim Yousaf, who also is the grandson of Allama Mashriqi.

Allama Mashriqi and Mahatma Gandhi shared many similarities — both men left their professions behind and dedicated their lives to liberating India from British rule. Both adopted a life of simplicity and began their grassroots campaigns in the streets and villages of the country. Both were nominated for the Nobel Prize (Mashriqi for his monumental work, Tazkirah, and Gandhi for his non-violence) and shared a common objective of achieving independence for the nation. Yet despite all their similarities, they could not

reach agreement on Mashriqi's The Constitution of Free India,



1946 A.C. nor were they able to work together to achieve a united, independent India. Why? The answers are contained in this book. In Mahatma Gandhi and My Grandfather, Allama Mashriqi, Mr. Yousaf brings together nearly 17 years of exhaustive research of historical documents as well as firsthand knowledge and insights gained from Allama

Mashriqi's wife, sons, daughters, and the Khaksars, who were part of the freedom movement and witnessed the division of India.

Lund University's fourth ICCR Professor Kalyan Mandal held installation seminar

Professor Kalyan Sankar Mandal from the Indian Institute of Management Calcutta (IIM-C) in Kolkata held his installation lecture as Visiting Indian Council of Cultural Relations (ICCR) chair professor at Lund University, on Wednesday 9th October 2013, 13.00 –15.00. Venue: Kulturens Hörsal, Tegnérplatsen, Lund. See the seminar poster. The title of his presentation was "Regional Diversities in Indian Society", and focuses on regional variations in the status of women in India and the social development situation in India. The status of women varies in a broad North and South Indian context, primarily due to the prevalence of different kinship rules and marriage patterns that distinguishes North from South of India. Additionally, the divergent social development situation in Indian states plays an important role. For instance, it could be argued that the largest state in India, Uttar Pradesh, if taken as a separate country, would have been one of the most socially deprived countries of the world. But at the same time, in terms of some indicators of social development, the state of Kerala would be comparable to Europe and north America. Realizing these regional variations is necessary for a better understanding of the Indian society.

THE ranks five Indian universities to be among world's 400 best

According to the Times Higher Education (THE) World University Rankings 2013-14, only two Nordic universities appear among the top 100 in the world – Karolinska Institutet as No. 36 (up six positions compared to last year), and University of Helsinki as No. 100. The majority of universities in the top of the list are American or British. The ranking list was published on 3 October 2013. The THE rankings employ 13 separate performance indicators, making them the only global university rankings to examine all the core missions of the modern global university – research, teaching, knowledge transfer and international activity. Just below the top 100 comes Stockholm University as No. 103, Uppsala University as No. 111, Royal Institute of Technology (KTH) in Stockholm as No. 117, and Lund University as No. 123 (sliding 39 positions down since last year!). Aarhus University ranks as No. 138, Copenhagen University as No. 150 (down 20 positions), and Oslo University as No. 185. In South Asia, Panjab University (photo) in Chandigarh, India, makes an exceptional entry into the Top 400, now ranked to be among the positions between 226 and 250. Only four other South Asian universities – all Indian – are ranked among the top 400. All of them being Indian Institutes of Technology (IIT) and collectively ranked to be in a position between 351 and 400, they are IIT Kharagpur, IIT Roorkee, IIT Kanpur, and IIT Delhi. On the other hand, IIT Bombay has fallen out of the Top 400. See the full THE ranking 2013-14. http://www.timeshighereducation.co.uk/world-university-rankings/2013-14/world-ranking/range/001-200

Compare this information with another ranking service, QS World University Rankings 2013, said to be among the most trusted university rankings available. According to this ranking, Lund University is the premier Swedish university, ranked as No. 67 (up by 4 positions), whereas University of Copenhagen is No. 1 in Scandinavia on position No. 45 (followed by Helsinki on No. 69, Uppsala on No. 79, Oslo on No. 89, and Aarhus on No. 91. That means six Nordic universities among the top 100. QS also has a different ranking priority when it comes to South Asia. Here, IIT Delhi is the premier institution with position No. 222 (photo of celebrating IIT Delhi students). It is followed by IIT Bombay on No. 233, and IIT Kanpur on position No. 295, and then follows IIT Madras on position No. 313, and IIT Kharappur on position no. 346. The only non-Indian South Asian university to qualify to the QS Top 800 ranking is the National University of Science and Technology (NUST) in Islamabad, Pakistan, ranked to be in a position between 481 and 490 in the world, slightly after IIT Roorkee (401-410) and University of Delhi (441-450). University of Mumbai is ranked to be in the gap 601-650, and ranked together characterized as 701+ we find the universities of Colombo, Dhaka, Karachi, Lahore, Pune and the University of Engineering and Technology (UET) in Lahore. Uppsala book launch and talk by Kali Ghosh on his autobiography "A Revolutionary in British India"

The Department of History, Uppsala University is hosting a book launch and talk with legendary Indian personality Kali Ghosh on 15 October 2013, 15.00 – 16.30, in connection with the release of his autobiography entitled "The Autobiography of a Revolutionary in British India" (New Delhi: Social Science Press 2013). The event is organised as a part of the university's Historic Seminars series. Venue: Uppsala Univerity Library (Carolina Rediviva).Kali Ghosh grew up in Bengal when the independence movement against British colonial rule spread like wild-fire. He came to political awareness during its "terrorist phase" in the 1920s, when the leading Congress movement leaders were either jailed or withdrew from the larger scene. He was one of the many disillusioned young men and women who found no other way to battle the British than violence. —Kali Ghosh himself became particularly good at making explosives. Jailed and deported to England, he met a Swedish woman, journalist and translator, in London. She encouraged him to write and share the account of a young mind in the movement, far from the biographies of the leading Indian nationalists. The seminar will be introduced by Prof. Gunnel Cederlöf, Department of History. SASNET lunch seminar on common human dependence on living soil

Professor Håkan Wallander from the Division of Microbial Ecology, Department of Biology, Lund University, holds the second SASNET/ABF Thursday lunch seminar talk for the fall semester 2013 on Thursday 17 October 2013, 12.30–13.30, at Lunds konsthall. The presentation is entitled "Soil – the basis of our existence. Examples from Nepal, America and Amazonas". With examples from three different places on earth, two in America and one in Asia (Nepal), Håkan Wallander demonstrates how dependent we are on a living soil, and give us a glimpse of the immense diversity we are stepping on every day. Prof. Wallander is a professor in soil biology and environmental sciences. He works mainly with ectomycorrhizal fungi that form symbiotic relationships with trees. They produce several hundreds of kilogram of mycelia per hectare every year in most forest ecosystems. Part of his research has been carried out in Nepal, in areas where the soil is prone to erosion and salinization. The lunch seminar presentation is based on his recent book "Jord – Funderingar kring grunden för vår tillvaro" (Soil – Reflections on the Basis of our Existence), published by Atlantis, 2013. This book has been widely praised and at the 2013 Göteborg Book Fair, it was given the award "Årets Trådgårdsbok 2013" by Gartnersållskapet. In the motivation, it is said that Prof. Wallander in a personal way presents global and local aspects of soil and cultivation in an ambitious holistic manner. Read more.

Copenhagen guest lecture on China in Subaltern Indian Images

Professor Kamal Sheel, Professor of Chinese Studies and former Dean of the Faculty of Arts at Banaras Hindu University (BHU) in Varanasi, India, holds a lecture entitled "China in Subaltern Indian Images: Travel Narratives of Thakur Gadadhar Singh and Mahendu Lal Garg during the Boxer Rebellion", at the Asia Research Centre, Copenhagen Business School (CBS) on 23 October 2013. Venue: CBS, room DSO52, Dalgas Have 15, Frederiksberg, Copenhagen. The presentation looks at Indian travel writings and explores intra-cultural encounters and the construction of knowledge about China at the beginning of the twentieth century. Kamal Sheel focuses on two Indian travellers, namely Thakur Gadadhar Singh (1869-1920) and Mahendu Lal Garg (1870-1942). Both writers were part of the native regiments under the British Army which was dispatched to China during 1899-1900 where they joined the Joint Foreign Expeditionary Force and fought the Boxers. Their writings demonstrate that modern subaltern Indian images of China were dominated by voluntaristic and populist impressions evincing cultural and brotherly affinities between the two, and as such overrode the colonial state's agenda and westerners' derisive and contemptuous description of Boxer China. Kamal Sheel has recently finished a co-authored manuscript on 'Thakur Gadadhar Singh: An Indian Subaltern's account of the Boxer Rebellion'. Uppsala Seminar on Middle Class Education and Religion in 19th Century Colonial Bengal

The Department of History at Uppsala University in collaboration with the Forum for South Asia Studies is organising an afternoon with two presentations on the Bengal Renaissance, Gender, and British Education on 24 October 2013, 14.15–16.00. The

presenters are Professor Rachana Chakraborty, Department of History, Calcutta University, and PhD candidate Abhishek Ghosh, Department of South Asia Languages and Civilizations, University of Chicago. Prof. Rachana Chakraborty's presentation is entitled "Debates on Women's education in nineteenth century Bengal: Its form and content". The presentation discusses how the consolidation of British power in India during the nineteenth century and the acceleration of Western contact brought about far- reaching changes in the structure of the Bengali society. Efforts to provide education for Indian females had begun early in the 19th century, by the missionaries, being the early players in the game. But as they were primarily driven by proselytizing urge they were inclined to focus on the poor and low caste women, these efforts met with little success until the idea of female education had gained respectability amongst the intelligentsia. To uncover variegated inflections of this radically-gendered discourse one has to turn to Bengali women's magazines with a view to locating the form and content of female education and also the new role model that these educated women were expected to follow.

Abhishek Ghosh's presentation is entitled "British Raj, Bengal Renaissance and Bhadralok Vaishnavas". In this presentation, Ghosh discusses the European 'gaze' of civilizing mission on Hinduism and analyze the specific response of the Vaishnava savant Kedarnath Datta Bhaktivinode (1838-1914). The presentation captures the broader socio-historical context of nineteenth century Bengal through a discussion of the beginnings of 'Orientalism' and the establishment of Christian missions, but also of the Hindu reform movements of the intellectual middle class (bhadralok). Orientalist research and missionary discourse often criticized what they viewed as the 'lewd' and 'reprehensible' aspects of Hindu traditions such as Caitanya Vaishnavism, and in response those Hindu reform movements tried to 'redress' these issues through an agenda for organized social, religious and political reform. Within this context, this presentation aims to analyze and theorize the contributions of bhadralok Vaishnavas, which have so far been relatively overlooked by contemporary scholarship on modern Hinduism. It will also place the role of Bhaktivinode at the cusp of this encounter.

SASNET concert with eminent artists from Kolkata at Sagohuset in Lund

The extraordinary talented North Indian classical singer Sudokshina Chatterjee Manna from Kolkata again visits Lund for a concert along with her Tabla player husband Subrata Manna, and the Kathak dancer Sohini Debnath, on Sunday 13 October 2013, at 19.00. Subrata was a student of Tabla maestro Pandit Shankar Ghosh and has learnt all the most important musical styles (gharanas). Both Subrata and Sudokshina also have academic degrees from Rabindra Bharati University in Kolkata. Sohini Debnath dances Kathak, the Indian original behind the Spanish Flamenco dance. They come to Sweden as part of a European tour, being invited to Lund by SASNET. The Lund concert, organised in collaboration with Theatre Sagohuset and Sensus, will be the only one in Scandinavia.
