

### SASNET News

 Inter-disciplinary SASNET Research Workshop on South Asia: Culture, Technology, and Development



The Swedish South Asian Studies Network (SASNET) at Lund University organises an inter-disciplinary Research Workshop on South Asia: Culture, Technology, and

Development on 13–15 June 2014 at the Falsterbo Conference Resort, Sweden. The conference is organized in collaboration with the Nordic Centre in India (NCI) and the Nordic Institute of Asian Studies (NIAS), Copenhagen University. SASNET is now accepting abstracts of research papers for presentation at the workshop. Go for the conference web site.

The main objective of the workshop is to bridge the gap between Nordic researchers in various disciplines working on South Asia. We will discuss interdisciplinary research in terms of theoretical and methodological approaches, assumptions, ethical considerations, and practices. The workshop will consider interdisciplinary research that is already being done in the field of South Asian studies, and will give participants an opportunity to explore promising new areas for future research. Talks by three prominent researchers will be featured.

The workshop is divided into three main thematic sessions.

Session A: Methods, Fieldwork and Ethics in the South Asian context

Session B: Culture , Religion and Technology in South Asia Session C: Theory, Practice and Development in South Asia

Researchers and young scholars interested in submitting papers at any of the aforementioned sessions are requested to submit an abstract of individual papers (maximum 500 words) as an email attachment addressed to Hawwa Lubna, by email lubna.hawwa@sasnet.lu.se. Deadline for submission is 2 December 2013. Please specify clearly in the email in which session you would like to present the paper. A clear goal of the workshop discussions is to create strong academic cooperation on South Asia between different disciplines in the form of joint publications or new research projects. Therefore, participants are highly encouraged to send us ideas for new research project or publication in no more than 100 words. We are also exploring the option of bringing out the previously unpublished papers presented at the workshop in a special publication.

### · SASNET Seminar on Fragile Peace in Kashmir and the way forward

SASNET organised a successful seminar entitled "Fragile Peace in Kashmir. Is there any way forward?" at Lund University on Thursday 14 November 2013. It was arranged in collaboration with the South Asian Students Association (SASA) at Lund University. The two invited speakers were Professor Sten Widmalm from the Dept. of Government, Uppsala







Sten Widmalm, Muhammed Farooq Sulehria and Ali Daalat.

University, and PhD Candidate Muhammad Farooq Sulehria from the School of Oriental and African Studies (SOAS), University of London, UK.

Sten Widmalm's presentation was entitled "How to build peace in the world's most dangerous place", and focused on the issue how peace in the Indian state of Jammu and Kashmir to a large extent depends on whether confidence in democracy can be revived on the ground. However, he also pointed out that stability is also decided by the development in other parts of India, and the political stability in Pakistan and Afghanistan.

Muhammed Farooq Sulehria's presentation was entitled "The Kashmir Cauldron: Complexities facing the nationalistic political project" offered a lot of insights regarding the Kashmir national question.



Sulehria argues that the Kashmir question remains a tripartite dispute whereby Kashmiris constitute the third elemental party to the dispute, and that India and Pakistan mutually want to maintain a status quo on the Kashmir dispute for strategic reasons.

The seminar was followed by a screening of "Lakeer", a feature film on Kashmir by British-Kashmiri film maker Ali Daalat, who was present and held an introductory speech about the film

about people who have had to suffer great pain and separation because of India's partition in 1947. The film skillfully brings alive the pre- and the post-partition life in


Abstract: In unfolding the "logic" (Arendt 1970; Bourdieu 1992; Stoler 2010) inherent to different kinds of violence, Helle Rydström examines how gendered and aged violence is informed by assumptions about masculinity, femininity, superiority, and not least male privileges. In so doing, she discusses how women and the girl children become included by exclusion of the social order and its promises about human rights and security (Agamben 1998; Rydstrom 2012; Sanchez 2004).







### · SASNET film seminar on Chinese mining exploitation in Afghanistan

the Mes Aynak project in
Afghanistan, that

threatens to destroy ancient Buddhist cultural artifacts located on top of the copper deposits, the largest untapped copper reserve in the world. Huffman's film



"The Buddhas of Mes Aynak" will be shown at the seminar that is jointly organised by SASNET, UPF (Association of Foreign Affairs at Lund University) and the Swedish Committeee for Afghanistan in Lund. Venue: Café Athen, Akademiska Föreningen (AF), Sandgatan 2, Lund. See the poster.

Brent E Huffman is working as Assistant Professor at the Medill School of Journalism, Media and Integrated Marketing Communications at Northwestern University in Illinois state, USA. After following China's international development in Africa for the last few years, he became interested in China's Mes Aynak project in 2011, and began documenting in volatile Taliban country the beginnings of the largest private investment in Afghanistan's history. Huffman later discovered that as a result of the Chinese copper mine, the entire region would be completed destroyed by open-pit mining. This cost-effective method would force local Afghans to relocate out of the area, as well as demolish their homes and the ancient Buddhist artifacts. The fate of Mes Aynak hangs in the balance as the Chinese company begins creating their destructive open-pit copper mine.

Earlier the same day – 4th December 2013 – the Centre for Middle Eastern Studies at Lund University (CME) organises an academic seminar with Dr. Huffman. The seminar will be held 13.15–15.00, in the seminar room at CME, Finngatan 16, Lund. More information will follow.

### Minutes from October 2013 SASNET board meeting now available

The minutes are now available from SASNET's October 8th, 2013, board meeting. Go for the verified Minutes (as a pdf-file).

Among the many issues to be discussed, plans for conferences and other activities during the coming year were agreed upon, and the budget for 2014 was approved. Some important decisions regarding SASNET's organisational structure were also taken. Dr. Olle Frödin, working for SASNET since August 1, was appointed Deputy Director for the period up till 31 December 2015, with a specialization on issues related to research collaboration, research applications



and interdisciplinary collaboration at Lund University. Lars Eklund continues to be in charge of SASNET's daily work as a Research Communicator, but will keep the title

Deputy Director as well. The board also approved that Hawwa Lubna should be given an internship on 20 % at SASNET for a period of six months, assisting Lars with the daily work.

#### Lars Eklund travel reports from October–November 2013 SASNET/Lund India choir tour



During the period 23 October till 10 November 2012, SASNET deputy director Lars Eklund was away from the SASNET office at Lund University. He travelled to Kolkata along with other members of the Lund India Choir, specialized in singing songs by the Indian/Bengali Nobel Laureate poet and composer Rabindranath Tagore (1861-1941). Lars however also visited a number of universities as part of his SASNET work, among them Indian Statistical Institute in Kolkata, North Orissa University in Baripada – involved in a Erasmus Mundus collaboration with Lund University, and Indian Institute of Technology (IIT) Kharagpur, the highrest ranked IIT in India located 120 km west of Kolkata.

In two weeks time the Lund India Choir completed a successful tour consisting of no less than seven concerts in Kolkata, Shantiniketan, Balasore, Baripada and Kharagpur, in order to commemorate the 100th jubilee year of Rabindranath Tagore's Nobel Prize in 1913. The main concert was held at classical Star Theatre in north Kolkata on Saturday 26th October, in a programme together with world famous Mamata Shankar Ballett Troupe. The group



also had an amazing concert for students and professors at Sangheet Bhawan, the Music Department at Viswa Bharati University in Santiniketan, Tagore's own university.



First part of the programme coincided with the official Swedish Embassy Tagore commemoration programme held in Kolkata on 25–26 October (more information), but was by some strange reason not admitted to be part of it. The Lund India Choir, led by Bubu Munshi Eklund, also performed at the Calcutta Cricket and Football Club, and at the inauguration of a new Swedish-funded Shakuntala Rheumatology Hospital and Research Institute in Balasore, Odisha State on Thursday 31 October. Other programmes were held at North Orissa University in Baripada and at IIT Kharagpur, and everywhere the choir performed it was

### · Bollywood and Diaspora in focus for Karlstad researcher visiting SASNET



Assistant Professor Charu Uppal from the Department of Media and Communication Studies (MKV) at Karlstad University visited SASNET's office in Lund on her own initiative and had a fruitful meeting with SASNET deputy director Lars Eklund on Monday 11th November 2013. Dr. Uppal hails from India, but has a professional background from Penn State University in the US, and more recently University of the South Pacific in Fiji. Her research focuses on Bollywood and Diaspora, and about how girls, 8-15 years in different countries, including India and Fiji, perceive images of

girlhood in Disney movies. At a recent London conference on "India China Soft Power", Dr. Uppal presented a paper on "Bollystan: An Expanding State (of Mind)", in

which she claims that the international spread of Bollywood films to a large extent is connected to the fact that there are now 25 million people of Indian origin living in diaspora in 110 countries all over the world.

### · Swedish Research Links grants to South Asia related projects

On 18 November 2013, the Swedish Research Council decided upon the distribution of grants through the Swedish Research Links (Asian—Swedish research partnership programme). A few South Asia related collaborative research projects were selected in this tenth round of the programme, that from this is year entirely handled by the Swedish Research Council.



The Swedish Research Links programme offers grants for international collaborative research projects of high scientific quality and of mutual relevance for scientists in Sweden and scientists in selected countries in Asia, the Middle East and North Africa, Africa, Latin America and Europe. The South Asia projects selected will be carried out in collaboration with partners in Bangladesh and Sri Lanka.

### · Amazing collection of documents provided by South Asia Archive



The South Asia Archive is a great new and extensive web based resource for students and scholars across the humanities and social sciences, offering access to historical documents reflecting the varied range of knowledge production in colonial and early post-colonial

India and the wider sub-continent. The content of the South Asia Archive was sourced from a large collection of scholarly material held by the South Asia Research Foundation (SARF), a Kolkata-based, not-for-profit organization that has built an extensive collection of printed historical materials through the acquisition of private collections and the purchase of individual pieces.


The South Asia Archive represents the digitization of a large part of this material, helping to ensure its availability on a global scale. Editors in Chief for the Archive are Professor Boria Majumdar, University of Central Lancashire, UK; and Dr. Sharmistha Gooptu, South Asia Research Foundation, Kolkata. Dr. Kausik Bandyopadhyay, West Bengal State University in Barasat is Advisory Editor.

Documents included in the South Asian Archive can be divided into five main categories covering all available publication types:

- Journals more than two hundred journals in a range of subjects published from India and South Asia, including early journals such as Asiatic Researchers (first published in 1788), Indian Review, Modern Review, and Calcutta Gazette.
- Reports a diverse collection of reports from colonial and post-colonial India, including volumes of the 1901, 1911, 1931, and 1951

Indian Census documents, and the near complete set of Calcutta Riots of 1946 Gazetteers from a range of Indian states such as Bengal, Madhya Pradesh, and Maharastra are also available.

On 13 November 2013, the United Nations Educational, Scientific and Cultural Organization, UNESCO, decided to establish a research centre in Sweden with a focus on international water issues. The centre will be run by Stockholm International Water Institute, SIWI, in collaboration with Uppsala University and the University of Gothenburg. With its

focus on transboundary water cooperation, the centre will be one of a kind. The majority of the world's countries share water resources in some form, such as rivers and lakes, Consequently cooperation between States over this vital resource is essential. The Swedish UNESCO Centre will focus on equitable water cooperation and aims to develop research and knowledge on transboundary water resource management. The centre, which will be located at SIWI, will also concentrate on how to establish and develop effective water partnerships despite contexts of political conflict. 81 UNESCO Centre's exist in different parts of the world, with 18 of them focusing on water related issues. This is the first time that a UNESCO Centre has been established in Sweden and the first time a Centre will focus on transboundary cooperation. This new UNESCO Centre will help Sweden deepen its involvement in water issues and disseminate Swedish research in this area. The focus will draw from the strong tradition of research on water conflict and cooperation that exists in Sweden today. More information.

#### Seminars and Conferences in Scandinavia

### · South Asian issues in focus at MR-dagarna 2013 in Stockholm

In connection with the 2013 edition of the yearly Swedish Forum for Human Rights (MR-dagarna) that was held 14-16 November in Stockholm, several programmes were devoted to South Asian issues. See the entire programme for MR-dagarna 2013.



On Thursday 14 November, 16.30–17.30, a panel was held that to a large extent focused on the Maldives. The panel,

organized by the Raoul Wallenberg Institute (RWI) at Lund University, was entitled "National Human Rights Institutions work on National Inquiries", and highlighted problems related to lack of access to education for children with disabilities in the Maldives. The participants included a representative from the Human Rights Commission on the Maldives, Ms Aishath Fasoha.

On Saturday 16 November, 11.00–11.30, the Dalit Solidarity Network-Sweden (DSN-S), and Friends of Village Community Development Society (VCDS) jointly organised a mini-seminar focusing on Caste and Dalit issues in India. A new film on the the living conditions of Dalits – "Vi är inte oberörbara!" was shown; and Mr. P K Mahanandia, artist living in Borås, but originally coming from Orissa in India, spoke about his experiences of the oppressive Caste system and how he – being a Dalit – was discriminated against by teachers and high caste students during his childhood and youth.

On Saturday 16 November, 13.00–14.00, the Lund based NGO Swallows India Bangladesh organised a panel entitled "Women's Rights in Bangladesh – Progress or Backlash", focusing on how women's rights and possibilities in Bangladesh are affected by the political instability. Khushi Kabir, from the Bangladeshi civil society organisation Nijera Kori ("we do it ourselves" in Bengali) working with grassroots women's empowerment, discussed the situation faced by Bangladeshi women, with Monica Erwér from the Swallows.

On Saturday 16 November, 14.30–15.30, the Swedish Committee for Afghanistan (SCA) organised a panel entitled "Afghanistan and the future beyond 2014". Next year the afghan people will elect a new president and the government will have taken over the full responsibility for upholding security from international forces. What actions are most important to give the civilian population an opportunity to enjoy their human rights? What is required of the aid organizations? Participants included Torbjörn Pettersson, director of Department for Conflict and Post-Conflict Cooperation at Sida, Dr Soraya Sobhrang, Afghan Independent Human Rights Commission, Magnus Forsberg, former senior security advisor for SCA in Afghanistan, Dr Aminulhaq Mayel, head of education program at Swedish Committee for Afghanistan in Kabul, and Helené Lackenbauer, researcher at research institute FOI. Moderator was the journalist Lasse Bengtsson.

### · Stockholm seminar on the Future of India

### Uppsala seminar with Martin Fuchs on Indian Bhakti



Dr Martin Fuchs from the Max-Weber-Kolleg, Erfurt, Germany, holds a seminar on *Indian bhakti: The Comparative Analysis of Civilizational Diversity* in Uppsala on 21 November 2013, 16.15-18.00. Venue: Room 2-0023, Thunbergsvägen, Engelska parken, Uppsala University. The lecture is organised by the Forum for South Asian Studies. Abstract: How to conceive of "civilizations" in a meaningful way without falling into the trap of essentialization? How to do justice to cultural divergences and ruptures in civilizational analysis and inter-

civilizational comparison? Addressing these questions the paper explores aspects of Indian bhakti – the strand of personal religious devotion or "participation in God" (Prentiss) – from a sociological as well as anthropological point of view. Taking prominent attempts of constructing an integrated picture of India the paper discusses the difficulties their authors have in coming to terms with bhakti. The lecture suggests alternative ways to allow social theory to give full scope to the particular experiential modality of bhakti and examines the potentialities bhakti has offered to disadvantaged segments of society in India. The paper ends with some considerations for new approaches to the idea of "civilization" in the Indian context.

### · Copenhagen seminar on The Taliban and Afghanistan - Beyond 2014

Which role might the Taliban play over the coming years? Will they negotiate for political power, and over which issues? And could they play a role in stabilizing Afghanistan?

Speakers include Alex Strick van Linschoten, PhD Candidate at Kings College; Michael Semple, Visiting Research Professor, Institute for Study of Conflict Transformation and Social Justice, Queen's University Belfast and former deputy to the European Union Special Representative for Afghanistan; and James Fergusson, Journalist and author of A Million Bullets: The Real Story of the British Army in Afghanistan (Bantam Press, 2008) and The Taliban: The True Story of the World's Most Feared Guerrilla Fighters (Corgi Books, 2011).

### · Uppsala Seminar on Fictionalization of Violence in Contemporary Hindi Literature

On 28 November 2013, at 16.15, Dr Ines Fornell from Göttingen University, Germany holds a guest lecture in Uppsala on "The Fictionalization of Violence in Contemporary Hindi Literature". The seminar is organised by the Department of Linguistics and Philology, Uppsala University in collaboration with the university's Forum for South Asia Studies. Venue: Engelska parken, 42-0026, Thunbergsvägen, Uppsala.



Seminar abstract: For several decades India has frequently been tormented by outbursts of large-scale communal violence, especially between Hindus and Muslims. One of the most traumatic incidences was the destruction of the Bābrī Masjid by Hindu nationalists on December 6, 1992 in Ayodhya followed by a wave of bloody riots in many parts of India. Those events prompted several Hindi writers to deal directly or indirectly with the problem of Hindu nationalism and religious violence in a fictionalized manner. In my paper I will give a short overview of important Hindi novels and stories dealing with different aspects of communalism and communal violence in the 1990s. In this regard, I will mainly focus on the novel Kathāvācak (2001, The Story-teller) by Ābid Surtī which includes fictionalized scenes of the demolition of the Bābrī Masjid as well as the novel "Triśūl" (1993, Trident) by Śivmūrti which describes the effect of the Ayodhya incidents on the relationship between the Hindus and Muslims of a small North-Indian town. The Stress Research Institute at Stockholm University, and the International Institute for Population Sciences (IIPS) in Mumbai, India,

Stress and poor working conditions have repeatedly been shown to be bad for the health and well being of the workforce. However these studies have largely been conducted in Europe, Japan and North America. We know little about whether these factors are prevalent in India or whether they impact on the health of workers in India in the same way. These are crucial questions given the rapid economic growth of the Indian economy and the transformation of the workforce. Employment in agriculture has declined from around 72% of the workforce in 1971 to just over 50% in 2008. This has been coupled with a dramatic rise in the number of people employed in the service and IT sector. How these changes and the new environments in which these employees work might impact on their health are key questions. This conference will bring together researchers from two of the world's leading centres on work environment and health and researchers from India to discuss these crucial issues. More information.

### · Copenhagen seminar on what role India could play in the UN Security Council

### · Stockholm seminar on China and India: Emerging Powers in a New World Order

The Forum for Asian Studies at Stockholm University is holding a seminar entitled "China and India: Emerging Powers in a New World Order" on Thursday 12 December, 13.00–15.00. Venue: Stockholm University, Frescati, room F 289.

Dr. Sumit Roy (photo) from the Nordic Africa Institute in Uppsala is the main speaker at the seminar. His presentation will focus on China and India, as the two major 'Emerging Powers' among the group of nations coined as the BRICS (Brazil, Russia, India, China and South Africa) which are destined to reshape the world. This is set in the frame of globalisation – a process defined by a blurring of national borders underscored by a shift in emphasis from state to non-state market led policies.



In this context there is controversy over the capacity of China and India to become major players in the world. They function under different socio-political systems-China a 'planned,' 'state directed,' and 'centralized democracy' run by one party and India a 'mixed' state and market economy based on 'multiparty democracy.' In this respect, the focus of this seminar is on capturing more fully through political economy the key forces which enhance and inhibit the capacity of both to pursue their goals. This is underscored by (a) structural economic transformation to diversify and boost growth while tackling domestic socio-economic and political strife and (b) strategic ties or alliances with nations/regions and institutions within and beyond Asia to bolster their economic and political influence. Insights emerge into the capacity of China and India to usher in a New World Order.

Alongside these new developments a new wave of service privatization, of universities, hospitals and schools is sweeping across the city, pricing out the vast majority from access to basic services. Millions of poor people moved to the city's peripheries with the hope and prosperity where they were again entrapped into the new urban poverty. It is thus in this context in which the peripheries, where new manufacturing and garments factories are fast developing, which become centers for poverty, violence and exploitation. In fact, urban poverty, widespread violence, and massive population movements to Dhaka have contributed to the peripheralization of poverty and violence during the period of market democracy. This new forms of urban violence has produced citizen insecurity. The conference organisers are Prof. Shahadat Hossain, and Dr. Samina Luthfa, both from the Dept. of Sociology, University of Dhaka. #### The Sri Lanka Graduate Student Conference in Stanford









Though important, these discussions leave little room to explore the complex intersections between child labor and schooling in colonial and postcolonial India: intersections that draw attention to issues not necessarily exhausted by ensuring school access for laboring children. The workshop also welcomes intellectually creative, non-disciplinary reflections on the issue of Dalit and other marginalised communities experience of schooling and work. More information.



### New book on Dalits and Adivasis in India's Business Economy

"Dalits and Adivasis in India's Business Economy

— Three Essays and an Atlas" is a new book
authored by Barbara Harriss-White, Emeritus
Professor of Development Studies at Oxford
University, and others.

The book deals with the fact that India's founding fathers and neo-liberalisers alike expected economic development to dissolve 'archaic' forms of exchange, but the modern Indian economy remains embedded in caste relations. At the base of the caste hierarchy are formerly untouchable



and tribal workers. But a growing minority of dalits and adivasis have been incorporated into the Indian economy not as workers but as owners of firms.

The Atlas shows the striking and consistent regional and sectoral differences in the way


dalits and adivasis have been incorporated into 14 occupational sectors of the business economy at both state and district levels of resolution over the period 1990 – 2005. Explaining these differences and some adverse trends during the era of globalisation is a task that the three essays accompanying the Atlas attempt to begin. Using contemporary field research, dalit narratives and statistical data they explore the dalit experience of disadvantageous entry into markets, the state and civil society; their adverse experience of business associations regulating markets; and the surprisingly distinctive patterns of regional disadvantage that dalit and adivasi businesses suffer. ### New book on contemporary development of Indo-Danish cultural heritage and tourism in Tranquebar

Dr. Helle Jørgensen, Dept. of Culture and Society at Aarhus University, has authored the book *Tranquebar*—*Whose History?* published by Orient Black Swan. The book is based on the research done within the Tranquebar Initiative of the National Museum of Denmark.

About the Book: Tranquebar, a small fishing town on the coast of Tamil Nadu, was a Danish trading colony from 1620 to 1845. In recent years, the drive to develop it into a heritage destination has generated large-scale conservation and restoration efforts aimed at preserving the monuments of the town's colonial past.

Alongside the proliferation of surveys and development plans, manifold agents including local and state-level authorities, private entrepreneurs, researchers, NGOs, and tourists—Danish and Indian—congregate in the



town. Yet the townscape also sets the scene for the everyday lives and concerns of the local inhabitants. Tranquebar—Whose History? explores the significances of cultural heritage in this small town, revealing the multiple attachments to, uses of, and negotiations around the townscape and its histories in daily life, tourism, research and heritage development.

The discussion moves from the differing motivations attending local and transnational constructions of Tranquebar as a remote location, and the sometimes contradictory expectations from development; the conflicting attitudes to modernity and notions of aesthetics among various stakeholders; to shifting constructions of history in which Tranquebar emerges as a postcolony, caught between colonial nostalgia, collective memory and contemporary narrations of anti-conquest. SASNET film seminar on Chinese mining exploitation in Afghanistan

On Wednesday 4 December 2013, 19–21, US-based journalist and documentary filmmaker Brent E. Huffman participates in a seminar on Chinese mining companies involvement in the Mes Aynak project in Afghanistan, that threatens to destroy ancient Buddhist cultural artifacts located on top of the copper deposits, the largest untapped copper reserve in the world. Huffman's film "The Buddhas of Mes Aynak" will be shown at the seminar that is jointly organised by SASNET, UPF (Association of Foreign Affairs at Lund University) and the Swedish Committeee for Afghanistan in Lund. Venue: Café Athen, Akademiska Föreningen (AF), Sandgatan 2, Lund. Brent E Huffman is working as Assistant Professor at the Medill School of Journalism, Media and Integrated Marketing Communications at Northwestern University in Illinois state, USA. After following China's international development in Africa for the last few years, he became interested in China's Mes Aynak project in 2011, and began documenting in volatile Taliban country the beginnings of the largest private investment in Afghanistan's history. Huffman later discovered that as a result of the Chinese copper mine, the entire region would be completed destroyed by open-pit mining. This cost-effective method would force local Afghans to relocate out of the area, as well as demolish their homes and the ancient Buddhist artifacts. The fate of Mes Aynak hangs in the balance as the Chinese company begins creating their destructive open-pit copper mine. Earlier the same day – 4th December 2013 – the Centre for Middle Eastern Studies at Lund University (CME) organises an academic seminar with Dr. Huffman. ### Copenhagen seminar on Law Reform in Pakistan

Common to their equally obsessive pursuit of 'speedy justice' is a remarkable obliviousness to the historical, institutional and sociological factors that alienate Pakistanis from their formal legal system. The lecture endeavors to highlight vital and widely neglected linkages between the 'narratives of colonial displacement' resonant in the literature on South Asia's encounter with colonial law and the region's post-colonial official law reform discourses. Against this backdrop, it will discuss a typology of Pakistani approaches to law reform and critically evaluate the IFI funded single-minded pursuit of 'efficiency' during the last decade. It will also analyze extant empirical support for a widening chasm between popular, at times violently expressed, aspirations for justice and democratically deficient reform designed in distant IFI headquarters that is entrusted to the exclusive and unaccountable Pakistani 'reform club.'
