SEASONAL RENTAL AGREEMENT

It is agreed to rent the apartment D2 located on the 2nd floor of the residence Silver Beach Zeedijk De Haan 24 at 8420 De Haan.

The apartment consists of a living room with an american kitchen, a small bedroom, a bathroom (shower and a toilet), more detailed on the site <u>www.silverbeachd2.be</u>. It is equipped according to available inventory on the site in the section "The Apartment".

Duration of the rental

This rental is agreed and accepted for the period chosen by the Lessee. It begins on the first day at 4 p.m. and ends on the last day at 11 a.m.

Rent value / Charges

The price includes the application fee, insurance, cleaning, preparing the apartment for the stay of the Lessee. The due cost for consumption of electricity, heating, hot and cold water is re-invoiced according to actual consumption. They will be deducted when the guarantee is reimbursed.

Guarantee

The Lessee will pay a sum of 250 euros to the Lessor as a guarantee for damages that may be caused to the apartment or furniture. This sum will be refunded to the Lessee after the Lessor is assured that there is no damage and no lack in the apartment.

Payment
