








## What GDPR tells you to

- Protection impact assessment (PIA), is intended to identify and minimize non-compliance risks.
- The GDPR redefines a data breach as "a breach of security leading to the accidental or unlawful (...) loss, unauthorized disclosure of, or access to, personal data transmitted, stored otherwise processed".
- However, you might be exempted from notifying individuals if you have implemented appropriate measures to protect data, such as encryption.




