- and a focused, limited bibliography, to draw out the context of the responses;
- aim for a maximum of 750 words.

Both of these calls are opportunities to share pedagogic practice, offer theoretical perspectives, or to provoke, challenge and inspire colleagues. We are open to a range of approaches, so please feel free to be creative in your thinking. Scholarship for the 2019 conference

There has been a tradition first started at the 2005 conference of offering conference fee waivers and/or financial support to presenters from less well-off countries where universities are typically unable to support their staff to attend conferences.

These scholarships are paid out of the small profits made from the preceding conference(s). We plan to repeat this procedure again for the 2019 conference. In addition, the organising committee at Chalmers University is offering an additional 10 conference fee and conference dinner waivers. The requirements for eligibility for a scholarship are as follows:

- **1**. Applicants must have a proposal accepted for the conference.
- **2**. For the EATAW organisation Scholarship, the applicant must submit a statement justifying their application for a fee waiver and financial support to **Stuart Wrigley** < **Stuart.Wrigley@rhul.ac.uk** > with the subject line "Request for EATAW2019 Scholarship" by latest **15 April 2019**.
- **3.** For the fee and conference dinner waiver from the conference organiser, please send your request with subject line "Request for EATAW2019r Fee Waiver" to <magusta@chalmers.se"> by the latest 15 April 2019
- **4**. Applications will be evaluated after **15 April 2019** by a committee who will consider them on the merits of both the statement and the conference abstract. We hope to make decision within a week to ten days from receiving applications.
