A FEW MEMBERS HEARD MY PLEA FOR CONTRIBUTIONS TO THE NEWSLETTER. HERE WE GO.

SARAH AND COLIN RIACH SUBMITTED THE FOLLOWING:-

#### THE JOYS OF IMPORTING A VEHICLE -

ON THURSDAY 25TH MAY 2023 I DROVE MY U.K. PLATED VEHICLE TO THE ITV STATION FOR AN APPOINTMENT WHICH HAD BEEN MADE A FEW DAYS EARLIER.

The vehicle in question - Suzuki LJ80 - had been off the road for many years and was at a local garage, it had been undergoing a rebuild and had just completed an extensive final service for it to attend the itv inspection which was also for historic plates. I was told that it could be legally driven directly to and from it's appointment providing it was covered by insurance. Vehicle had been insured through Mapfre since 1986.

This process for historic importation had taken almost 3 years to get to this stage. The inspection was also to determine that the vehicle was original so as to comply with the historic legislation. The paperwork for historic vehicle is extensive 30+ pages, itv inspection 4 pages, importation at least 4/5 pages plus all the original necessary paperwork 6/7 pages.

On the return journey the local police decided to follow me just at the final kilometre as I was arriving home.

TO BEGIN WITH THEY WERE WANTING TO FINE ME FOR DRIVING WITH U.K. PLATES - I EXPLAINED THAT THE IMPORTATION FOR THE VEHICLE WAS PENDING AND I PRODUCED ALL OF THE DOCUMENTATION. THEN THEY DECIDED TO FINE ME FOR NO INSURANCE - MAPFRE WAS CALLED AND CONFIRMED VEHICLE WAS AND HAD BEEN INSURED THROUGH THEM CONTINUOUSLY SINCE 1986.

ONE OFFICER THEN TOOK IT UPON HIMSELF TO TRY TO REMOVE THE REGISTRATION PLATE WITH A LARGE SCREWDRIVER THAT HE OBTAINED FROM THEIR CAR, BEARING IN MIND THE VEHICLE WAS PARKED ON PRIVATE PROPERTY. THE OTHER OFFICER WAS MORE COURTEOUS AND TRIED TO COAX HIM TO STOP. HE FOUND IT DIFFICULT TO REMOVE THE PLATES SO HE

ISSUED ME WITH A PIECE OF PAPER I BELIEVED WAS A FINE BUT WITHIN A FEW MINUTES HIS COMPANION TOOK THE PAPER AWAY, APOLOGISED AND THEY BOTH LEFT.

Last Saturday, 5th August, I received a summons in My Mailbox, it had no postal date on the envelope, letter was dated 21st July and it gave 20 days in which to appeal - which meant from receipt of letter I was now down to only 3 days to appeal. It appears I am being fined by local Police for not paying road tax in any country.

MY UNDERSTANDING REGARDING THE LEGISLATION ON TAX:

The UK authorities (DVLA) were informed that the vehicle was out of U.K. however, if it were to still be in U.K. the following legislation on road tax would apply:-

- As the vehicle was first registered 43 years ago it is classed as a historic vehicle
- HISTORIC LIGHTWEIGHT VEHICLES OF 40YEARS+ IN U.K. ARE EXEMPT FROM PAYING ROAD TAX
- AN APPLICATION FOR ROAD TAX EXEMPTION WILL FIRST REQUIRE THE VEHICLE TO HAVE UNDERGONE A ITV/MOT INSPECTION
- o The Legislation for road tax exemption came into force in 1997
- O A VEHICLE CAN BE LEGALLY DRIVEN DIRECTLY TO GET AN MOT INSPECTION PROVIDING AN APPOINTMENT HAS BEEN PREVIOUSLY MADE TO RECEIVE THE VEHICLE. IT CANNOT BE LEFT OR PARKED ON A PUBLIC HIGHWAY/STREET.
- VEHICLE MUST BE INSURED AT ALL TIMES

#### LEGISLATION ON SPANISH ROAD TAX

- $\circ$   $\;$  Road tax implementation requires that vehicle is to be registered in Spain
- o TO OBTAIN SPANISH PLATES THE VEHICLE FIRST NEEDS TO BE IMPORTED
- TO COMPLETE THE PROCESS FOR IMPORTATION IT REQUIRES TO HAVE THE VEHICLE INSPECTED AND AN \*ITV CERTIFICATE PRODUCED PRIOR TO ISSUING IT WITH SPANISH REGISTRATION.
- HISTORIC LIGHTWEIGHT VEHICLES ARE EXEMPT FROM ROAD TAX

THROUGHOUT IMPORTATION PROCESS I HAD FOLLOWED THE ADVICE OF MY GESTOR WHO HAD NOTIFIED ME THAT THE VEHICLE MUST BE KEPT OFF THE ROAD AT ALL TIMES UNTIL REGISTRATION AND WITH THE PROCESS OF AN ITV INSPECTION THE VEHICLE CAN BE DIRECTLY DRIVEN TO AND FROM AN ITV STATION PROVIDING IT HAS INSURANCE.

UPON SPEAKING WITH SOMEONE AT THE DVLA THEY WERE ASTOUNDED WHEN I EXPLAINED THAT THE SPANISH AUTHORITIES WERE FINING ME FOR NOT PAYING U.K. ROAD

TAX, THEY INFORMED ME THAT AS THE U.K. IS NO LONGER PART OF THE EU IT IS NOT POSSIBLE TO THEM TO APPLY SUCH LEGISLATION.

I HAVE APPEALED AND WILL LET YOU KNOW THE OUTCOME IN DUE COURSE IN THE MEANTIME PLEASE FEEL FREE TO COMMENT.

### CENTRE CONSOLE

IN MY MUSTANG THERE WAS ONLY THE GLOVE BOX TO STORE ITEMS IN THE CABIN. WHEN I FITTED THE AIR CONDITIONING PART OF THE KIT WAS A MUCH SMALLER GLOVEBOX INSERT BECAUSE THE A/C UNIT WAS MUCH BIGGER THAN THE OLD HEATER THIS CREATED A PROBLEM BECAUSE YOU COULDN'T FIT A PAIR OF SUNGLASSES IN THE NEW GLOVEBOX

I STARTED LOOKING AT ORIGINAL MUSTANG CENTER CONSOLES AND MODERN VERSIONS NEITHER HAD THE LOOK I DESIRED AND THE COST WAS CRAZY. AN ORIGINAL STYLE CENTER CONSOLE WAS AROUND \$600 PLUS IMPORT SO I THOUGHT "I CAN MAKE ONE"!

PREVIOUSLY ON OUR COBRA KIT CAR BUILD IN THE UK I MADE THE DASHBOARD AND DOOR CARDS SO I THOUGHT IT WOULD BE STRAIGHTFORWARD TO DO A CONSOLE......NOPE.

As with all projects of this type it's best to start with a drawing and template of what you want before making the final product so I cut a load of cardboard and held it together with gaffa tape.

After a few tries I was happy with it and purchased some 5 ply plywood and some black vinyl cloth with a similar grain to the rest of the car.

After dis-assembling the Cardboard and using it as a template to cut the wood I had my first problem, when try- fitting the basic box shape it became apparent the floor of the bell housing/ tunnel in the car sloped as you move to the rear of the cabin and the gap between the seats is narrower than I thought (the cardboard squeezed itself it the gap the wood didn't).

I MADE THE NECESSARY CUTS AND ALL WAS HAPPY.

NEXT TEST FIT WITH THE SECTION AROUND THE GEAR LEVER ATTACHED SHOWED THAT THE GEARBOX/ LEVER IS OFFSET TO THE DRIVERS SIDE!!!!!

SO AFTER A BIT OF THOUGHT I MADE SOME RELIEF CUTS VERTICALLY IN THE SIDE THAT HAD TO CURVE INWARDS AND CLAMPED IT IN PLACE OVER THE NEXT WEEK I SPRAYED THIS AREA WITH WATER AND ALLOWED IT TO DRY OUT MANY TIMES THIS ALLOWED THE RIDGED WOOD TO BEND TO THE DESIRED SHAPE.

During this period I was a victim to Amazon and bought a usb and cigarette lighter panel to fit in the console along with a 6 fuse fuseboard for under the bonnet.


The next stage was to cover it in material. I had some 2 mm foam to put under the vinyl to cover screw holes and imperfections in the console, that was quite easy to glue in with spray contact adhesive

THE VANILLA WAS A PIG BECAUSE I HAD TO TRY AND STRETCH IT 3 WAYS AT THE SAME TIME AND BECAUSE OF THE CONSTRUCTION IT NEEDED PARTIALLY FITTING BEFORE I COULD FINALLY STICK DOWN THE VINYL

Once covered and the electrics fitted it came to securing the console in place. I just bent some thin bar into 90 degrees and painted it black along with the screws

AT THE END I WAS VERY HAPPY WITH THE CONSOLE IT NOW HAS A CUBBY HOLE AT THE FRONT A SMALL SPACE FOR A PHONE 2 CUP HOLDERS AND A BOX/ ARMREST AT THE BACK

Total time about a month on and off ( poss 20/30 hours) and around €250 for materials
