DESCRIPTION:

True Pro-Ten Plus is a unique blend of beneficials for plant and microbial (protein hydrolysates, humic acid, fulvic acid, seaweed extracts, shrimp shell) formulated to enhance soil microbial growth and activity; improve nutrient and micronutrient uptake; and increase plant tolerance to stress conditions in fruit, nut, vegetable and row crops.

DIRECTION FOR USE:

True Pro-Ten Plus can be applied to most crops as a preplant soil application, by fertigation, or by foliar sprays. For compatibility information on tank mixing with True Pro-Ten Plus, please consult a True Organic Products representative. In general, True Pro-Ten Plus is compatible with most common nitrogen fertilizers but should be diluted with water (at least 50% volume) with other fertilizers. True Pro-Ten Plus should not be tank mixed with acids. Tank-mixed solutions should be immediately used.

SOIL APPLICATION RATES:

True Pro-Ten Plus can be applied combined with water or fertilizer solution. Use 1 to 10 gallons per acre. If applying as transplant drench, do not exceed 1% solution of True ProActivate Plus in water.

FOLIAR APPLICATION RATES:

True Pro-Ten Plus can be applied combined with water or tank mixed with some fertilizers and pesticides solutions. Apply 1 pint to 5 gallons per acre in at least 10 gallons of water. Foliar application solutions should not exceed 3% solution of True Pro-Ten Plus.

A test solution of a specific tank-mix is recommended before use. Or please contact a True Organic Products representative

MIXING INSTRUCTIONS:

1. Fill tank with half volume of water and begin agitation.
2. Add True Pro-Ten Plus.
3. Add additional compatible fertilizers and/or pesticides.
4. Fill remainder of tank with water while continuing agitation.
