The World Bank Group (USA) and the Committee of 300, which are under my Chairmanship, released a copy of the **INFINITE BANK STATEMENTS (IBS)** [2012], which refer to the **INFINITE ACCOUNTS IN US \$** including their respective Account Numbers and Account Names in many prime banks.

THE TRUSTESHIP ORIGIN OF THE INFINITE ACCOUNTS IN US \$ IS FERDINAND EDRALIN MARCOS, SR. WHO IS MY FATHER AND THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES (1965 – 1986).

HH, Pope Benedict XVI, who served as White Pope and sovereign of the Vatican City State from 2005 to 2013, officially signed the **IBS** in 2012.

The Bank has two Accounts with Account Names of **White Spiritual Boy** and **Spiritual Wonder Boy** with respective standing balances of **US \$ ∞** and confirmed as Eternal Deposit (while under time deposit, its principal balances and interest are untouchable and/or unloanable and/or unprogrammable) that having maturity rate of 4% per annum and per 30 years of maturity and upon maturity 50 % shall be forcibly used for whatever Development Program and 50% shall be automatically and forcibly maintained and preserved to another 30 years until lasted for eternity.

My Code Names are **White Spiritual Boy** and **Spiritual Wonder Boy**; thus, I am the Sole Owner of the said **26 INFINITE ACCOUNTS IN US \$**.

The Confirmed Infinite Accounts have continuous maturity earnings.

As HM, King ASM, these are my five Mission Statements:

- 1) to return all currencies into gold standard (or backed up with treasure)
- 2) to uplift the living conditions of poor people in the world
- 3) to protect the Mother Earth from total environmental destruction
- 4) to encourage people to be religious or spiritually-inclined persons
- 5) to finance Humanitarian and National Economic Development Programs for humanity's basic needs such as nutritious food, potable water, comfortable shelter, appropriate clothing, and many others

Regarding the official document of **MARCO DI MAURO**, who is of the Italian P2 Freemason lodge according to Benjamin Fulford, a freelance journalist based in Tokyo, Japan, Marco reveals that the Kingdom of Spain donated the Philippine Islands as dowry to the Vatican in 1593 (goo.gl/86c7ox).

The Vatican became the Philippines' Titular Archipelago Owner under the **Omnipotent Creator Alpha Omega World Governance Pontifical Administration** with the Spanish civil administration until Spain ceded control to the federal government of the United States of America through the Treaty of Paris in 1901.

The participants of the 1966 Manila Summit Conference were Prime Minister Harold Holt of Australia, President Park Chung Hee of the Republic of Korea, Prime Minister Keith Holyoake of New Zealand, President Ferdinand Marcos of the Philippines, Prime Minister Thanom Kittikachorn of Thailand, President Lyndon B. Johnson of the United States of America, and Prime Minister Nguyen Cao Ky and Chairman Nguyen Van Thieu of South Vietnam.

The amount of **US \$500 DODECALLION** is backed up by at least **1 million metric tons of dorè bullion** (dorè gold bars are typically a super high gold content alloy, sometimes actually pure) created at the site of “LEMORIA” (or LEMURIA) that refers to gold mining in the Hollow Earth or Inner Earth.



I recently sent letters to Queen Elizabeth II, King Felipe VI and Queen Letizia, King Harald V, Queen Margrethe II, Grand Duke Henri and Grand Duchess Maria Teresa of Luxembourg, and King Carl XVI of Sweden, requesting their assistance to my worldwide enforcement of the **Code of K.O.R.A.N.**

With reference to Mauro's official document dated February 10, 2011, the **ALPHA OMEGA GLOBAL MARSHALL PROGRAM** has an (initial) appropriation of **US \$456 TRILLION** under the **Code of K.O.R.A.N.**

For Mauro, the total amount of my treasury is **US\$ 1214 TRILLION!**

I have the honor to provide you more information about my Global Assets.

Human Trust (人類資金 Jinrui Shikin), which is the 2013 Japanese suspense film, ascertains the existence of the **M-FUND** (meaning “Mankind Fund”), which is the secret joint U.S.-Japan account for gold-based currencies.

In their expository book entitled *Gold Warriors: America’s Secret Recovery of Yamashita’s Gold*, Sterling and Peggy Seagrave reveal that the only people who knew of the stashes of the 175 hidden treasure vaults in the Philippines were the Japanese military tops and the Imperial Family, also referred the Imperial House of Japan including the Emperor Hirohito whose name has a meaning of “abundant benevolence”. The Seagraves also allege that the Emperor Hirohito appointed his brother Prince Chichibu to head a secret organization from 1937 to 1946 called “The Golden Lily (Kin no yuri) Operation” by which the Imperial Household’s members were personally involved in a territorial expansion for their massive ‘treasure hunting’ in Asia.

Prince Chichibu’s secret team was given a code name of the Golden Lily after a poem the said Emperor had once written. The Golden Lily Operation included the **Yamashita’s Gold**. Together with Nazi war loot from Europe, the United States funneled the Yamashita’s Gold into the **Black Eagle Trust**, named after the Nazi insignia stamped on gold bullion stolen by the Nazis and discussed clandestinely at the Bretton Woods in 1944, from which the Federal Reserve System and others would be greatly and secretly funded.

According to this YouTube video entitled *The Philippine History Revisited: The Wealthiest Nation on Earth*, which is (secretly) authored by Karen Hudes, **Dr. Jose P. Rizal** is the father of German Führer **Adolf Hitler** and Japanese General **Tomoyuki Yamashita** (goo.gl/uFWFG5 [downloadable pdf file]).

In his online article entitled “*The Spoils of War: The Secret Story of WWII Japanese & Nazi Gold*”, David Guyatt reveals the plans of the United States in tandem with England **before** the Second World War, to wit:

“The United States had its own well-laid plans to become the imperial world power of post WWII. These plans had been formulated before the Second World War by The Council on Foreign Relations an organization founded by wealthy Americans in the wake of WWI, in tandem with England’s Royal Institute of International Affairs, known as “Chatham House” for short.”

I renewed with U.S. President Donald John Trump the **1950 BILATERAL MINESFIELD BREAKTHROUGH SUCCESSOR AGREEMENT (BMBSA)**, enabling the Federal Reserve System with all the 13 vaults of my gold bullion (“The Golden Lily”) as the super **GOLD BULLION BANK OF THE WORLD**. I am the Federal Reserve System’s Chairperson; I am the Successor-Heir and Sole Owner of the Black Eagle Trust’s Japanese and Nazi Gold.

In *Day of Deceit: The Truth About FDR and Pearl Harbor*, Robert Stinnet proves America's greatest secret and worst military disaster. The attack on Pearl Harbor was NOT a surprise military strike by the Imperial Japanese Navy Air Service against the United States naval base at Pearl Harbor, Hawaii Territory, on December 7, 1941. For Stinnet, the attack was a result of the carefully orchestrated design initiated by the U.S. government.

Stinnet's book still makes the case that the attack on Pearl Harbor was the result of an intentional 8-step plan drawn up by Naval Intelligence Lieutenant Commander Arthur H. McCollum and implemented by then U.S. President Franklin Delano Roosevelt (FDR) in cahoots with the Japanese military tops.

FDR dispatched his closest adviser and the Secretary of the War Cabinet, Harry Hopkins, to meet British Prime Minister Winston Churchill in January 1941. Hopkins told Churchill: "**The President [FDR] is determined that we [the United States and England] shall win the war together.**"

The Japanese attack on Pearl Harbor on December 7, 1941 marked the official entrance of the United States into World War II, demonstrating FDR's ulterior motive of winning the war on the British side.

FDR ordered General Douglas MacArthur to launch a number of successful offensive operations against the Japanese military in the Pacific including the Philippines during the Second World War after the 1941 Pearl Harbor attack. General MacArthur successfully accomplished his 'retaliatory' mission with Secretary of War Henry L. Stimson who ordered Assistant Secretary of War John Jay McCloy to be the planner of the **Black Eagle Trust**.

For Karen Hudes, the atomic bombings of Hiroshima and Nagasaki in 1945 hastened the Japanese surrender, causing Hitler to redirect his treasure ships of looted gold and valuables toward his ally, Japan, to the Philippines.

Based on the online article entitled "*The Secret History of The Atomic Bomb*", Albert Einstein's letter to FDR dated August 2, 1939 was delivered personally by Alexander Sachs, who is a bagman for the Rothschilds, on October 11, informing FDR that **the Rothschilds approved of the atomic bomb project** (goo.gl/hTFxpF). The Rothschilds were behind the costly project.

The financial power of England is centered in the London Branch of the House of Rothschild (goo.gl/kut919). The Rothschild family controls the United States of America through 'their' private Federal Reserve System (goo.gl/sMLNwc). According to the said weblink, the **House of Morgan**, which also fell under Rothschilds' and Rockefellers' control, encouraged the Japanese attack on Pearl Harbor in 1941 by conspiring to share war profits with the Iwasaki and Dan clans who owned Mitsubishi and Mitsui in Japan.

According to Hudes, **Rizal, in his disguised role as “Fr. Jose Antonio Diaz”**, elicited secret information directly from his son, Yamashita, identifying easily valuable burial sites of massive looted wealth in the Philippines.

In 1944, General Dwight Eisenhower initiated the Bretton Woods Conference to confiscate all the Gold stolen by Hitler and Yamashita (goo.gl/eACpka).

The recovered Nazi and Japanese treasures – the ‘Black Gold’ – gave Washington virtually limitless, unaccountable funds, providing an asset base to reinforce the treasuries of America’s allies (goo.gl/9pbTvL).

Based on the Treasury Certificate, the Rothschild & Sons (Great Britain) with Account Number 3092837667712 has a net balance of \$ ∞ and time deposit of 4% per annum since January 1, 1967. **The Rothschild family is linked with all depository information for the People of the Philippine Islands and the Authorized Party of President Ferdinand E. 





This Declaration Order, covered by the Law of Treaty of Perpetual, verified on February 7, 1976 that I, as **TVM-LSM-666**, have full discretionary power on my Trust Asset-Commodities in Bullion Banks around the world. Then Presidents Ferdinand E. Marcos and Gerald R. Ford signed this Declaration from the **United Nations Conference on Trade and Development (UNCTAD)**.



The Manila Declaration General Assembly of the Group of 77 – 1981 adopted the **New World Legal Order** dated October 4, 1982 in UNCTAD, Cancun, Mexico. The **New World Legal Order** has only five Commissions: (1) **UNCTAD**; (2) **United Nations Industrial Development Organization (UNIDO)**; (3) **United Nations Higher Commissioner for Refugees (UNHCR)**; (4) **World Health Organization (WHO)**; (5) **ALPHA OMEGA** or the **AOWDMP**, which is under my Chairmanship.


This Letter of Instruction also confirmed my **Titular Decree: 010-22-74-OA**.



Regarding the refusal of any trustee bullion bank to coordinate and comply with the Rule of Banking Law of Bailment, the liable Bailee is punishable under Veto Act or Embargo Act 1807.

Refer to this copy of the Delivery Receipt's original dated August 11, 1950 that reveals the 400,000 metric tons of Gold with Gold Certificate Numbers 083-030-L-50 in the treasury vault of the Central Bank of the Philippines (CBP). Based on the CBP's Receipt, the Gold and other commodities are Integral Part of the Bilateral Memorandum of Agreement or the 1950 BMBSA.



In addition, the said 400,000 metric tons of Gold were lawfully derived from King Solomon's 1,181,336,675 metric tons of Gold, which I inherited from my ancestor named Marcus Ulpius Trajanus or Trajan (98 to 117 AD), Roman Emperor, through **King Ferdinand VII** under the Code of KORAN.

The CBP's Receipt was signed by **Fr. Jose Antonio Diaz** whose known real name is Jose Protacio Mercado (JPM) before he called himself Rex al or Rizal (JPR) or King of Kings. JPR had access to King Ferdinand VII's vast wealth.

In 1939, JPR and two members of the Tallano clan, brought 640,000 metric tons of Gold, which would be LENT to Pope Pius XII, to the Vatican where he was known as Jose Antonio Diaz de la Paz or secretly the Black Pope (or the Jesuit Superior General). As written in the CBP's Receipt, my grandfather is **King Ferdinand VII** of Spain (also known as Don Amando Villamor, et al.), and my grandmother is **Queen Isabel II** of Spain who was instrumental in the establishment of the **EL BANCO ESPAÑOL FILIPINO DE ISABEL II** in the Philippines.

King Ferdinand VII, who is also known as the **Code of FLAT-KORAN** (Ferdinand Lacan Acuña Tallano [**FLAT**] – King of Recognized Asset Nations [**KORAN**]), was King Felipe's Successor-Heir in the Sole Ownership of the **HACIENDA FILIPINA ARCHIPELAGO** with the **Original Certificate of Title (O.C.T.)
