- **Anthony Fauci**, lead member of the Trump Administration's White House Coronavirus Task Force; and
- **Christine Grady**, head of the National Institutes of Health (NIH); and
- **Tedros Adhanom** head of the World Health Organization (WHO), and

BE IT RESOLVED, that a motion was passed to declare the pandemic, declared by the World Health Organization (WHO) as a fake pandemic; and
