### Minutes of the previous Council meeting 8<sup>th</sup> June 2022

It was Resolved that the minutes of the meeting be approved and signed by the Chair

### Road to Fraisthorpe Beach

Chairman told the council that this could become a major issue as the road is eroding rapidly, the road is not suitable for the amount of traffic that uses it., There is a danger of road eventually disappearing.

Cllr Jackson met with a representative from East Riding some 3 months ago but no action has yet been taken

Cllr Manuel showed the council photos of the badly worn road. Cllr Manuel said he would like another site visit for this matter to be re addressed.

### Parish Council Land at Fraisthorpe Beach

There is a small area of land by car park on beach at Fraisthorpe owned by The Parish Council. this is now being used for parking and motorhomes staying overnight on this area of land. It was suggested that signs be made telling its land owned by council and access is always needed.

### Layby at Fraisthorpe

There is a new Mobile catering van at layby, Cllr Manuel asked Cllr Evison if holes in and near layby could be filled with any spare road repair.

### Bridge at Fraisthorpe

Cllr Manuel showed the council pictures of the bridge which shows that the bridge walls are wearing away, there is a danger of the bridge falling in. The bridge should have a weight limit on and currently does not, Cllr Evison to investigate.

### Bus Shelter

We now have funding from Lissett Wind Farm Community Fund, Chair said that we need to decide what type of Bus shelter to purchase, Chair to obtain new updated prices for Bus shelter and for the laying of concrete slab for it to go on, before next meeting, so decisions can be made so work can start.

### **New Seats at pond**

Two of the seats at the pond that was purchased earlier in year, the screws have rusted, clerk has tried to contact company, to rectify this, but they have gone into Liquidation  
Chair has priced up for new screws and asked permission to purchase and replace himself, all agreed

### **Litter Pick**

After several residents asking about a litter pick in the village, all agreed to organise one for October  
It was suggested that it be held on Saturday 29<sup>th</sup> October 2022, refreshments would be provided after at Village Hall  
Clerk to put add in next edition of Village Voice,.

### **Defib Course**

Clerk informed the Council that she has been in contact with North Yorkshire Ambulance Service who organise training De Fib training, dates are available in January evenings or a Saturday Morning. After a discussion it was agreed by all a Saturday morning would be better it was agreed to book the date for Saturday 28<sup>th</sup> January 2023.

Clerk to book date with Ambulance service and The Village Hall to be advertised in Village Voice later in year for people to put names forward if they want to attend.
