MyEPO is a suite of online services that makes it easy for you – a patent applicant, opponent or representative – to conduct your EPO business:

- MyEPO Portfolio is the place for interacting with the EPO during EP, UP and PCT proceedings.
- Online Filing 2.0 is the tool for you to file EP and PCT applications and requests for unitary effect, as well as submissions in opposition, appeal and other proceedings.
- **Central Fee Payment** gives you all the options for paying fees relating to patent proceedings and allows you to claim refunds.

During this seminar, you will learn more about the features and benefits of **MyEPO Portfolio**, which offers representatives and paralegal staff:

- easy access to portfolios of applications and deadlines, including direct access to the digital files associated with each application filed with the EPO
- fully operational access to your EPO Mailbox, including options to create email alerts for new communications, pending procedural actions and deadlines
- the ability to reply directly to selected EPO communications, with streamlined steps and guidance
- a shared area for live interaction with examiners on documents
- a business-to-business technical interface (API) for automating download of Mailbox communications to their IP management systems

And it offers company administrators the possibility to manage user permissions, Mailbox access and fee payment rights.

MyEPO Portfolio replaces the old Mailbox, MyFiles and Administration Facility tools which will be decommissioned in June 2024.

Niclas Morey, EPO
