

Kære beboer i Bispeparken

Jeg skriver til dig, fordi Bispeparken stadig er på den såkaldte "ghettoliste", som Transport- og Boligministeriet offentliggør den 1. december hvert år.

Listen er en oversigt over almene boligområder, hvor Folketinget mener, at der bor for mange beboere, der enten har for lav indkomst, højst 10 års skolegang, en dom for overtrædelse af straffeloven eller er uden arbejde.

Vi gør, hvad vi kan

I fsb gør vi alt, hvad vi kan, for at Bispeparken ikke er på listen næste år den 1. december 2020. Det kan du læse mere om i dette brev, og du kan også møde op til afdelingsmødet den 8. juni 2020, hvor vi vil fortælle mere om planerne for at udvikle og styrke Bispeparken.

I løbet af 2019 er der sket flere ting, der forhåbentlig kan være medvirkende til, at Bispeparken ikke er på listen næste år. Det er blandt andet:

1. Ny udlejningsaftale

Københavns Kommune og de københavnske boligorganisationer vedtog i juli 2019 en ny udlejningsaftale. Udlejningsaftalen skal blandt andet sikre, at de beboere, der flytter ind i Bispeparken, lever op til specifikke krav i forhold til beskæftigelse, indkomst, uddannelse og kriminalitet.

2. Udenlandske uddannelsesbeviser

22 beboere har fået deres udenlandske uddannelse vurderet og godkendt i Danmark. Det betyder, at Bispeparken har 22 beboere, der nu er registreret med en højere uddannelse end tidligere.

3. Uddannelsesvejledning for unge

Den boligsociale helhedsplan, Beboerprojekt Bispebjerg, har i 2019 tilbudt vejledning til afdelingens unge, som ikke er under uddannelse, for at få flere af dem til at tage en uddannelse.

Bispeparken skal væk fra listen

Trods disse tiltag er Bispeparken altså stadig på listen. Det skyldes, at ministeriet laver listen ud fra informationer, der er op til 2 år gamle. Derfor vil fsb's indsatser i år tidligst kunne påvirke den liste, som bliver offentliggjort den 1. december 2020.

Så vi fortsætter alle ufortrødent. Det skal lykkes. Vores håb er, at i år er sidste gang, at Bispeparken optræder på listen.

Dear resident in Bispeparken

I write to you because Bispeparken is still labelled as a so-called “ghetto” on the list released by the Ministry of Transport and Housing 1st December every year.

The list is an overview of the social housing estates where Folketinget has judged that too many of the residents either have too low of an income, a maximum of 10 years in school, a sentence under the criminal law, the arms act or the law on drugs or are without employment.

We do our very best

In fsb, we are doing everything we can to have Bispeparken removed from the list by 1st December 2020. You can learn more about our efforts in this letter. You can also attend the general assembly in Bispeparken 8th June 2020, when we will inform further about our plans to develop and strengthen Bispeparken.

During 2019 several things have happened that we hope will contribute to our goal of not having Bispeparken on the list next year. These are among others:

1. New Rental Agreement

Copenhagen Municipality and the social housing companies in Copenhagen reached an agreement on the new rental agreement in July of 2019. Among other things the agreement will ensure that new residents in Bispeparken comply with several criteria regarding employment, income, education and criminal records.

2. Degrees from abroad

22 residents have had their degrees from abroad assessed and recognized in Denmark. This means that Bispeparken now has 22 residents who are registered with a higher level of education than before.

3. Education counselling for youths

Throughout 2019 the social housing program, Beboerprojekt Bispebjerg, has offered counselling to youths in Bispeparken, who are not currently involved in an education program. The objective is to get more of them to enroll in some sort of education.

Bispeparken must be removed from the list

Despite these initiatives, Bispeparken is still on the list. This is due to the fact that the Ministry create the list using information that may be up to 2 years old. Initiatives taken this year will therefore only have an effect on the list to be published 1st December 2020 at the earliest.

We continue our work relentlessly. We must succeed. We hope that this year is the last year that Bispeparken is on the list.
