Welcome from the current Chair


Thank you for your interest in becoming a Trustee.

About the Choral Foundation

The Choral Foundation at His Majesty's Chapel Royal, Hampton Court Palace, preserves and promotes the unique heritage of choral music 500 years in the making. Recognised as the cradle of Evensong, composers such as Tallis, Byrd, Purcell composed for the choir and their music is still being sung by the choir today.

The choir forms part of the Ecclesiastical Establishment of the Royal Household and is an integral part of the iconic Tudor palace open to the public, but it is not fully funded. The Choral Foundation was set up in 2011 to fund the musicians and choristers and build an endowment to secure this historical tradition in perpetuity.

The institution may be 500 years old, but the Choral Foundation is forward thinking. The choristers come from a broad range of schools through an open recruitment process designed to spot potential and the Choral Foundation funds their musical education, giving every boy with talent the opportunity to gain a place in the choir directed by Carl Jackson MVO. The Choral Foundation works to bring the music to new audiences and to commission or introduce to the repertoire new choral pieces. Most recently, a local schools' programme called Songstars has been developed to bring singing into local schools, working with children and their teachers at schools in Hounslow to nurture musical education and the joy of coming together in song.

The role

We are looking for a Trustee who has expertise in fundraising to join the Board of the Choral Foundation.

We expect, in due course, to appoint a Development Director /fundraiser who will manage day to day operations and

- we need your skills to help update our fundraising strategy
- we expect you to be involved in shaping the operational role and appointing the Development Director
- your role would include monitoring and supporting the new job holder

Time commitment

- Full Board meetings 4 times per year, usually in person at Hampton Court Palace, sometimes in London, usually Wednesday evenings between 5-6.30pm
- Chairing the Fundraising Committee as needed, mostly virtually and around 6 times per year with calls and correspondence in the interim.
- Supervising the work of the Director of Development/ fundraiser once appointed, probably via weekly calls. Conducting annual appraisal with input from Chair and other Trustees.
- Attending occasional events during the year.
- Attending services or events at the Chapel Royal Hampton Court Palace

Term of office

Trustee appointments are for three years. They may serve second terms, if approved, and have this extended further in exceptional circumstances.

Our governance and board

The Choral Foundation, The Chapel Royal, Hampton Court Palace ("The Choral Foundation") is a company limited by guarantee (registered company number 07542466) and a registered charity (registered charity 1142075, England and Wales).

The main Board meets four times a year, currently late afternoon on the first Wednesday in March, June, September and December. There are main sub committees covering Finance & Investment, Fundraising and Songstars (committee which oversees the work of our community singing programme). The Chair is invited but may not always attend the latter two.
