# Minutes of Committee Meeting held via Zoom on Monday 29 March 2021 at 7pm

## 2 Minutes and matters arising:

#### 4 CWDF Annual Report May 2020-April 2021:

Comments:

- Date in title needs to be altered to 2020
- Very comprehensive report on CWDF's year
- Concerns raised about whether should include referral to 2 political issues which emerged last year ie the merger of DfID with the Foreign Office and the reduction in the aid budget. Although these issues of grave concern to CWDF perhaps the annual review is not the place for such comments?
- Following on from that was the issue of whether to mention the Government's Integrated Review in the report.
- Some concerns also raised about the inclusion of the statement on nuclear weapons issue in last paragraph.
- May be more advisable to have a discussion and seek the views of Forum members and then issue a position statement separately to send to Dominic Raab
- Some committee members felt that mention of the Integrated Review was acceptable in the report but that the comments on nuclear weapons could be omitted

BP and TG will revise the statements before the next committee meeting. Finally, BP encouraged the committee to look at the Integrated Review as it contained some very worrying statements
