1. General Information

As a Non Profit Church Foundation, Stichting Ondersteuning Christ Church Amsterdam is a registered ANBI (Algemeen Nut Beogende Instelling) under Dutch law, registered under KVK number 4121231 with RSIN number 8052751. An ANBI is a public benefit institution. An institution can only be an ANBI if it is at least 90% committed to the public benefit. 2. Accepted Payment Methods

Donations to Christ Church Amsterdam can be made securely through our app or website using the following methods

- iDEAL (for Dutch and Belgian bank accounts)
- Credit and Debit cards (Visa, Mastercard)
- PayPal

We also accept:

- Bank transfers
- SEPA Direct Debit (for recurring donations)

Payments are processed through Buckaroo in full compliance with:

- EU Payment Services Directive 2 (PSD2)
- Strong Customer Authentication (SCA)
- PCI DSS security standards

3. Use of Donations

- Building maintenance

4. Refund Policy

Donations are generally non-refundable. If a donation was made in error (e.g., wrong amount, duplicate transaction), please [contact us](#) within 14 days of the transaction. We will assess refund requests on a case-by-case basis; please note that credit card fees are non-refundable.

5. Tax Deductibility

Donations to Christ Church Amsterdam may be tax-deductible. Some guidelines* to qualify :

- One-time donations: Must exceed 1% of your annual income.
- Periodic donations (min. 5 years): are fully deductible with a signed agreement.

6. Data Protection (GDPR)

We collect only necessary personal data (e.g., name, email, transaction details) to process your donation and provide receipts.

- Your data is securely stored and not shared with third parties unless required for legal or payment processing reasons.
- Under the GDPR, you have the right to access, correct, or delete your data.

7. Security

All online donations are encrypted and transmitted via secure SSL connections.

Christ Church Amsterdam does not store your credit card details.

8. Anti-Fraud and Compliance

We monitor transactions for compliance with Dutch and EU Anti-Money Laundering (AML) laws. We reserve the right to decline or refund donations if fraud, coercion, or other concerns are suspected.

9. Inactive Wallet Funds Policy

If a donor leaves the Christ Church Amsterdam congregation or ceases using the digital giving functionality, any remaining donated balance in their app wallet that has not been designated to a specific cause or location will, after a period of 12 months of inactivity, be reallocated as a designated donation to the Chaplaincy. These funds will be used to support the ongoing ministry and operational needs of Christ Church Amsterdam.
