### Day 2:

1. Cash flow analysis and predicting the financial future of the company.
2. Evaluating investments and growth opportunities using advanced financial analysis techniques.
3. Understanding economic analysis and its impact on the company and the sector.

### Day 3:

1. Financial risk analysis and implementing risk control strategies.
2. Utilizing advanced financial models to evaluate companies and projects.

3. Analyzing financial scenarios and their impact on strategic decision-making.

### Day 4:

1. Advanced financial performance analysis and using sophisticated models to measure efficiency and competitiveness.
2. Understanding factors influencing strategic financial decision-making.
3. Analyzing the competitive environment and evaluating current and future financial challenges and opportunities.

### Day 5:

1. Applying acquired knowledge in practical case studies and simulations for advanced financial analysis.
2. Identifying improvement opportunities and developing strategies to enhance financial performance.
3. Reviewing best practices in financial analysis and outlining action plans for their implementation in daily operations.

## Program Methodology:

The program will be conducted along workshop principles with formal lectures, case studies and interactive worked examples. Relevant case studies will be provided to illustrate the application of each topic in an operations environment. Difficult concepts are minimized wherever possible and handled in a visual way that is easy to understand with examples demonstrated.

Each learning point will be re-enforced with practical exercises.
