

The active participation of undocumented citizens in decisionmaking and public life is at the core of City Rights United. The participation of marginalised groups stimulates civic democracy in Europe and improves their situation in Europe.

Since 2019, City Rights United, a network of grassroots, migrant-led and cultural institutional organisations have collaborated to cocreate a Toolkit for Inclusive Cities: a collection of innovative and creative practices and ideas to make cities more inclusive for undocumented people.

The toolkit is a collective effort by a coalition of people with and without documents from all over Europe by exchanging experiences struggles and solutions. They have come together both online and during in-person conferences in Amsterdam, Utrecht, Hamburg and Naples. The knowledge shared is now combined in the Toolkit for Inclusive Cities.



The toolkit consists of a series of 15 illustrated ers showing the practices, a website, a series of webinars and presentations during the Unite for City Rights Conference: 12 - 14 May 2022, Each poster has a QR code with directs you to the online toolkit at the City Rights United website.
