## 1. Introduction

The European Commission is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to Regulation (EU) 2018/1725 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This privacy statement explains the reason for the processing of your personal data in the context of the meeting, organised by the European Commission. It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller (cfr. point 9) with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

## 2. Why and how do we process your personal data?

<u>Purpose of the processing operation</u>: the European Commission collects and further processes your personal data to provide you with information about the specific meeting or event (before, during and after) and to process your application for participation in that meeting or event.

Your personal data will not be used for any automated decision-making including profiling.

Please note that this meeting will be held using the third party IT services which processes personal data. Please read section 7 below for more information.

Live web-streaming and audio-visual recording at the event of the speakers, organisers and participants, including the audience or non-speaker participants, as well as photographs, panoramic photographs and screenshots will be taken and published in the context of the event as indicated in the specific consent forms linked to this event, specifically on <a href="https://www.copernicus25.eu/">https://www.copernicus25.eu/</a>, and on the DG DEFIS Europa website.

Consent will be asked via the online registration form. For more information on which personal data is collected and for which purpose, please see point (3) and (4).

### **Speakers and moderators**

Names of moderators and speakers will be published on <a href="https://copernicus25.eu">https://copernicus25.eu</a> and may be published on <a href="the DG DEFIS Europa website">the DG DEFIS Europa website</a>.

Speakers' entire interventions, including electronic files, likeness, voice and verbal statements will be recorded and live-streamed on Clevercast.

# 3. On what legal ground(s) do we process your personal data?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the Celebrations of the 25th anniversary of Copernicus event (including registration, live-streaming, photos, audio-visual recording, Q&A) are necessary for the management and functioning of the Commission, as mandated by the Treaties. Those provisions are in particular, Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union.

Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body).

The processing operations on personal data of the speakers for the meeting or event with whom a contract is concluded, are carried out in line with the contractual provisions. Consequently, that processing is necessary and lawful under Article 5(1)(c) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract).

## 4. Which personal data do we collect and further process?

Registration to view and submit questions for the event is not compulsory.

If you decide to register, the following personal data may be processed in the context of the event:

	contact details (function/title, first name, last name, name of organisation, city, country, email address, telephone & mobile numbers);
	nationality, passport or identity card number and its date of issue and expiry date may be collected, so that the data subjects may obtain access to the premises where the event is held;
	dietary requests or specific access requirements;
	photos and audio-visual recordings;
	photos and biographies (of speakers/moderators) for promotional purposes;
	shared files or presentations;
	IP address, anonymised browser-generated information for analytics (device information, operating system, device type);
	other personal information voluntarily disclosed by participants during the Q&A sessions.

	Slido for Q&A (optional): First name, last name, organisation (it is possible to submit questions without sharing the identity);
	Clevercast (video web player): IP address, anonymised browser-generated information for

5.	How long do we keep your personal data?
of t	Data Controller only keeps your personal data for the time necessary to fulfil the purpose his processing or further processing.
	each of the categories of personal data that may be processed, please find below the ention details and the reference to the relevant record of processing:
	Personal data related to the organisation and management of the event (this includes the information given during the registration, before, during or after the event) will be kept for <b>five years</b> after the event.
	Sensitive personal data relating to dietary and/or access requirements will be deleted as soon as they are no longer necessary for the purpose for which they have been collected in the framework of the event, but no later than within <b>1 month</b> after the end of the event.
	Recordings from the web-streamed event will be kept for <b>2 years</b> before being deleted. More information is available in the Record of Processing DPR-EC-00306 (Web-streaming of Commission events).
	Photos and videos for which consent was obtained via the registration form for the event will be kept for <b>2 years</b> . Their publication in the channels identified in the registration form will

follow the longevity of the content posted therein, unless consent was redrawn at an earlier stage.

- □ In case of audio-visual recording of the event, the recordings will be kept for **3 months** after the event before being deleted. More information is available in the Record of Processing DPR-EC-01937 (Audio-visual recording of meetings). Their publication in the channels identified in the registration form will follow the longevity of the content posted therein, unless consent was redrawn at an earlier stage.
- Personal data shared with the Directorate-General for Human Resources and Security of the European Commission for the participants to gain access to Commission buildings is kept for 6 months after the termination of the link between the data subject and the Commission.

Personal data shared with the controller for future mailing purposes (e.g., for receiving newsletters or invitations to similar events) are processed in line with the Record of Processing **DPR-EC-03928** (Management of subscriptions to receive information) and the specific privacy statement prepared by the organising Commission service.

Selected service providers for organisational purposes (such as caterers, travel agents or event management organisations) are contractually bound to process personal data on behalf of and in line with the instructions of the data controller, to keep confidential any data they process and to protect it from unauthorised access, use and retention.

## 6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission or of its contractors. All processing operations are carried out pursuant to <a href="Commission Decision (EU, Euratom) 2017/46">Commission Decision (EU, Euratom) 2017/46</a> of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

The Commission's processors (contractors) are bound by a specific contractual clause for any processing operations of your personal data on behalf of the Commission. The processors have to put in place appropriate technical and organisational measures to ensure the level of security, required by the Commission.

## 7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

#### Cookies

Cookies are short text files stored on a user's device (such as a computer, tablet or phone) by a website. Cookies are used for the technical functioning of a website (functional cookies) or for gathering statistics (analytical cookies).

The web stream of the event will be available on a Commission website. The cookies employed by the Commission will be covered by the cookie policy of the Commission, which is available here: <a href="https://ec.europa.eu/info/cookies\_en">https://ec.europa.eu/info/cookies\_en</a>.

When you visit the web page of the event, we will indicate how long we will keep the browser history of your visit. This information will then be deleted. The collection, aggregation and anonymising operations are performed in the data centre of the European Commission under adequate security measures.

Cookies are stored by Europa Analytics, the corporate service which measures the effectiveness and efficiency of the European Commission's websites on EUROPA. More information is available in the Record of Processing DPR-EC-00685 (Europa Analytics).

Enabling these cookies is not strictly necessary for the website to work but it will provide you with a better browsing experience. You can delete or block these cookies, but if you do that, some features of the meeting/event website may not work as intended.

The cookie-related information is not used to identify data subjects personally and the pattern data is fully under the Commission's control. These cookies are not used for any purpose other than those described here.

Should you wish to opt your personal data out of our anonymised, aggregated statistics, you can do so on our cookies page. In particular, you can control and/or delete those cookies as you wish.

- Under Cookie Settings the user can choose which categories to allow: Necessary,
   Preferences, Analytical, Other Cookies
- Under 'Cookie Declaration', detailed information on each Cookie can be found.

Geolocation has been disabled - all users will be able to manage cookie choices and will get the CookieHub dialog on the first load.

Enabling cookies is not strictly necessary for the event information website to work but it will provide you with a better browsing experience. You can delete or block these cookies, but if you do that, some features of the Copernicus Conference website may not work as intended. The cookie-related information is not used to identify data subjects personally. These cookies are not used for any purpose other than those described here.

# Third party IT tools, including Social Media

We may use third party IT tools to inform about and promote the meeting/event through widely used communication channels, including the social media. You may be able to watch our videos, which may be also uploaded to one of our social media pages and follow links from our website to other relevant social media.

In order to protect your privacy, our use of third party IT tools to connect to those services does not set cookies when our website pages are loaded on your computer (or other devices), nor are you immediately redirected to those social media or other websites. Only in the event that you click on a button or "play" on a video to watch it, a cookie of the social media company concerned will be installed on your device. If you do not click on any social media buttons or videos, no cookies will be installed on your device by third parties.

In order to view such third-party content on our websites, a message will alert you that you need to accept those third parties' specific Terms and Conditions, including their cookie policies, over which the Commission has no control.

### International transfers

Please note that pursuant to Article 3(13) of Regulation (EU) 2018/1725 public authorities (e.g. Court of Auditors, EU Court of Justice) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as recipients. The further processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

# 8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

If you consented to provide your personal data to the data controller for several processing operations, mentioned under Heading 3, you will be able to withdraw that consent at any time by notifying the data controller. Withdrawal of your consent will not affect the lawfulness of the processing carried out before the withdrawal occurred.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.
