STATUS

Almost 2/3 of the total patient population has been included in the AID-ICU trial. We are picking up speed and getting back to normal after the pandemic put a halt to inclusion at many sites in the spring. The second wave of the pandemic have struck Europe hard and many countries are struggling with high incidence rates including Denmark. The health care system in Denmark is however better fit for this second wave and as opposed to the first wave all research activities are still running. We are still fighting to improve outcomes for the most vulnerable patients in the ICU – the delirious patients.


INTERIM ANALYSIS

Our Data Monitoring and Safety Committee (DMSC) held their interim meeting on the 28th of September 2020 to evaluate data from the interim analysis performed on the first 500 patients included in the AID-ICU trial. Sponsor and Coordinating Investigator presented the data on an online investigator meeting the 9th of October. If you did not have the chance to participate, we will present some of the data in this newsletter (see box below). Our DMSC consist of




Interim data

Of the 500 included patients 196 (39%) were dead at 90day follow-up, while 295 (59%) were alive. We had missing data from 9 patients (2%). Below is our primary outcome 'Days alive and Out of Hospital' (DAOH) illustrated in a histogram. Note that 0 DAOH accounts for in-hospital mortality and patients that are still admitted to hospital at 90-day follow-up. The largest bar illustrates these patients. The median DAOH was 25, while interquartile range was 0-66.

Safety data of the 500 patients showed that 8 patients had experienced Serious Adverse Reactions (SARs). Five were Ventricular Arrythmia (VT/VF), 1 Malignant Neuroleptic Syndrome and 2 Hepatic Failure. 286 patients have received escape during the intervention period.

Protocol Compliance

10% of the included patients had a major protocol violation registered during the intervention period. 4% due to use of open-label antipsychotics, while 6% was due to protocol deviations in management of trial medication.
