Entries acceptance criteria	The World Boxing Cup BRAZIL 2025 is an open-entry competition, with participation determined by the following priorities. The first priority is given to the winners of the 2023 and 2024 World Boxing Cup stages, as well as the Paris 2024 Medalists. To ensure transparency, Final Entry Lists will be circulated to all participating teams, keeping everyone informed of potential draw cut-offs. Withdrawals, including late withdrawals will be managed in accordance with Article 5 of the Competition Rules.
Ranking points	World Boxing Cup Champion – 300 points / Silver medal – 200 points / Bronze medal – 150 points, per Competition Rules Article 1.10.10.
Number of rings	One or Two dependent on entry. If two rings required for Preliminary rounds the event will transition to one ring for semi-finals and finals

4. ENTRY PROCESS

It is required that respective participating National Federations confirm the technical and medical standard of the boxers and other Team Members. Participating National Federations are also responsible for submitting the personal data on behalf of each member of their Team, and for ensuring that the personal information provided during the entry process is accurate.

At this time, the entry process for Teams is completed via email, as specified in the table below:

Registering reserve boxers is strongly encouraged to allow for substitutions after the entry deadline prior to the Sport Entries Check without penalties.

There will be a participation fee for National Federations to ensure neutrality requirements. Further details on the fee structure will be provided in January. Bringing a World Boxing certified Referee and Judge to the competition is highly encouraged. Referee and Judges are subject to confirmation by World Boxing, and ultimately, the NF might be asked to replace the proposed R&J.

Withdrawals after the final entry deadline will not be refunded.

It is the responsibility of participating National Federations to ensure that all Team Members are qualified to perform their duties.

4.1. Sport Entries Check

The Sport Entries check is the final part of the event entry process and it will take place on 30th March, time and location TBC. World Boxing and the LOC will inform Teams of their exact appointment time prior to the event as well as it will be displayed on the Team information board.

The Sport Entries Check is mandatory for all Teams, and teams should make all necessary arrangements to arrive timely for their respective appointment.

Each Team may appoint a maximum of two people to attend its Sport Entries check (e.g. Team Manager and the Team Doctor).

In order to be cleared for the competition, Teams must provide the following documents for each boxer, signed and completed as required:

- Copy of passport
- Record Book (with annual medical examination completed within the previous 12 months)
- Medical Certificate issued within the previous three months, signed by the National Federation doctor
- Declaration of Non-Pregnancy Form (women boxers only), signed by the boxer/legal guardian
- Uniforms (red and blue) per World Boxing Competition Rules

To complete the Sport Entries process and receive accreditations, Teams must have fully settled their accommodation costs with the LOC.

Important: Failure to attend the Sport Entries Check per scheduled appointment by any Team will lead to the exclusion of the entire Team from taking part in the event.

5. VISA & ENTRY TO THE HOST COUNTRY

LOC will provide assistance to participating Teams requiring Visas but cannot guarantee their acquisition.

For information and visa support letters, please complete visa information form and email via worldcupbrazil2025@cbboxe.com.br. **The deadline to submit requests for visa support letters is 10 February 2025.**

Passports of all Championships participants must be valid for at least six months from the date of arrival and must contain blank page(s) for visa(s) and stamps.

It is the responsibility of participating National Federations to ensure that their Team respect the conditions of stay defined by the Government of the country hosting the event. If any participant does not respect these conditions, any costs arising will be borne by the respective National Federation.

6. INTERNATIONAL TRANSPORTATION

7. GROUND TRANSPORTATION

The LOC will provide airport transfers and ground transportation for Teams during the event period between airport-hotel-airport. Daily transportation will not be necessary, because competition venue and training area are in the hotel. If delegations are using an unofficial hotel or an official hotel, not reserved through the LOC, they are not allowed to use the official event transportation.

Additional transportation costs will apply when airport transfers or any other transportation is required outside of event days and costings will be sought on request.

Or, exceptionally, is possible to request to pay in cash, as soon the arrival. In this case, the information must send to worldcupbrazil2025@cbboxe.com.br, until 20th February, and it is necessary to pay 25% by money transfer. LOC will receive the complete payment at the airport, so the team will be taken to the hotel.

Please, request a corresponding invoice from the LOC before initiating the payment to settle the total amount.

10. IMAGE RIGHTS & VIDEO RECORDING

The LOC will film the event for broadcast, promotional videos and official event photographers will take still images of boxers before and during the event. All training sessions will be open to the accredited media unless a Team specifically requests otherwise. By participating in the event, each Team Member agrees to release his/her image rights to World Boxing and the LOC.

Video recording of bouts for broadcasting purposes of any kind (including social media) will not be allowed.

National Federations may be allowed to record bouts of their boxers using only one camera per ring, exclusively for technical purposes. Specific location in the venue will be reserved for this purpose. Each National Federation must submit a signed copy of Video Recording Disclaimer at the Technical Meeting to World Boxing Competition Manager.

11. MEDICAL SERVICES

The LOC will provide first aid during the entire event period to any participant who suffers from a sports injury contracted during the event.

12. ANTI-DOPING

Doping control will be conducted in accordance with World Boxing Anti-Doping Rules and World Anti-Doping Code. According to WADA regulations, blood testing may be conducted during World Boxing Competitions.

13. INSURANCE

All accredited participants must have their own travel, medical, repatriation and liability insurance covering the entire event and travel period.

14. TRAINING CAMP AND ACCLIMATIZATION

From 22/03/2025 – 29/03/2025 LOC will provide a “*Training Camp and Acclimatization*” facilities, with special charges, at the same hotel and competition place.

LOC will make available 120 (*one hundred and twenty*) places.
