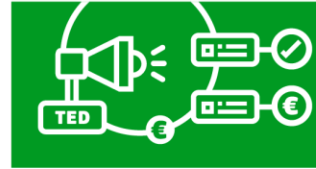

What is EUR-Lex?

- Online portal giving access to European Union law
- Managed and maintained by the Publications Office of the European Union
- Accessible in 24 languages
- Free of charge
- Constantly updated
- More than 1 million documentary units
- Up to 190.000 visits per day
- Access to the authentic Official Journal
 - Since 2013 only the electronic version is legally binding.



What can you find on EUR-Lex?

- Treaties
- International agreements
- Legal acts
- Preparatory documents and information related to legislative procedures
- EU case-law
- National case-law
 - National transposition measures
 - National case-law related to EU law

Each document is accompanied by analytical information and linked to other documents published on EUR-Lex
