Use of your personal data

On the website emilypals.nl you leave (personal) data. Emilypals.nl only asks for the most necessary data. Your e-mail address is needed to send you a newsletter; your name can be used to personalize e-mails. Emilypals.nl processes your personal data for the following purposes:

- Sending a newsletter
- Being able to e-mail you if you contact us via a contact form

Special and/or sensitive personal data

The website does not intend to collect data on website visitors who are younger than 16 years old. Unless they have parental or guardian consent. However, it is not possible to check whether a visitor is older than 16. If you are convinced that emilypals.nl has collected personal data about a minor without such consent, please contact us at emily@emilypals.nl and this information will be removed.

Retention of personal data

Emilypals.nl does not retain your personal data longer than is strictly necessary to fulfil the purposes for which your data is collected. If you unsubscribe from the mailing list, your data will remain in the system for a maximum of 1 month. For administration, the legal retention period of 7 years applies.

Sharing personal data with third parties

Emilypals.nl does not share personal data with third parties, unless this is necessary to comply with a legal obligation.

Cookies, or similar techniques

Emilypals.nl only uses technical and functional cookies. And analytical cookies that do not invade your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies used by emilypals.nl are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferences. They also allow emilypals.nl to optimise the website. You can opt out of cookies by configuring your internet browser to stop storing cookies. In addition, you can also delete all information previously stored via your browser settings.

Data inspection, correction or deletion

You have the right to inspect, correct or delete your personal data. You can do this yourself via the personal settings of your account. You can unsubscribe from a newsletter at any time. You also have the right to withdraw your possible consent for data processing or to object to the processing of your personal data. If you want to exercise your right to object or have other questions/ comments about the data processing, please send an email to emily@emilypals.nl. Emilypals.nl will respond to your request as soon as possible, but at least within four weeks. Emilypals.nl would also like to point out that you have the possibility to file a complaint with the national supervisory authority, the Personal Data Authority.
