Events Asia Match & Meet Policy **Terms And Conditions**

1. The Age Requirement Of Becoming A Valid Member Of Events Asia Match & Meet Membership Service, Must Be A Minimum Of 18 Years Of Age And Above, The Detailed Service Is Only VALID For UK Residents ONLY.
2. All Membership Information Provided Must Be Of A True, Accurate And Correct To The Best Of One's Self Knowledge. Members Maybe Be Obligated To Take A DBS Check In Accordance With Their Membership Due To Verifying Safety Measures To Protect Other Members And Staff, Also Events Asia Can Request Medical History Of Members From Their GP Surgery Which Can Have An Effect Of Their Overall Match Making Process And Will Be Accurate Of Their Vetting And Verification Status.
3. Members Are Strictly Prohibited And Forbidden From Owning Or Registering A Secondary Account.
4. All Membership Fees Can Be Paid By Debit / Credit Cards Or BACS Payments And Can Also Be Paid In Cash, All Membership Fees And Payments Are A NON-REFUNDABLE BASIS, All Membership Fees Must Be Paid On Or Prior To The Initial Membership Consultation Process For Any Memberships To Be Activated, A Request For Payments To Be Made After The Initial Consultation Process Has Been Completed Will Unfortunately Be Declined, All Payments Must Be Made Prior Or On The Actual Consultation Process Stage.
5. All Members Are Accountable For Their Own Personal Membership And Cannot In Any Circumstance Generate An Account Or Membership For Any Other Person Than Their Own Membership Or For Any 3rd Party Persons. All Members Are Responsible For Their Own Activities Within Their Account Of The Events Asia Match & Meet Membership Service And Must Take Full Accountability Of Their Own Appropriate Actions.
6. The Applying Member Has To Successfully Undergo An Initial Face To Face Meeting At The Business Address Or Via An Online Consultation Meeting, And Also The Member Can Be Visited At Their Home Address, All Members Will Have To Complete And Sign The Members Application Forms, Including To Provide An Up To Date Driving Licence With A Valid Up To Date Passport, Or Utility Bill / Letter Indicating Proof Of Residency, Along With Their Selected Package Membership Fees Which Are NON-REFUNDABLE, 4x Updated Recent Photographs Of All Applicants Are Very Important Which Are Used For Bio Data And The Members Lounge Profiles, Which Can Also Be Sent Electronically, This Will Determine And Verify Members Eligibility For A 12 Month Membership Period. We Will Endeavour To Do What We Can To Vet Everyone To A Basic Level That Signs Up To The Service.
7. On Special Circumstances And For Any Reason The Applying Member Can Not Travel To Events Asia Match & Meet Offices, Events Asia Match And Meet Can Also Arrange A Video Conference Call Where All Requested Application Details Can Be Completed Electronically By A Team Member Of Staff, And Identification Can Be Transferred Via Email Or Web Based Applications With The Request That Payments Must Be PAID IN FULL Prior To The Application Process, A Team Member Can Also Happily Arrange To Travel To The Applicants Location On The Basis That ALL Travelling Costs Including Accommodation (If Required) Are Paid In Full Prior To The Meeting.
8. Events Asia Match And Meet Service Has A 3 Strike Policy For All MEMBERS That Are Applying For A New Membership, Who Has Made An Appointment To Join The Membership Services, Without Any Form Of Due Notice And Does Not Show To Their First Initial Appointment, A Secondary Appointment Will Be Offered, And Again For Any Reason Does Not Attend Their Secondary Appointment Given Without Any Notice, A Third Appointment Will Be The Final Appointment Given Before Declining Any Future Services Offered And Any Future Appointments, Events Asia Will Strongly Decline Any Services Offered After This Point.
9. On Month 11 Of All Membership Subscriptions A Reminder Notice Of Membership Renewal Will Be Sent Electronically Requesting Valid Members To Renew Their Membership For A Further 12 Month Period.
10. Once Completed An Initial Membership Consultation, Your Account Of Membership Will Be Activated Immediately Although Your On-Line Profile TO MEMBERS LOUNGE Can Take Slightly Longer To Be Activated, A Letter Of Confirmation Will Be Sent Out Via An Email To Members Confirming Their Successful Activated Membership And Including Their Selected Package And List Of Entailed Services.
11. All Members Are Subjected To Always Adhere And Abide To A High Level Of Respect And Compliance Towards All Other Members, And Staff Within The Events Asia Match & Meet Environment At Any Point And At Any Time. This Includes Any Form Of Verbal Abuse, Verbal Aggression Or Behaviour, Assaulting, Bullying, Discriminating, Intimidating And Racial Discrimination, Harassment Of Any Kind. Events Asia Match & Meet Does Not Take Any Responsibility For The Safeguarding & Outcome Of Any Member You Will Be Meeting And It Is Your Responsibility To Notify Family & Friends Prior To Any Initial Meet, And This Includes Any Background Criminal Checks. The Matching Process Can Take Up To A Period Of Time, And We Do NOT GUARANTEE Any Matches Or Any Number Of Any Matches, Or Any Specific Time Frame Required For Any “PERFECT MATCH” And Highly Respect Your Patience In Such Matters, As Personalities And Circumstances Of Each Members Criteria’s Are Taken In To Consideration For Any Matches To Be Made, Events Asia Match & Meet Will Do Their Very Best To Provide You With Your Ideal Match, All Dependant On Our Current Database, Match And Meet Service Does Work Tirelessly And Seeks Every Avenue To Maximise Your Chances For Any Potential Matching And Meeting.
