## Annex 2 – Report of the President

Dear Delegates and advisors, Ladies and gentlemen,

This report is rather short due to the fact that we had our last GA in September 2021 and gives you a glimpse about the work in the board. However, together with the report of the General Secretary, the Treasurer and the Commissions you will have comprehensive information about the work within the FIFe board during 2021. The co-operation with the commissions has been positive, several questions have been dealt with and the commissions have given a lot of support and recommendations to the board for the benefit of the Members.

Correspondence to and from the FIFe board has increased tremendously during the last years – and not only routine matters but sometimes difficult questions and decisions that are really time consuming. Because of the worldwide pandemic, during the last two years, there are still some exceptions valid throughout this year, 2022. Since February we have also had a lot of questions and discussions about the horrible situation in Ukraine and, of course, these matters also involve other FIFe Members and I would like to express our gratitude to all Members supporting Ukraine in different ways.

Again, there were questions about different regulations from Ministries of Agriculture or Governments in some countries, questions referring to some of our cat breeds, often about banning breeds. Some of our Members are working closely with their Governments, presenting the FIFe rules, health regulations and standards to show that FIFe is well aware of existing problems. The FIFe board and Commissions are working to improve standards and the health of our breeds; we have to guard FIFe and our cat breeds, the only way to do this is to cooperate with Governments and Ministries.

The registration statistics from our Members, shows again that we are the largest cat federation in the world and it can also give us some advantages when it comes to cooperation with governments to show that we have a large and healthy cat population in FIFe, some countries even ask for a broad gene pool or breeding of pure bred cats could be questioned.

The FIFe World Show was organised by the FIFe member Associazione Nazionale Felina Italiana, ANFI in Vicenza, Italy. It had an impressive amount of entries, in spite of the situation at hand with COVID and a lot of restrictive regulations around the world. The entire FIFe board was present there, which was decided a long time ago and we were all able to participate. **It was an excellent, well-organised event and a success** for FIFe as an International Federation and I would like to express my sincere gratitude for the hard work done by our Italian Member and their show team.

Due to the COVID situation the World Cat Congress have had no meetings in 2020, 2021 and 2022 but a meeting is planned in June 2023, in Tasmania, Australia, organised by ACF.

I would like to thank the FIFe Members for all support that I feel the board and I have had during the last year and also thank my fellow board members, Eric, Leo, Veikko, Karl and Charles.

## Annex 3 – Report of the General Secretary

Dear Delegates and advisors, ladies and gentlemen,

Obviously, the figures and background information, which I will share with you are not from the past year but from the 4<sup>th</sup> of October 2021 until this GA in Plzeň. As always, this overview is not comprehensive but gives you an idea of most of the daily work done at the FIFe secretariat.

The Minutes of the 2021 GA in English, German and French were sent to you on 4<sup>th</sup> November 2021, only 5 weeks after the GA 2021, thanks to the excellent work done by the Vice-Secretary and the 3 supervisors, Bette Lind for the English, Liz Parry for the French and Herbert Steinhauser for the German version. Thank you again for your excellent cooperation!

The standard items that the Secretariat dealt with in the past period were the following:

## Members' matters

### 1. Dispensations to the number of cats at shows (per day) were granted to 15 Members:

This gives a total of **57** exceptions (counted per show day) to the Show Rules. In all cases these were requests to consider shows as "International" with less than 150 cats entered in the catalogue for shows in Europe. In total FIFe had **250** show days so considering that the COVID restrictions were still in place in many places, the number of exceptions is very reasonable.

### 2. Permissions given to FIFe Members to invite non-FIFe judges at their shows

The Board granted **6** Members, permissions to invite **8** non-FIFe judges to officiate at **16** FIFe shows (counted per show day):

- 1 permission for 1 LOOF judge in SVERAK (SE) – 2 days
- 1 permission for 1 GCCF judge in FB (GB) – 1 day
- 2 permissions for 2 CFA judges in SK (FI) and FFM (MX) – 4 days
- 5 permissions for 4 TICA judges in FFB (BR), ČSCH (CZ) and FB (GB) – 9 days

This is a small decrease compared with the previous period; June 2019 until September 2021.

### Student Judges matter

From October 2021 until last week, we dealt with **3** requests from **3** Members to check the requirements set to prospective FIFe student judges for which the JSC set exams. We dealt with:

- 1 request for a preliminary exam in category 1 – FPL (PL)
- 2 requests for preliminary exams in category 2 – ÖVEK (AT and ANFI (IT)

Two candidates passed the exam and were listed on the FIFe website; one will sit the exam in September.

Since the last GA, **5** FIFe Members informed us that **5** of their Judges and **2** of their student judges wished to be listed as a student judge in 1 or 2 additional category/ies:

3 for category 2, 2 for category 4 and 2 for categories 1 and 2

I refer you to the student judges list on the website to see all detailed information.

### Judges Matter

At this moment, we have a grand total of **218** judges; 8 NE, 16 dormant and 2 probational judges included.

The database driven judges list on the website makes it quite easy for to see how many judges we have in which categories. Two of our judge colleagues died last year, Lili Anciau and Cris Simeonov and a total of **4** judges resigned. Since the 2021 GA, a total of **4** permissions to sit judges' exams were granted:

1x cat 1 (in E), 1x cat 4 (in E) and 2 in BG D (1 E, 1 G). So, **3** exams were done in English and **1** in German. All candidates passed their exams and were appointed as International Judges.

A total of **11** judges requested **12** times permission, with reference to art. 3.7 of the Judges Rules to judge at non-FIFe shows. They officiated at the following non-FIFe show-weekends:

1x at CFA show (FI)                      1x at CCCA show (AU)                      2x at GCCF show (GB)  
 4x at TICA show (AR, FR, NL)      4x at IDP shows (CN, IT)

In **75%** of the cases there was a national FIFe Member in the country where the FIFe judge was invited to officiate at a non-FIFe show, who granted permission.

As you know, no judge needed to send the engagement (activity) form in 2020 and 2021. However, for 2022 this is compulsory again. Until today, 6 judges have sent this form and I ask all judges to send this form to me as soon as they have judged at least 3 times per category.

I hope this summary was of interest to you; the other, very varied work, which was done, you can read about in the Board Minutes. I want to thank our Members, their secretaries and contact persons for their cooperation. I also want to thank all commission members and the cattery-name, show-list and breed-council administrators for their excellent work and amicable and effective cooperation.

As always it has been a pleasure to work with my Board colleagues, Annette, Charles, Karl, Leo and Veikko and I thank them for their support, input and help.

As always, thank you Pepa for all support and help and the fact that you are always there.

I truly hope that we will have a constructive GA for the good of all of us, our breeders and exhibitors and mainly our cats.

## Annex 4 – Report of the Treasurer

Dear Delegates, Members, ladies and gentlemen.

Here is a brief summary of the 2021 financial report.

The year 2021 was a very strange year for the finances of the FIFe. Due to COVID-19, the income for the international shows was 70,000 euros less than in the budget. The income for Cattery names was 30,000 euros higher than in the budget

Also, a lot of payments made in 2020 could be used in 2021, the largest amounts came from the hotel in Riga and the payment, which had already been made for the translators. In total I was able to book 24,787 euros as a refund. The sale of rosettes was also lower than budgeted (-4,200 euros)

On the expense side there were also a number of advantages, the prices of the hotel in Riga were so low due to COVID that only 31,000 euros of the budget was used, so 24,000 euros lower than budgeted. Because the board and commissions hardly had any meetings, a total of more than 20,000 euros less was spent there. There has also been no WCC meeting, so another 6,000 euros less.

The total profit was almost 27,000 euros, of which I have booked 15,000 euros into the reserve, so that a total of 26,000 euros is now under reserve.

The reason for this high reservation is that I expect that the income in 2022 for the International shows will again be considerably lower than the 106,000 euros budgeted for 2022, so I have adjusted the budget for 2023 in consultation with the controllers. You will find the adjusted budget here.

I also expect the costs for GA and Commissions to be quite higher in 2023. In addition, there are plans to modernize the website.

All financial documents for 2021 were sent to the 2 controllers for verification in February.

This time we were able to make an appointment to meet in Luxembourg, it was only at the beginning of May, because it was very difficult to find a date. We have already made an appointment for next year in April.

I must say that the meeting in Luxembourg was very expensive.

Hopefully, this GA does not make decisions that lead to much more costs.

All fees now remain the same, but I doubt whether that will still be the case in the future.

I want to thank everyone for the contributions for the past difficult year.

In accordance with the FIFe Rules art. 7, we have duly carried out our audit of the books of account. We believe that, based on our audit, we have obtained a comprehensive picture of the transactions of the financial year 2021.

In the following, we inform you about our findings:

The records were mailed to us by the Treasurer at the beginning of the year so that we could review them at our convenience at home. On a meeting on 10 May 2022 in Luxembourg, we were able to ask the treasurer various questions, which he was able to answer to our full satisfaction. On this occasion, we also inspected many receipts and documents and checked their correctness and completeness. Thanks to the very good filing system of Mr. van de Haterd, he was able to present all the requested documents.

We propose to the General Assembly to accept the annual accounts 2021 with a profit of EUR 11'825 and a balance sheet total of EUR 209'529 and thank the treasurer for the work done.

We also discussed the presentation of the budget 2023 and recommended some adjustments, which were implemented by Mr. van de Haterd.

The new, adjusted budget is available for you or has already been distributed.

## Annex 6 – Report of the Breeding & Registration Commission

The Breeding & Registration Commission (BRC) consists of Cecilia Wennergren (SE), Maria Myrland (NO), who is the Chairman, (both elected 2019) and Sarah Johnson (GB), who is the Secretary (elected 2021).

Since our last report, we held no physical meetings, all matters having been dealt with via e-mail and other electronic means.

We have dealt with requests from the Board for recommendations regarding new colours, problems understanding the BRR in connection with the registration of cats, etc. The commission have dealt with these cases since last GA:

- NRR on how to register silver kittens from non-silver parents
- BC for BSH/BLH on EMS 11 on silver and pointed cats
- ICA on how to register silver and/or charcoal in Bengals
- MCO BC on how to deal with MCO with polydactyl cats in the pedigree with a separate breed code
- BC for BSH/BLH in how to deal with x-colours and why not all possible colours are OK in BSH/BLH
- LFA on how to register kittens with Scottish Straight in their pedigree
- FFH on how to register MCO kittens after a blue-eyed sire
- SVERAK on sister breed status of JBS/JBL non and RUS/NEB non
- FD on MCO with polydactyl cats in their pedigree
- FD about register eye colour or not on bicolour MCO
- NRR if a national rule limiting queens to no more than 2 litters in 12 months is within the Rules.

In addition, we have worked extensively with the Breed Councils for Bombay (BOM non) and Lykoi (LYO non), both of whom will apply for Preliminary Recognition this year.

We also present statistics for the second time. Following this report as a separate document are the last three years of statistics, 2019, 2020 and 2021 for comparison purposes.

I would like to thank the Board for their cooperation and support, and especially Charles Spijker, for helping with translations, formulating proposals, etc.

## Annex 8 – Report of the Health & Welfare Commission

Members: Mrs. Jurgita Gustaitiene (Chairperson), Mr. Vladimir Isakov (secretary), Mrs. Sara Moroni

This year the HWC had no physical meetings, the members have communicated by e-mail. Our commission have dealt with the following issues:

- We received health data from Bombay BC and compiled a report for the proposal for preliminary recognition.
- We received data from Lykoi BC and compiled a report on it for the proposal for preliminary recognition.

- We discussed on guidance “Supplementary guidance for cat breeders on the socialisation of kittens” with conjunction with Responsible Cat Breeding Guidelines (endorsed by the EU platform on Animal Welfare 3 November 2020 – DOC/2020/11982 Rev1). These documents FBE (BE) forwarded from a workgroup of the Eurogroup for animals to the FIFe Board. This guidance applies to all those keeping cats for breeding and can be used as “best practice text” for all EU governments, wanting to work out new legislation regarding health and welfare for cats. HWC have been asked to review this and give back our feedback. HWC find this guidance important for our cat breeders and put down some comments.
- HWC give answer to question about national rule for queens. FIFe member has adopted a National supplement to BRR § 3.3, Queens, that states “a maximum of 2 litters in 12 months”, in addition to the FIFe rule of 3 litters in 24 months for a queen. HWC has widely discussed the topic and agrees that a queen can have two litters in one year, as long as the overall framework of three litters in two years is respected, as BRR. In the opinion of our commission it makes sense to allow two "close" litters, if the total of three litters is guaranteed. Maybe the queen has a lot of heat or has a pyometra (or other health issues) so needs to be mated again after treatment, so it can be an option with today's opportunity to control heat, follow pregnancies and to achieve better cat health.
- We received for discussion proposal from secretary FIFe breed council of Burmese according BUR outcross, GM2, Novice. HWC give suggestion for this proposal. We also would support proposed questionnaire for collecting more information about the GM2 from all FIFe breeders from different countries.
- HWC received from FIFe secretariat question about mandatory tests for BUR, KOR, NFO, BAL/SIA, OSH/OLH, PEB . We have reviewed the submitted document " Report and statistics regarding the mandatory tests for BUR, KOR, NFO and oriental breeds in SVERAK". HWC are in favour of removal the mandatory tests for BUR, KOR and NFO and replacement recommended tests. The commission considers it necessary to leave the mandatory PRA testing for BAL/SIA, OSH/OLH, PEB

I would like to thank my two commission colleagues for their work and cooperation in the past year. Our commission has worked in a new composition, but I want to express my joy that all members are experienced breeders, judges and therefore naturally understand that in felinology the health and well-being of cats play a key role.

Finally, I would like to invite all FIFe members to submit more proposals regarding the health and welfare of cats. FIFe is the largest feline organization and should therefore be a leader on the world stage with a strong opinion and vision. in favour of supporting every proposal to better our cats' health.

During the past months the work in the Show Commission was performed timely, with pleasure and enthusiasm, based on an excellent teamwork and contact with the Board.

During this period the Show Commission had one physical meeting, in connection with GA in Riga and one web-meeting in March 2022. The minutes of the meetings were sent to the General Secretary. During this period also, whenever necessary, emails were exchanged to respond and follow up on any type of question.

As in the years before the Vice-secretary assisted the General Secretary in producing the 2022 edition of the Show Rules in English, German and French languages. The Show Commission after checking the final versions, thanks him for the work and collaboration.

The situation with covid pandemic slowed down a bit in the autumn 2021 and in most countries shows were organized, including the World Show Italy 2021 and some Winners Shows. But after just few months the situation worsened again and most of shows were cancelled again during the winter time.

The Show Commission contacted the Members regarding the Show Survey. Unfortunately, after the first send out of the Show Survey, only a quarter of the members responded. In April, we sent it once again, in the hope for greater response and the new elected SC will be able to work on the results and come with new proposals upon suggestions received.

This year in short period from the last GA, the Show Commission prepared three proposals regarding the Show Rules to the GA, which draw our attention and we felt matters need to be handled.

Finally, we would like to thank all members of the Show Commission for the excellent teamwork during our mandate period.

## Annex 11 – Report of the Breed Council Administrator

The year 2021 was a difficult year for the Breed Councils (BC). Difficult in many ways like breeding and renewals. Moreover, the CHA BC still has no BC Secretary.

In 2021 Catfancy still was not active in its full capacity. Breeders faced problems like re-registering their kittens after a crossbreeding, due to limited shows. Also, the Bulgarian member was disbanded. This left the respective BC members with no rights to remain in the BCs. With sadness I had to remove them, even though they were a long standing and respective member in their BC and always paid their fee in time. BC administration is busiest in the months of December up to February. This year the process was again long and slow. Not because BC members did not pay in time, rather the response of the Members themselves was late or even absent. I would kindly like to remember Members that the BC renewals must be finished by 31st of January of the upcoming year.

In March 2021 we had 30 BCs, consisting of 28 members and 302 individual delegates. At the time of writing this report we have 30 BCs with 280 individual members from 28 Members.

Seeing these numbers, I would like to urge all our Members to encourage their breeders to join the BCs so that they may have an opportunity to share their knowledge and expertise and have their voice heard where it matters most. Last but not least I would like to ask the FIFe Members to be of great assistance when the renewals have to be extended. This way you will really make a difference.
