1.3. I.1. Reminder of the objectives of the mission

Following the terms of reference, the audit of the accounts of the Fund for the Congolese women "FFC" in acronym for the period from 1 January to 31 December 2016, close to 31 December 2016, aims to achieve a number of objectives, namely:

- 1. Review of the financial propriety, by the control and the assessment of the accuracy, completeness and sincerity of the various accounting transactions relating to the operation of the FFC, either in full or by survey according to the necessities and according to the assessment of the risks before in the course of the audit;
- **2. Review of compliance with the goals of the projects,** by the monitoring and evaluation of the transactions (revenue and expenditure);
- **3. Review of the conduct of the affairs of economical and efficient manner** through the monitoring and evaluation:
 - a) Of the minimization of the costs of the resources used for the activities, while ensuring an appropriate quality,
 - b) The comparison of expenditure compared to budget and the explanation of discrepancies.
- 4. Review of the opportunity, the relevance and the operation of the system of internal control, speaks monitoring and evaluation:
- a) The internal organization (structures, functions, tasks, competence, responsibilities, methods, procedures, etc.);
- b) The existence, the respect and the application of laws, regulations, guidelines;
- c) The protection of resources and assets;

- 5. Check the level of implementation of the recommendations made in the previous audit report accounting year 2016 be the first year of this three-year program, as well as their impacts on the quality of the financial management of the FFC;
- **6. Recommendations** on the aspects found as being still weak or not in accordance with the generally accepted accounting principles.

This is in order to allow us to express a free opinion, independent and professional on the accounts of the Fund for the Congolese women "FFC" in acronym at the end of the period close to 31 December 2016.

I.2. Audit Methodology

a) Meeting for start-up

Our work have begun by a meeting of startup that took place in the presence of the staff of the Direction of the FFC .

b) Receiving of Documents

After the meeting of startup, the accounting documents have been put at our disposal. These documents were :

- Legal documents authorizing the operation and legality in tax matters and professional dues,
- The budget of the period to be audited;
- The supporting documents for the revenue and expenditure;
- Booklets of cash flow;
- Notices of bank credits relating to the various transfers made by the various financial partners;
- Surveys of bank accounts;
- The heels of checks issued during the period;
- The files of the staff of FFC;
- The tax record;
- The financial report of the period to be audited;
- The previous audit reports.

c) Mission Process

During our work on the field which lasted six days, we proceeded to:

- The exploitation and verification of legal documents authorization the operation
- The analysis of the payments of taxs, taxs and other contributions are legally recognized.
- The audit of all supporting documents for expenditures and revenues available to us;
- The analysis of the management of human resources,
- The audit of the chain of communication and interconnection between the various organs of the structure;
- The procedure for the delegation of power and the chain of command
- The audit of the financial statements and other accounting traceability;
- The review of the control system.

d) Restitution meeting

The Meeting of restitution of the conclusions of our work took place in the presence of officials of the Fund for the Congolese women "FFC" in acronym.
