

Terms and conditions for Freedom 4 Girls fundraisers:

To fundraise for Freedom 4 Girls by organising your own events, activities and challenges, you must agree to our important terms and conditions which are stated below.

These terms constitute the fundraising agreement between Freedom 4 Girls and you, as a participant.

Taking part in fundraising event/ activity:

1. I confirm that I am aged 18 or over. (Participants can be under 18, as long as the organiser is over 18).
2. I understand that the event/ activity is in aid of the Freedom 4 Girls.
3. I understand that the event/ activity is my responsibility (including but not limited to all costs and liability) and Freedom 4 Girls holds no responsibility or liability whatsoever for the event. The event/ activity will not be covered by the Freedom 4 Girls insurance policies. If necessary, I will arrange my own insurance if needed to cover the events/ activities.
4. I understand that it is my responsibility to ensure all participants of any event or activity are medically fit. Every participant will participate in the events/ activities at their own risk. Freedom 4 Girls shall not be responsible or liable for injury or illness resulting from my participation and I need to arrange my own insurance
5. I am responsible for the health and safety of all involved in my event, activity or challenge.
6. I am responsible for ensuring food hygiene and ensuring that I have the relevant licenses e.g. if selling alcohol at the event.

Fundraising

1. I will use my best to raise money for Freedom 4 Girls, in connection with my participation in the event/ activity.
2. I understand and will make clear to those who support my fundraising that any money is raised to support Freedom 4 Girls. Donations are not refundable, even if the event does not take place.
3. All donations made will be forwarded to Freedom 4 Girls by cash, cheque or via online providers no later than 4 weeks after the event.
4. I will commit to transparency by providing regular updates on the fundraising progress, how funds are being used, and any administrative costs deducted from donations.

5. I will only use lawful means to fundraise for Freedom 4 Girls and will not bring the charity's names into disrepute. I will observe the following fundraising rules and I will comply with any further rules and requirements about fundraising of which Freedom 4 girls may notify me:

- I will not use the Freedom 4 Girls logo without first obtaining permission from the Charity and will allow Freedom 4 Girls to approve any materials produced whether printed or online.
- I will tell event attendees that I am raising money “in aid of” Freedom 4 Girls.
- I will not incur nor am I authorised to incur any cost, claim, loss or liability on behalf of Freedom 4 Girls.

6. I will Specify the start and end dates of the fundraising campaign to inform donors about the timeline within which they can contribute. This will be shared with Freedom 4 Girls via email using info@freedom4girls.co.uk

I confirm I have read, understood, and agree to all the terms and conditions set out above, and understand Freedom 4 Girls may terminate our relationship if I am in breach of any of the terms and conditions.
