ECFD draws mixed conclusions on the compromise reached by the EU Council of Environment Ministers on the CO₂-emissions performance standards of cars

Brussels, 30 June 2022 – European Confederation of fuel Distributors (ECFD – European Association of Small and Medium-sized Oil Companies) welcomes the fact that the EU Environment Ministers have underlined the central importance of renewable fuels for climate protection and the preservation of affordable mobility in their decision today. However, concrete proposals for a crediting system that would promote their ramp-up were not taken up.

"The EU Council of Environment Ministers has declared its support for e-fuels and thus taken a stand against a blanket ban on combustion engines. This is the positive message of the day," said ECFD Secretary General Matthias Plötzke in a first assessment. The Council has instructed the EU Commission to draw up a proposal on how new passenger cars and light commercial vehicles with combustion engines powered by CO₂-neutral fuels can be registered even after 2035. "The route via the EU Commission could delay the urgently needed production ramp-up of e-fuels. We expect now a quick and substantial proposal by the Commission." continues Mr Ploetzke. In its decision, the Council emphasised the role of a fair and economically viable transformation to a climate-neutral future; the connection would also apply to participation in individual mobility for all EU citizens. "A possible proposal must be measured against this. Neither the Parliament nor the Commission should accept possible sham solutions from the EU Commission," emphasises Matthias Plötzke from ECFD.

"In essence, a ready-to-use proposal has already been discussed in Parliament and Council, it should be used as a basis", Matthias Plötzke demands. He points out that the Transport Committee in the European Parliament has proposed the integration of a CO_2 crediting system into the CO_2 fleet regulation. It is envisaged that for the use of renewable fuels in the market.

ECFD understands the Council decision to further work substantially and contribute to a constructive dialogue with EU decision maker an Commission, Parliament and Council.
