Patent Box

What Is Patent Box?

The Patent Box incentive was introduced over four years (2013–2017) in phases to encourage UK businesses to commercialise intellectual property within the UK. The relief allows eligible companies to apply a lower rate of Corporation Tax (10%) to profits generated from its patented inventions.

Who Can Benefit From Patent Box?

Your company will need to be profitable from exploiting patented invention(s)

- The company must be liable to Corporation Tax.
- The company has undertaken qualifying development on the patented invention(s).
- The company must own or have the exclusive licence of the patented invention(s).
- The company has elected for Patent Box (via computations accompanying a CT Return or separately in writing), within 2 years of the accounting period in which the relevant profit and income arose.

What Makes A Patent Eligible For Patent Box? Your company must own or exclusively licence patents granted by

- The UK Intellectual Property Office.
- The European Patent Office.
- These countries in the European Economic Area: Austria, Bulgaria, Czech Republic, Denmark, Estonia, Finland, Germany, Hungary, Poland, Portugal, Romania, Slovakia, Sweden.
- Following the announcement in the 2021 Spring Budget, from 1st April 2023 the CT rate will increase up to 25% for companies with profits over £250,000, the Patent Box will become more important to UK businesses developing and exploiting patented inventions.

Land Remediation Relief allows companies to claim tax relief of 150% on their Corporation Tax, for expenditure associated with the clean up of contaminated areas such as buildings and land.

Investors, developers, and commercial property owners are able to claim Land Remediation Tax Relief on expenditure that has been spent on the process of decontaminating land or buildings. This acquisition should be made from a third party.

Capital Allowances

Over 50% of commercial property owners are vet to make a Capital Allowances claim. Are you one of them?

The Capital Allowance benefit is aimed at people that fit into any of the wide range of expenditures. Typical items qualifying for Capital Allowances are cars and vans. computers, machinery, furniture, and non-residential buildings. Owners of UK commercial property. multi-unit residential properties, owners of Furnished Holiday Lets, improving or renovating properties, and selling or purchasing a property.




