

## SHARE TRANSFER (DONATION) AGREEMENT

This 3<sup>rd</sup> day of August 2016, between the undersigned:

1. **Maria Eva Virginia Grabowski** holder of Greek passport with number [REDACTED], resident of Kifissia, Greece at [REDACTED] (hereinafter referred to as the "Donor")

2. **Georgios Papazisis** holder of Greek passport with number [REDACTED], resident of Psychiko, Greece, at [REDACTED] (hereinafter referred to as the "Donee")

(hereinafter the Donor and the Donee together called the "Parties"),

**IT IS HEREBY mutually irrevocably and unconditionally agreed as follows:**

### PREAMBLE:

**WHEREAS** the Donor is the sole and indisputable proprietor, owner and possessor of 950 shares (hereinafter "the Shares") of "SCI PERSONAL VENTURES" a company legally incorporated and organised, validly existing and legally operating under the laws of France and in good standing, with registered address in 1 Rue de Beaune, 75007 Paris, with RCS Paris 490 793 288 (hereinafter "the Company")

**WHEREAS** the Donor wishes to donate, transfer and deliver to the Donee the Shares and the Donee has accepted the donation and to take delivery of the Shares.

1. The Seller hereby donates, transfers, endorses and delivers as of today the ownership and possession of the Shares to the Donee, with all their rights of any nature attached thereto, including the right to dividend and free of any encumbrances whatsoever. Therefore, as of today, the Donee becomes the legal sole owner, user and possessor of the Shares. Therefore, by these presents, which stand also as a Protocol of Delivery and Acceptance of the Shares, the Donee states that the Donor has delivered to him the Share Certificate(s) for the Shares.

2. The Parties hereby authorise the BoD of the Company to make all necessary entries in books of the Company.

2. Any cost related to this transaction shall be equally born between the Donor and the Donee.

8. This agreement is governed by the Laws of France and is submitted to the jurisdiction of the Courts of Paris, France.
