4. Kindly noted that, any halal products that intended to be exported to Malaysia must comply with all the regulations besides been halal certified by the Foreign Halal Certification Body.

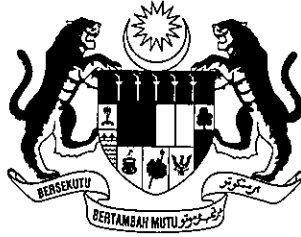

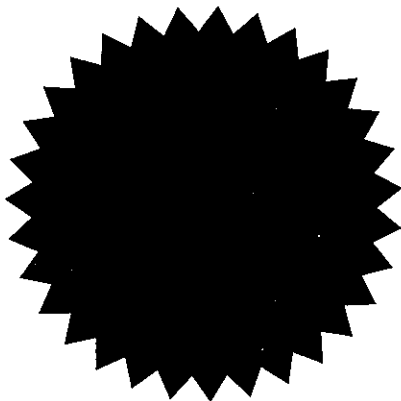
