

# **GUIDE TO SORTING AT SOURCE**

FOR PRIVATE HOUSES UNSORTED WASTE ONLY

PLEASE NOTE THAT BIG BAGS ARE COLLECTED USING A LIFTING VEHICLE, AND MUST BE PLACED IN A LOCATION WITH PLENTY OF FREE HEIGHT AND NO MORE THAN 5 M FROM THE PLACE WHERE THE VEHICLE CAN STOP. COLLECTION IS NOT INCLUDED IN THE PURCHASE OF BIG BAGS; IT IS INVOICED SEPARATELY.

### IT'S FORBIDEN TO PLACE HAZARDOUS WASTE. ELECTRONICS OR HOUSEHOLD WASTE IN THE BAGS

#### FLAMMABLE:

Frigolite, wood shavings, plastic ties, paper bags, fabric, wallpaper, plastic pipes, cellular plastic, EPS, cardboard, cork-based cardboard, laminated panels, linoleum, paper, plastic containers, binders, tape, tar paper, covering paper, damp-proofing felt, corrugated card. No PVC.

## LANDFILL, UNSORTED:

Residual material that cannot be recycled or used to generate energy – for example, concrete, tile, stone, gravel, porcelain, mineral wool, reinforced plastic, plastic mats (PVC), PVC pipes (drain/electrical), demolished plaster – contaminated, hoses and insulation.

#### **WASTE WOOD:**

For example: Timber formwork (without concrete lumps), glulam, joinery, fibreboard, Masonite, wood doors, disposable pallets, pallet collars, planks and plywood. Treated (painted or varnished, as well as wood with nails and fittings) or untreated wood (without adhesive/paint residue). No pressure-impregnated wood, No insulation material, No wood contaminated with plaster or concrete spillage, for example.

### **SCRAP & METAL:**

All kinds of scrap iron and metal, such as cables, cross beam ties, down pipes, ventilation ducts, metal warehouse shelving, etc. Rebar, drill steel, cast iron pipes, copper pipes, metal conta iners, packing ties, sheet metal, strip cross beam ties, PVC-coated sheet metal, steel pipes, band saw blades, roofing sheet, ventilation sheet.

## INERT DEMOLITION WASTE/FILLER WASTE (NOT IN 2 CUBIC METRE BAGS):

Non-reinforced/pure concrete (max. 50 x 50 cm), tile, sheet glass, floor tile, light concrete, LECA, brick, concrete or clay roofing tile, stone, marble sheet, dry excavated material, asphalt, demolished concrete- no cut rebar, mortar, gravel, soil, plaster.

### **UNSORTED WASTE:**

Unsorted, mixed waste - Combination of the waste fractions listed above.
