The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

PART A - PECUNIARY INTERESTS

NB - In accordance with Section 34 of the Localism Act 2011, a person commits an offence if, without reasonable excuse, they fail to register their pecuniary interests within 28 days of taking office or fail to update their register within 28 days of a change to their pecuniary interests.

(b) Any payment or provision of any other financial benefit (other than from the authority) made or provided within the relevant period in respect of any expenses incurred by me in carrying out duties as a Member, or towards my election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

(c) Any contract which is made between any of the above-named persons (or a body in which any of the above-named persons have a beneficial interest*) and the authority under which goods or services are to be provided or works are to be executed, and which has not been fully discharged.

* Body in which any of the above named persons has a beneficial interest means a firm in which any of the above named persons is a partner or a body corporate of which any of the above named persons is a director, or in the securities of which any of the above named persons has a beneficial interest.
