140 projects have been implemented for the total EU funding of 99 775 717 EUR

EU funds of 92 402 736 EUR were paid to the beneficiaries

Enhanced energy efficiency in
741 apartment buildings and 54
social homes

149.8 km of heating networks
and 286.7 MW of heat
generation capacity were
reconstructed


35.55 MW of CHP plants using

decreased from 20% to 14.95%



4.PA Energy efficiency – risk to loose ERDF performance reserve – 17,5 M.EUR. However, prognosis based on the data of financial beneficiaries indicates, that ERDF financial indicator can be achieved up to 106% of its target.



Cohesion policy has a significant impact on convergence

- LV has closed the gap in GDP per head by 21 % to EU average (46%-67%, 2004-2017)
- Despite overall convergence disparities remain at national level (Riga 107 %, Latgale 32 % of EU average)
- Since 2004 Cohesion policy contributed additional 7,3 % to Latvia's GDP*
- Cumulative impact on employment - around 20 thousand people (2,9 %, 2007-2017)*




Cohesion policy – the main priorities and structural challenges for Latvia

Productivity/ Innovation

- Productivity up by 16%; still only 68 % of EU average

Sustainable and competitive transport system

- 2nd worst road quality in EU
- 48 % of regional roads in bad condition

Sustainable use of resources (energy efficiency)

- Residential energy consumption 2nd highest in EU
- Energy - one of RIS3 priorities

Social convergence, healthy and competitive labour force

- 2nd highest patient (out of pocket) payments for healthcare in EU
- 28.5 % of people live at risk of poverty and social exclusion


Qualitative and effective education system

- 40% on students in vocational education (behind 50% target)
- 43 % of enterprises are affected by labour shortages (Citadele index)

Depopulation and balanced territorial development

- Low GDP convergence outside the capital region (32%-49% of EU average)
- Population loss in external border regions reduced by 24 % (15% overall)
