1.3 ADDRESS OF DIRECTOR OF TET RALLY LATVIA

Welcome to Latvia! Welcome to 37th country to ever host a round of the FIA World Rally Championship. And welcome to the 2024 *Tet Rally Latvia*, our inaugural WRC event and Round 8 of the 2024 WRC Calendar.

A historic summer is approaching, providing new memories and experiences for the vast family of WRC. With the high-speed gravelsurfaced special stages on plate, some courage will be required from the competitors, to fight for the coveted first victory, at the same time, producing some unforgettable moments for the rest of us watching. Being this our debut event, we looked for the best way to introduce the FIA World Rally Championship to as much people in Latvia as possible. And so, we opted for the most widespread rally we have ever organised – making way to meet the spectators, and giving way to challenge the most picturesque special stages around Latvia.



The rally week is set to start with the official test sessions organised on Saturday, July 13, and Sunday, July 14, in Talsi region. Be informed, there will also be options for private test sessions upon request. Rally HQ will be situated in our beloved rally city Liepāja, on the shore of the Baltic Sea. With equally picturesque location for our service park – just a shy walk away from the sea side.

Reconnaissance is scheduled to start on Monday, and cover special stages in our capital city Rīga and Tukums region. Tuesday should give the first glimpse of special stages in regions of Talsi, Kuldīga and Dienvidkurzeme. The reconnaissance will conclude on Wednesday afternoon, giving competitors the required time to get acquainted with the remaining special stages in Dienvidkurzeme region.

The final phase of the *Tet Rally Latvia* will commence on Thursday, July 18, with early morning run shakedown. After a short break at the service park, the competitors will then travel to Riga for the opening ceremony and the very first super special stage, with an overnight parc fermé in our capital city to conclude the day. The action will resume on Friday, July 19, with special stages around regions of Tukums and Talsi. With no midday service, crews will have an extra set of challenges to deal with, but have no doubt, every second will count anyways. The crews shall return to rally city Liepāja on Friday evening for evening visit to service park. Saturday, July 20, is set have equally fast-paced special stages around regions of Kuldīga, Dienvidkurzeme, and rally city Liepāja to distribute the first championship points at the end of the day. Finally, Sunday, July 21, will resolve all the remaining questions, and give spectators a unique experience to wrap up the event. In total, *Tet Rally Latvia* is set to have 20 special stages and over 300km in special stages before deciding first ever winner of Latvian round of the FIA World Rally Championship.

And while we often get drawn away by the spectacle of rally crews, we must make sure the longevity of the event. The work never stops to protect the environment and establish a sustainable *Tet Rally Latvia* and thus it is our goal to acquire Two-Star rating ahead of our World Championship debut. With that in mind, we pledge everyone to set environmental objectives that are SMART: specific, measurable, achievable, relevant, and time-bound, while engaging in actions towards circularity: sharing, reusing, and recycling as much as possible.

Let us have fun, and enjoy the first edition of Tet Rally Latvia!

For the first time in the 51-years-long history of the FIA World Rally Championship a round in Latvia will be organised in July 2024, making Latvia only the 37th hosting country of such honour. Latvian round of the world championship *Tet Rally Latvia* is organised by *RA Events* – a company with more than 15 years of experience in the motorsports – always looking into each and every detail and nuance, and always pushing to achieve the highest quality of the event organised. *RA Events* is keen to learn and adjust its operations to reach the exceptional level to set the example of good practice – nationally and internationally, within motorsports industry and for other events as well.

Tet Rally Latvia environmental policy is to be reviewed once a year.



5.3.3 Electricity

16.1 MUST SEE LOCATION IN RĪGA

Riga Motor Museum, located a few kilometres from Riga city centre, and just next to *Biķernieki Track*, houses the largest and most diverse collection of antique vehicles in the Baltic states and offers a truly interactive, fun, and educating journey into the world of motors. The museum is considered as one of the most remarkable museums in Latvia. It is the largest and the most modern museum of historic vehicles not only in Latvia, but across the Baltic States, and for warmth of our gasoline-run hearts, displays a very special vehicle – the 1930s mountain-racing automobile *Auto Union V16*.

16.2 FOOD OR DRINK TO ENJOY

Riga Black Balsam, whose origin dates to at least 1752, is an iconic symbol of Rīga and Latvia. It is made from 24, mostly different herbs. With its unique and slightly bitter taste, *Riga Black Balsam* has become popular among both local and international tourists. And do not give up so easily, if you do not like the classic flavoured balsams, you should try the blackcurrant flavoured edition.

16.5 HOW IS RĪGA REMARKABLE IN THE EYES OF OTHERS

About 40% of the entire construction of the centre of Rīga is made up of Art Nouveau buildings. This is much more than any other city in the world. Albert iela is the pearl of Rīga's Art Nouveau style – these magnificent and historic buildings are located along its entire length.

16.6 SOUVENIR TO TAKE WITH YOU

Most certainly, souvenirs that depict a rooster often called the golden guards of Riga. Wooden and metal roosters have adorned the roofs of Riga houses since the end of the XIII century. The rooster of St. Peter's Church rose higher



than other tribesmen. From a height of 123 meters, it has a clear view of what is happening both in the city centre and in its surroundings. His predecessor was placed on the spire of the tower as far back as 1491.

16.7 FACT, NOT EVERYONE MIGHT KNOW ABOUT

Before the First World War, at the most prominent restaurants of Rīga you could buy a postcard with an interior view of the establishment and send it right from your table. Then famous restaurant *Otto Schwarz* had ordered a set of six luxurious, colourful postcards printed in Paris.

17.1 MUST SEE LOCATION IN LIEPAJA

There are several locations for tourists not to be missed, and those include Liepāja's beachside and *Jūrmala Park*, *Guest House of Mrs. Hoijere*, now home of the Museum of interior design of 17th-19th century, and nonetheless, concert hall *Great Amber*.

17.2 FOOD OR DRINK TO ENJOY

Liepāja is an historic fishing village, so we recommend you to taste the freshly caught fish in local restaurants and cafes. Besides that, there are local breweries in Liepāja and an excellent winery in the Dienvidkurzeme region –



products of all of which, can and should be tasted in local restaurants and cafes.

Factory building of *Lauma Fabrics*, by its total area, ranks amongst the ten largest buildings in the world. While, St. Trinity Cathedral houses the largest mechanical (in its original state) organ in the world.

18 TUKUMS

18.1 MUST SEE LOCATION IN TUKUMS

The old town of Tukums acquired its planning already in the $14^{th} - 18^{th}$ centuries, but its visual image, so characteristic to modern Tukums, has been formed in the 19^{th} century and the beginning of the 20^{th} century. There are many old, minorly rebuilt workshops and residential buildings built in the style of a log house. It is interesting that already in a photograph from 1900s it is recorded that wooden boxes with flowers were placed near the windows. The citizens of the old town continue this tradition even in the 21^{st} century.

18.2 FOOD OR DRINK TO ENJOY

The special dish of Tukuma – meat main course "Tukuma veltnītis" that is served with cherry sauce, and can be found at bar *Smukausis* or cafeteria *Apsīte*. If you look closely, you can also fin medieval style meals in *Jaunpils Palace*. There you will also find the special drink is "Tukuma rose cocktail". Meanwhile, wine lovers are all invited to visit *Abava* winery for tasting and shopping.

18.3 LOCATION FOR #INSTASPOT

Landmark letters TUKUMS in Brīvības Square – in the heart of the city, a chance to catch the vibe of Tukums, which many are talking about and looking for. As Tukums is already known as a destination for castles and manors, *Durbe Palace* is one of the pearls of the Tukums region – one of the most luxurious classicist style palaces in Kurzeme, which managed to withstand the destruction during the Soviet era, as hospital and sanatorium were both located in the palace during that time.

18.4 LOCATION TO OVERSEE THE CITY

The city's greenery and patterned roofs can best be seen from the observation tower of the Tukuma Lutheran Church. The tower allows for remarkable sights on all four sides of the sky.

18.5 HOW IS TUKUMS REMARKABLE IN THE EYES OF OTHERS

Tukums is known as the City of Roses. During the *Rose Festival*, the largest wreath of rose flowers is made. In 2023, the pink wreath was made up of 10,143 larger and smaller rose flowers.

18.6 SOUVENIR TO TAKE WITH YOU

A rose – a real rose to plant in your garden, or a porcelain rose as a pendant, brooch, or earrings for a woman

you love or a lapel pin for a man. If you do not like jewellery, then a rose magnet next to the refrigerator will always be a wonderful reminder of your visit to Tukums.

18.7 FACT, NOT EVERYONE MIGHT KNOW ABOUT

The largest tree in Latvia and the Baltics grows in the Tukuma region – the *Kaives Senču* oak, which can be seen in Sēme parish. Its total circumference is 10.6 meters.

19 TALSI

19.1 MUST SEE LOCATIONS IN TALSI

There are many exciting places to see and get to know around Talsi! Valuable natural areas – Slīteres National Park, Talsi hillocks, Abava River Valley, and nature parks of Lake Engure.

Talsi is region with the longest coastal border – more than 90 km by the Gulf of Riga and the Baltic Sea, or as the locals say – $mazj\bar{u}r's$ (little sea) and $di\check{z}j\bar{u}r's$ (great sea). Kolkasrags is unique in its nature, where the two seas meet, forming a truly fascinating cross-wave scene, and the Libyan coast with its historic villages begins.

Building complex of cultural and historical pearl *Nurmuiža*, Valdgale mill, Dundaga castle. Sabile and Valdemārpils are proud of their historical buildings and each place has its own special small-town charm.

19.2 FOOD OR DRINK TO ENJOY

When in Talsi, be sure to reward yourself with a cheese-based treat of "Talsu ritulis" or "Devinkalnu siers"! And do not forget that Talsi has its own special dishes – Talsi cream and Talsi schnitzel. Look for them in cafes.

19.3 LOCATION FOR #INSTASPOT

Landmark object "Nine Hats" in Kēniņkalns, the barcode stairs next to the Talsi Culture Centre and the sign TALSI in Sauleskalns would make for perfect pictures to capture and share.

Anything with the local barcode of "Talsu brunči" – a stylized pattern of a




traditional women's skirts, will make the best of it.





GUIDELINES FOR THE RADIO-FREQUENCY SPECTRUM USE

DURING MAJOR SPECIAL EVENTS IN LATVIA









Every year, major sports, culture and entertainment events take place in Latvia. During such events radio-frequency spectrum is used intensively and widely in order to ensure their successful process.

Several hundred wireless devices during major events are used for the provision of communication between event organizers, for the control of special effects, the event process reflection in mass media and for other purposes.

Considering the wide application of wireless equipment, it is essential to make sure timely – before the event, about your radio equipment use conditions, in order to avoid situations, when there may occur radio communication interferences for the radio equipment operation of both - your own and other radio frequency spectrum users.



This informative material is intended for public major special event organizers and/or their representatives, who are planning the use of radio communication equipment in Latvia for the purposes to provide the process of abovementioned events.

This informative material includes important information, which applies to radio equipment check before its use.

WHAT MUST BE OBSERVED FOR THE RADIO FREQUENCY SPECTRUM USE IN LATVIA?

In accordance with the legislation of Latvia (see Clause 50 of the Law on the Electronic Communications), the radio frequency spectrum usage for radio equipment operation is permitted:

- If there is an individual radio frequency assignment, issued by Electronic Communications Office (hereinafter INDIVIDUAL LICENCE)
- or

If radio equipment operates in accordance with the licence for the shared radio frequency assignment use (hereinafter – **SHARED LICENCE**) according to the procedure stated in the Cabinet Regulations.

INDIVIDUAL LICENCE – is a licence, issued to a particular user, which gives the right to use frequency/-ies with the provided parameters. According to the legislation of Latvia, this licence is issued by Electronic Communications Office of Latvia for a particular term. It is also possible to issue short-term licence for one day.

During major events, most commonly used radio equipment, which operates based on the individual licence – portable radios for voice radio communications (working in 146 - 174 MHz and 406.2 – 470 MHz radio frequency bands), wireless microphones and in-ear monitors, video signal transmission radio links.

SHARED LICENCE – gives the right to use the radio equipment, which belongs to the radio equipment groups, provided in Annex No.3 of "National Radio Frequency Plan" (Cabinet Regulations No.1151 from October 6, 2009), and operates in particular shared radio frequency bands or channels, in compliance with technical requirements, conditions and restrictions for radio frequency spectrum use. The Shared licence for radio frequency spectrum users is not being issued individually in paper or in electronic form.

The most commonly used radio equipment, which operates based on the shared licence - PMR446 portable radios (operating in 446.0 – 446.2 MHz radio frequency band), car, alarm remotes, different WI-FI equipment (operating in 2.4 GHz and 5.2 GHz radio frequency band), Bluetooth headphones.

HOW MUCH DOES THE SHARED OR INDIVIDUAL LICENCE FOR A RADIO EQUIPMENT COST?

- There is no individual charge for the reception of a **SHARED LICENCE**.
- The charge for the reception of an **INDIVIDUAL LICENCE** depends on the type of the used radio equipment, radio equipment output power, radio channel bandwidth, etc. parameters, therefore to find out accurate costs for an individual licence please turn to the Electronic Communications Office specialists (see the contact information in the last page of the informative material).
 - Approximate costs of individual licence are EUR 3.00/per day for each radio channel.
 - Approximate costs of individual licence for *wireless microphones and in-ear monitors* are EUR 0.3/per day for each band or radio channel;
 - Approximate costs of an individual licence for *video signal transmission radio links* are EUR 1.00/per day for each band or radio channel.
- The charge for an individual licence application examination starts from EUR 35.

WHAT IS NECESSARY TO RECEIVE AN INDIVIDUAL LICENCE FOR A RADIO EQUIPMENT?

In order to receive an **INDIVIDUAL LICENCE** for a radio frequency use, event organizers and/or their representatives, who are planning the use of radio communication equipment need to apply to Electronic Communications Office of Latvia (ECO) with a request (application) in a form of paper or electronic document. In the application, need to provide:

- information about the licence demander;

- the necessary radio frequency band or the operation radio frequencies for the radio equipment;

- transmitter power, channel spacing;
- place or places scheduled for the radio equipment use;
- a scheduled duration for the radio equipment use from/to;
- the equipment type/manufacturer;
- the person responsible for the transmitting equipment use (contact phone).

ECO may request to precise the submitted information or to request any additional information, for example, a detailed description of the radio equipment operation principle.

After receiving the application, the specialists of ECO make an assessment of the customer's application as soon as possible.

If ECO are unable to assign the frequency requested by a customer, then the customer is informed about it and an alternative frequency is offered.









UNAUTHORISED USE OF RADIOFREQUENCY SPECTRUM

A use of wireless radio equipment, not complying with the requirements of regulatory enactments of Latvia, may cause harmful radio communication interferences for other radio frequency spectrum users, including the communications of safety and emergency services, the air traffic control radio communications, the voice and data communication of public mobile connections, the FM radio and TV broadcasting, etc.

An administrative penalty can be applied for the radio equipment use in Latvia without an issued individual licence (if an individual licence is necessary) or the radio equipment use, which does not conform to the conditions of the shared licence.

If the legislative requirements about the use of a radio frequency spectrum are violated, Electronic Communications Office of Latvia (ECO) has the right to demand an immediate termination of the equipment operation.

WHAT TO DO IF RADIO INTERFERENCES OCCUR?

The mutual radio interferences of the radio equipment, used and installed according to the conditions of the Shared licence, shall be considered as permitted or acceptable, and applications for their elimination shall not be examined.

In case if you have received an individual licence, and after the testing of your radio equipment there confirms that radio communication interference occurs, you must contact ECO specialists, who will provide a support to eliminate the radio communication interferences.

ENFORCEMENT ACTIVITIES OF ELECTRONIC COMMUNICATIONS OFFICE OF LATVIA DURING AN EVENT

In order to provide fast investigation of radio interference case or an unauthorised radio equipment usage case during major events, the ECO specialists, if necessary perform the radio monitoring on site. In such cases the event organizers provide the ECO specialists a possibility to be at the venue of the event and access to all the areas of the venue of the event, where the radio equipment is scheduled to be used.

WHAT NEED TO BE DONE BEFORE COMMENCING THE RADIO EQUIPMENT USE?

Electronic Communications Office (ECO) of Latvia asks the event organizers to make sure, if the radio equipment, used during the events, is installed in compliance with the requirements, stated by the manufacturer, and used according to the legislation of Latvia. Before the radio equipment use, especially during major events, it is important to check the radio equipment and its installation.

CHECK, WHAT LICENCE IS NECESSARY FOR YOUR EQUIPMENT

If technical parameters of your transmitting radio equipment does not conform to the Shared licence (Annex No.3 to the Cabinet Regulations No.1151 from October 6, 2009), you need an Individual licence, issued by ECO. If you have any doubt, please contact ECO specialists:

- about the issues of private mobile radio (PMR) communications call: +371 67331789;

- about the issues for use of PMSE equipment (wireless microphones, etc.) call +371 67333157.

- CHECK, IF YOUR RADIO EQUIPMENT IS SET ON A RADIO FREQUENCY, WHICH IS PROVIDED IN THE LICENCE
- If your radio communications system uses the radio frequency couple (separate radio frequencies for reception (Rx) and transmission (Tx)), MAKE SURE THAT THE COUPLE RADIO FREQUENCIES ARE CONFIGURED IN CONFORMITY WITH YOUR LICENCE
- MAKE SURE THAT THE SET POWER OF YOUR RADIO EQUIPMENT DOES NOT EXCEED THE POWER PROVIDED IN THE LICENCE
- MAKE SURE THAT YOUR RADIO EQUIPMENT DOES NOT CAUSE UNWANTED EMISSIONS OUTSIDE THE INTENDED (PROVIDED IN THE LICENCE) RADIO CHANNEL
- USE SHIELDED, HIGH QUALITY CABLES
- IF NECESSARY, USE RADIO FREQUENCY FILTERS
- CHECK THE CABLE CONNECTIONS AND BATTERIES
- MAKE SURE THAT THE RECEIVING ANTENNAS ARE PLACED FAR ENOUGH FROM THE TRANSMITTING ANTENNAS

PROPERLY AND CAREFULLY PERFORMED CHECK WILL ESSENTIALLY REDUCE THE RISK FOR OCCURRENCE OF RADIO COMMUNICATION INTERFERENCES.
