### General reservation and rental conditions

We ask that you make a 30% deposit within 1 week of making your reservation. We request that you pay the remaining 70% no later than 6 weeks before arrival. You pay 100% if you return within 6 weeks of arrival reserve.

After placing your reservation, you will receive an email with an invoice attached. This invoice states the payment terms and amounts. You can transfer this to us or pay via the link in the email.

If you cancel up to 6 weeks (42 days) before the day of arrival, 10% of the rental price will be charged.

If the cancellation takes place within 6 weeks (42 days) before the day of arrival, we unfortunately do not refund. You must then use your trip cancellation insurance.

If you have any problems making a reservation through our system, please contact us via our contact form. Of course we are happy to help you.

#### Camping information and rules:

Campsite opening hours: The campsite is accessible to cars in high season between 8:00 am and 11:00 pm. In the low season the gate may close a little earlier. If you are standing in front of a closed gate, you can park the car next to the kayak under the large camping sign.

Plan your arrival: Due to departing guests and any necessary actions afterwards, such as mowing on a camping pitch or cleaning a mobile home, etc., our rule is that you arrive after 3:00 PM. If you wish to arrive earlier, please contact us up.

Office/reception opening hours: The reception is open every day from 9:15 a.m. to 12 p.m. and from 2 p.m. to 5 p.m. At the reception you will find information about outings, days out, walking and cycling routes, etc. and rental prices for the canoes. If you need us urgently outside these hours, you can always reach us. You will find us at the campsite or you call/whatsapp us +31 (0)6 28644151 or +33 (0)7 72 29 25 88.

Do you want to leave: When 'unfortunately' (and we are sorry too) the time of departure has arrived, we would like to ask you to settle any outstanding amounts the day in advance. The latest departure time from our campsite is 11:00 am and not earlier than 8:00 am (unless otherwise agreed in consultation).

Residual waste: At the bottom of the driveway there are 2 containers where you can deposit your residual waste in a closed bag. For the good 'separator', in the village you will find containers for paper, cardboard, plastic, tin and glass. If you are unable to dispose of your waste yourself, you can place it in the waste bins next to the white house at the top of the driveway.

Plastic/glass bottles: Both plastic and glass are separated in France. We would like to ask you not to throw your plastic/glass bottles and jars in a waste bag, but to deposit them in the special containers. The glass container can be found on the way to Neuvic before the bridge on the right. In Neuvic at the roundabout 2nd right straight ahead past the Gamm Vert on the right you will find containers for paper, cardboard, plastic, tin and glass

Paper and cardboard: You will find these containers in Neuvic at the 2nd right roundabout, straight ahead past the Gamm Vert on the right.

### Bread service: You can place your bread order online until 2:00 PM via our web page

www.lesoustran.com/pain . The ordered bread can be picked up at the bar the next morning between 8:30 AM and 10:00 AM. There may not be a bread service available in the early and late season. We apologize for the inconvenience.

Snacks: During the high season, the takeaway is open 7 days a week between 5:00 PM and 6:30 PM for the collection of fries and snacks. Outside the high season a lot is possible, but we are not always open, so please consult us in time wishes with us.

Small restaurant: In high season our restaurant (terrace) is open on Monday, Wednesday, Thursday and Saturday from 6:30 PM. Reservations are mandatory. Send us a message via text message or WhatsApp.

On Tuesday you can join the 'long table meal'. That evening we will grill chicken legs, which will be delicious with fries and salad. On Friday we have a BBQ. For these two special evenings, reservations can be made the day in advance at reception by completing the reservation list.

Outside the high season, or in other words in the low season, we act according to the demand.

Bar: The bar and terrace are open every day (except Sunday) from 5 p.m. to 11:15 p.m./11:30 p.m. at the latest. Opening hours have been adjusted during the low season.

Barbecue: Only gas barbecues are allowed.

General fire pit at the bar: This is free\* to use, but always after consultation with the campsite owners. A bucket of water should be ready at all times in case of emergencies. Fire extinguisher and fire blanket hang immediately on the left in the recreation room. (\*it is only prohibited when nature is extremely dry)

Pets (dogs/cats): are allowed, but we trust that you will comply with our rules. Your four-legged friend must be on a leash throughout the campsite. There is a card in the office explaining where you can walk your pet. Pets are (logically) not allowed to do their business (no pee, no poop) at the campsite. There is a waste bin especially for the 'filled need bags' near the white house at the top of the driveway. Pets are not welcome in the sanitary building. Thank you for your understanding.

Washing: Your laundry is clean again, that's possible! The washing machine and dryer can be found in the sanitary building on the ladies' side. You create an account on the WASHIN app via your mobile phone, choose your machine (wash or dry) and pay immediately with your bank or credit card. If you can't figure it out, we are happy to help you.

Washing a car/caravan: This is not permitted. There is a car wash in the village.

Playing field/trampoline: These can be used until 10:00 PM, unless stated otherwise by the administrators. This is due to the evening rest. Use is at your own risk.

Children's play forest: This can be used from 12:00 noon until 6:00 pm at the latest and entirely at your own risk (of child and parents). Respect nature and take into account the campers in the area surrounding the play forest. Be careful and don't do anything crazy.

WIFI: The WiFi is free, you will receive the code at the reception.

Swimming pool: When the weather is good, the swimming pool is open from 10:15 am to 8:00 pm. Use of the swimming pool is at your own risk. Please respect the rules that you can read at the entrance gate of the swimming pool. Unfortunately, the swimming pool is not accessible to the disabled.

Chemical toilet: You can empty and clean your chemical toilet outside next to the sanitary building, on the right.

Cleaning of the toilet block: In high season the main cleaning takes place before 8:30 am and between 12:00 pm and 2:00 pm. Of course we also do our rounds through the sanitary building in between. In the low season we are more flexible in our time allocation depending on the occupancy of the campsite. The sanitary facilities are equipped with a disabled toilet and shower room.
