## FAQ

### What exactly is 'Målbar Verified Electricity Data'?

It is a structured way to document and apply your production-site-specific electricity mix in Målbar LCA, allowing customers to use your electricity data instead of generic electricity assumptions when screening products empowering your customers on their journey to achieve reduction targets

### Who owns the data?

You do.

You pay for the service and retain full ownership of your electricity data. You decide which brands are allowed to use your data in Målbar LCA. Brands can apply your electricity mix in their product screenings, but they cannot change, reuse, or redistribute the data outside Målbar LCA.

### What documentation is required?

You will complete a Målbar questionnaire covering topics such as:

- Electricity consumption
- Production site details
- Green certificates and issuing body of the green certificates
- Selection of processes performed at your production site
- Photo documentation of production site

### How long is the data valid?

The results of the investigation is valid for 12 months.

Målbar will contact you three months before expiry to support revalidation and ensure continuity.

### What does it cost?

EUR 1,000 per production site, with prepayment. Prior to payment, we will assess your Green certificates to ensure they are applicable to the service.
