(1) The company Mard Reap undertakes to process data and processing results exclusively within the framework of the supporter agreement or the application form. If Mard Reap receives an official order to release the data of the supporter / applicant, he must - if permitted by law - immediately inform the supporter / applicant and refer the authority to them. Likewise, processing the data for the supporter's / applicant's own purposes requires the above signature.

(2) The company Mard Reap declares in a legally binding manner that it has committed all persons responsible for data processing to confidentiality before starting work or that they are subject to an appropriate legal obligation to maintain confidentiality. In particular, the confidentiality obligation of the persons responsible for data processing remains in force even after their employment and leaving the Mard Reap company.

(3) The company Mard Reap declares in a legally binding manner that it has taken all necessary measures to ensure the security of processing in accordance with Article 32 GDPR.

(4) The company Mard Reap takes the technical and organizational measures so that the supporter / applicant has the rights under Chapter III of the GDPR (information, information, correction and deletion, data portability, objection, as well as automated decision-making in individual cases) within the statutory periods at any time can fulfill and leaves all the necessary information to the supporter / applicant. If a corresponding application is sent to the contractor and it shows that the applicant mistakenly considers him to be the supporter / applicant of the data processing he is operating, Mard Reap must immediately forward the application to the supporter / applicant and this to the supporter / applicant tell.

(5) Mard Reap supports the supporter / applicant in complying with the obligations specified in Articles 32 to 36 GDPR (data security measures, reporting violations of the protection of personal data to the supervisory authority, notification of the person affected by a violation of the protection of personal data, Data protection impact assessment, prior consultation).

(6) The company Mard Reap is advised that it must set up a processing directory in accordance with Art 30 GDPR for this order processing.

(7) The supporter / applicant is granted the right to inspect and control the data provided by him at any time, be it through third parties commissioned by him, the data processing facilities. Mard Reap is committed to providing the supporter / applicant with the information necessary to monitor compliance with the obligations set out in this agreement.

(8) After the termination of this agreement, Mard Reap is obliged to hand over / destroy all processing results and documents containing data to / on behalf of the supporter / applicant. If the company Mard Reap processes the data in a special technical format, it is obliged, after the termination of this agreement, either in this format or at the request of the supporter / applicant in the format in which it received the data from the supporter / applicant or in another common format.

(9) Mard Reap must inform the supporter / applicant immediately if he believes that instructions from the supporter / applicant violate data protection regulations of the Union or the Member States.

The location of the data processing is the headquarters of Mard Reap.

The supporter request forms are stored analogously in a folder and kept at the Mard Reap company location.

Mard Reap is not authorized to use a sub-processor and to sell the data or to pass it on without the consent of the supporter / applicant.
